The Agility Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit, on receipt of a report indicating that this has occurred.

#### **General / Event Information**

Lunch will be available for sale. Hamburger, sausage or chicken on a bun and a drink for \$5.00. There is also a Tim Hortons just up the street from the trial site.

The Agility Committee is in full charge of the Trials. The Show precincts shall consist of 10 ft. around the agility rings. Food and toys are not permitted in the course area and handlers are not permitted to use whistles or other training instruments or devices in the ring or within 10 feet (3.05m) of the course. Bitches in season **ARE NOT** permitted anywhere at the trial venue. Dogs must be ON LEASH at all times when outside the ring. PLEASE STOOP TO SCOOP!

Agility rings are outside on grass. Electronic timers will be used.

Agility handlers in all classes will be able to walk their course, without their dog prior to the start of the class. Handlers must be ready at the start line when called or risk forfeiting their run. If a dog is not at ringside after it has been called 3 times, it will be marked absent. Please advise us ASAP if you have a conflict and we will accommodate your needs.

There is no shade. Exhibitors are advised to bring shade tents.

#### **Agility Obstacles**

Obstacle familiarization will be available for Novice classes immediately prior to the first Novice Standard class. Obstacles shall meet the specifications in the CKC Agility Rules and Regulations effective January 1, 2014.

## Eligibility

To be eligible to compete in these agility trials, a dog must be 18 months of age. ALL dogs may be registered or be eligible for registration with the CKC, have an ERN or CKC Miscellaneous Certificate or Performance Event Number (PEN) or CKC Mixed Breed Number to compete in agility. Spayed bitches, debarked dogs, and neutered males are eligible to participate.

#### **Move Ups**

Move Ups will be allowed. Handler must notify the trial secretary prior to the start of the trial

#### **Bitches in Season**

Bitches in season may not compete. When a bitch comes into season after the entry has closed a Veterinarian's certificate, certifying the bitch was in season within the 10-day period preceding the trial must reach the secretary on or before the start of the trial. A full refund of entry fees and listing fees will be given.

## **Ribbons/Trophies**

Ribbons will be given for 1st through 4th qualifying scores in all Jump Heights. New Title ribbons are available.

#### Are you in the correct Class, please note changes.......

**Selected Class:** Any dog eligible to enter an agility trial may enter the Selected Class. Once a dog has been designated as a Selected and entered in this class, the dog cannot revert/transfer back to the Regular class. The dog will retain titles and/or Qualifying scores towards titles accumulated. Dogs will jump one jump height lower than their Regular jump height and get 10% more time then the STC.

**Novice** is for dogs that have never acquired a CKC agility title in that class. Dogs may continue to compete in Novice once they have acquired that title, but must be moved up once they have a leg in Intermediate in that class.

**Excellent** is for dogs that have acquired the Intermediate title, but have not yet earned the Agility Excellent title in either Standard or JWW.

Master Excellent (formerly Excellent B) is for dogs that have acquired the Excellent title or the Master Excellent Title. A dog may move up into Master Excellent in only the Standard or JWW class that they have earned an Excellent Title in. A dog only needs to be entered in Master Excellent for the class that he/she has achieved the Excellent title in. ie. A dog can be in Excellent JWW and Master Excellent Standard.

**Veteran Class:** a dog 7 years of age or older may be entered in the Veterans Class. Once a dog has been designated as a Veteran and entered in this class, the dog cannot revert/transfer back to the Regular or Selected Classes. The dog will retain titles and/or Qualifying scores towards titles accumulated. Dogs will jump one or two jump heights lower than its Regular jump height and this class will get 10% more time then the Regular Standard course time.

For full rules on these classes please refer to the Official CKC Agility rule & regulations.

#### Non Member Participation Fee \$59.40 + HST

A non-member participation fee will be charged to a resident of Canada who is a non-member of the CKC.

The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.

In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.
