## ELIGIBLE ENTRY

The trials are open to the following breeds Afghan Hound, Azawakh, Basenji, Borzoi, Greyhound, Ibizan Hound, Italian Greyhound, Irish Wolfhound, Pharaoh Hound, Rhodesian Ridgeback, Saluki, Scottish Deerhound or Whippet.

### 7.1 Eligibility of Hounds

7.1.1 To be eligible to compete at approved lure coursing field trials a dog must meet the following requirements:

- (a) A hound must be tested with another dog, of the same breed or a breed with a similar running style (preferably not a kennel mate) and certified running clean by a licensed judge. Hounds must be a minimum of 11 months old prior to being certified, and must run a course of at least 600 yards (548.4 m) in order to be certified.
- (b) A certificate signed by the judge is given to the owner at the time of the test and must be submitted to the Field Trial Secretary at the dog's first trial.
- (c) All dogs must be one year of age on the date of the trial to enter a regular stake and must be registered or eligible for registration in the records of the CKC as hereinafter provided.

7.1.2 Any dog who is disqualified/declared ineligible in any lure coursing field trial held under other jurisdictions is ineligible to course.

7.1.3 Listed breeds designated as Sighthounds are eligible to enter provided they have a Miscellaneous Certification Number (MCN)

### 7.2 Entries

7.2.1 Every dog entered in a lure coursing field trial must be one of the following:

- (a) Registered with the CKC
- (b) Have an Event Registration Number
- (c) Have a Performance Event Number
- (d) Eligible for registration with the CKC, or
- (e) Have a Miscellaneous Certification Number (MCN) if it belongs to a CKC listed breed
- (f) Have a Temporary Competition Number (TCN)

## 9.2 Draw

9.2.1 Hounds not present at the time of roll call shall be declared absent and will forfeit their entry fees.

9.2.2 The Field Trial Committee shall inspect each entry at the time of the roll call for lameness, bitches in season and adequacy of equipment. Spayed bitches, monorchid, cryptorchid and neutered males will be allowed to compete.

9.2.3 The order and arrangement of hounds coursing shall be determined by a public random draw at the beginning of each stake, preliminary and final run. The draw shall be conducted by the Field Trial Secretary. This applies to all stakes.

**IMPORTANT NOTICE** Hounds entering their first trial in Canada must be tested with another dog that is not a kennel mate, and certified running clean by a licensed judge. The CKC Hound Certification form, available from the Trial Secretary must be completed and submitted with the entry at the hound's first trial. Hounds with the following are exempt ASFA (FCh or LCM), AKC (QS, SC or DC), BUT are still required to submit the Hound Certification form at their first Canadian trial with their name and exempt title(s) circled.

**RUNNING ORDER** Dogs will be run by breed in alphabetical order in Open on Saturday and reverse alphabetical order on Sunday. Mixed stakes will be run at the end. The running order is subject to change by the judges if this makes the running more efficient. Single stakes will be run after all of the other runs on Saturday.

**BITCHES IN SEASON** Bitches in season shall not be eligible to enter the test.

## **REGULAR STAKES OFFERED**

**9.1.2 (a) Open Stake:** Each stake shall consist of entries of only one breed (dogs and bitches). Field Trial Champions of record in that breed may be entered.

**(b) Mixed Stakes:**

A mixed stake shall consist of breeds where entries are three or less. The stake may be offered at the option of the club with agreement of the owners and if offered must be stated in the premium list. Total hounds entered in the mixed stake shall be counted for the awarding of points. Only the winner of the mixed stake may compete for best in field.

**9.1.4 Non-Regular Stakes may be offered as follows:**

**(b) Kennel Stake:**

Open to any 2 hounds entered in the regular stakes owned and kenneled by the same person. Total of scores earned in the regular stake shall determine the winner.

**Single (Non-regular) Stake:** Offered on Saturday and limited to 10 dogs only. This is open to any dog NOT entered in a regular class. This is NOT a regular stake.

**Veteran (Non-regular) Stake:** Offered on Saturday and limited to 10 dogs only. This is open to any dog NOT entered in a regular class. This is NOT a regular stake.

**Breeder Stake** Offered on Sunday, determined by tally of scores.

**Best In Field** Best of Breed (BOB) and Mixed Stake winners (from either trial) may compete (no points toward titles) on Sunday September 25, 2022

**Puppy Run: There should be time to run puppies at the end of the Saturday trial (weather permitting). The fee is \$5. cash payable at the time.**

**RIBBONS AND PRIZES** Ribbons will be offered for all placements First place through to Next Best Qualified (NBQ). Rosettes and/or Prizes will be awarded to BOB winners and First in Mixed Stake, and to the Best In Field, Kennel Stake and Breeder Stake winners.

## **LURE FIELD TRIAL CHAMPIONSHIP POINTS**

Per CKC Lure Field Trial Rules & Regulations, Chapter 7, Section 1

First place – four X number competing to a maximum of 40 points.

Second place - three X number competing to a maximum of 30 points.

Third place - two X number competing to a maximum of 20 points.

Fourth place - one X the number competing to a maximum of 10 points.

NBQ - no points awarded.

**ADDITIONAL INFORMATION** Hounds not present at Roll Call will be scratched and entry fee not refunded. Bitches in season and lame hounds will have their entry refunded provided notice is given at or before Roll Call. The Club requests all competitors or spectators NOT to bring a bitch in season onto the grounds.

Stakes will be split if the entry in any breed reaches 24 or more at Roll Call.

All handlers must use a slip lead when releasing their hounds. Hounds may wear muzzles and/or catch collars at their owners' discretion. Leg wraps must be in neutral colours.

There will be a walking start. Do not release your dog before the "T" in "Tally-ho" or the dog may be assessed a pre-slip penalty of between 1 and 10 points for that run by each judge.

It is the responsibility of the exhibitor to be familiar with the rules pertaining to the event in which they are competing. **CKC REGULATION** It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Field Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

**TRIAL SITE** Bring water, shade and shelter for you and your dogs. These tests will be run **rain or shine**. All dogs must be under control, on a leash except during the trial. **Flexi leads will not be allowed on the trial grounds.** A port-a-potty will be available at the field. Wear appropriate footwear for traction and protection.

A \$10.00 fine will be levied against the owner of any hound loose on the field.

Clean up after yourself and your dog so that we will be welcome to use this site again. A \$10.00 fine will be levied against the exhibitor who does not scoop after their dog. Please properly dispose of trash (e.g. cigarette butts, dog poop) since this is an agricultural field. As courtesy to those who transport all trial equipment and garbage cans, please do not let your dog mark on them.

**Directions: From Vancouver: Hwy 1 to Abbotsford – cross Fraser River to Mission continue East on Lougheed Hwy, ca. 15 km, go over Harrison River bridge, turn left on Kennedy, about 2 km past camp ground, turn right, continue for 1 km. Do not park on ground between camp ground and bowl.**

**From Hwy 1, take Agassiz exit, on through Agassiz, heading to Lougheed Hwy and all the way to Harrison Mills; turn right at Kennedy Rd follow road to camp ground, turn right - continue for 1 km. Do not park on ground between camp ground and bowl.**

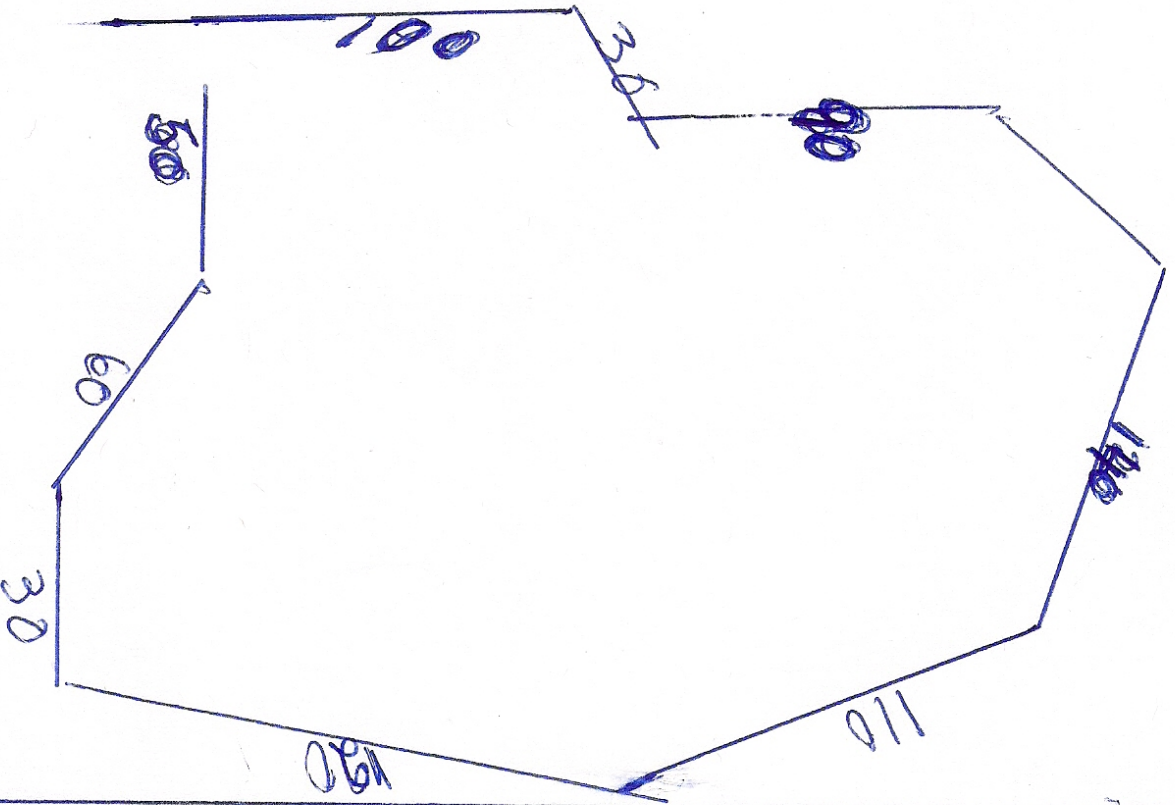
