SCRATCHES: Approved scratches will forfeit \$10.00 per entry. "NO SHOW" refunds must be requested in writing to the Hunt Test Secretary within fourteen days of the test event explaining the reason for the scratch. Entry fees will be refunded for bitches in season or for injured dogs, upon receipt of a veterinarian's certificate.

AWARDS: Standard CKC Rosettes for all qualifying scores.

Ducks, pheasants and/or pigeons may be used in all stakes. Wingers may be used in any stake.

A caravan will depart from the Regina Retriever Club Grounds at 7:30 am each day.

Running order will be available by 7:00 AM July 6th at the Hunt Test Headquarters.

This Hunt Test is open to all Retrievers, Irish Water Spaniels & Standard Poodles. The Hunt Test will be held under the rules of the Canadian Kennel Club.
