These tests are held under the rules of the Newfoundland Dog Club of Canada.

The NDCC and the Canadian Kennel Club have granted permission for the hosting of these tests.

IMPORTANT NOTICE: NEW TRACKING FEE FOR CANADIAN NON-MEMBERS

Effective January 1, 2011, the CKC instituted a tracking fee for all Canadian residents who participate in CKC events, but are not CKC members. In order to cover the clerical costs of recording and tracking points and awards earned at CKC events, a participating non-member can choose to purchase a CKC membership or pay a dog specific tracking fee of \$62.40 plus applicable taxes.

This only applies to dogs wholly owned by non-members and is not applicable to CKC members or dogs co-owned with a CKC member.

In order for the CKC to efficiently manage recording and tracking points, it is important that non-members select one of the two options within 30 days of notification, or unfortunately, the points, awards and titles will be cancelled.

EVENT REGISTRATION NUMBER

Every foreign born and owned dog that is entered in a Canadian Kennel Club event must obtain an Event Registration Number (ERN) within 30 days of that event. An Event Registration Number Application must be completed and submitted along with a copy of registration documents from a CKC recognized foreign kennel club and the required fee.

PERFORMANCE EVENT NUMBER

A Performance Event Number (PEN) allows an unregisterable dog of a CKC recognized or listed breed to participate in competitive events that are appropriate for the breed. In order for a dog to be eligible to receive a PEN, all of the following criteria must be met:

- 1) The dog must be of a CKC recognized or listed breed.
- The dog, for one reason or another, must not be eligible for CKC registration.
- 3) The dog must be spayed or neutered.
- The dog must be properly identified with a CKC approved microchip (this requirement is not necessary for ILP dogs).
- In the case of a foreign born dog residing in the USA, in addition to the above, the dog must have been issued an AKC PAL number.

Download the Performance Event Number Application from the online forms section under CKC Forms, Exhibitor.

ELIGIBILITY

This test is open to all Newfoundland dogs that are six months of age or older on the day of the test. Water Rescue Dog Excellent entries must have previously earned WRD titles in order to enter the WRDX level.

Re-qualifications will be accepted only after all untitled entries are included. Re-qualifications shall be judged as the last team in the section for which they are entered. The judges must excuse a dog at any time during a test for lack of physical capacity.

CLOSING DATE

August 11, 2017 at 8:00 p.m. EDT or when the limit total has been reached, even if the official closing date for entries has not arrived. If the limit is reached prior to the closing date, a list of alternates will be kept to fill any vacancies created up to and including the day of the test.

Entry fees will be refunded following the test to all withdrawals replaced by an alternate and to all alternates who did not participate in the test.

Re-qualifications are accepted pending "space available". Requalifications shall be judged as the last team in the level for which they are entered.

CONFIRMATION OF ENTRY

After the closing date, all entrants and alternates will be notified by e-mail, post, fax, or telephone of their placement.

A map and directions will be provided with this confirmation. Entries will be accepted on a first come, first served basis.

REFUNDS

It is the option of the exhibitor to request a refund for a bitch that has come into season, should they so desire. A veterinarian's certificate will be required for the refund to be issued.

Otherwise, **bitches in season** may compete, but will be judged after all other entrants have been tested.

Bitches in season must be kept away from the test site prior to being tested. Day of test entries will NOT be accepted for bitches in season.

THE TEST SITE

CONDC-NDCC will use due care and diligence for the welfare of the dogs and exhibitors, but will not be responsible for, or assume liability in the event of accident, or other misfortunes, to either dogs, exhibitors or patrons.

If because of riot, civil disturbance, or other acts beyond the control of management, it is impossible to open or complete the tests, no refund of entry will be made.

DAY OF TEST ENTRIES

The option of entering on the day of the test will be available for exhibitors if the combined tests have not reached the stated entry limits and/or all alternates have been accommodated.

Day of test entries will be accepted for the W.R.D.X. level of testing at the entry fee of \$75.00 plus an administration fee of \$25.00 for dogs that have passed under three judges and have the required W.R.D. title.

Day of test entries will be accepted up to one hour before commencement of the Water Rescue Dog Excellent level.

No bitches in season will be accepted under this provision.

All fees for these entries will be made in cash only. Test entry will be assigned at the end of all pre-entered dogs.

JUDGES


A judge officiating at a Water Test held under the NDCC Water Test rules shall not be subjected to any indignities of any kind during the progress of the test. It shall be the duty and obligation of the club holding the test to see that this rule is effectively carried out.

QUALIFYING SCORE

To earn a Water Rescue Dog title or Water Rescue Dog Excellent title at these tests, the entrant will be required to successfully pass all the exercises as written in the NDCC Water Test Rules, in the eyes of all three judges. During the test, the decision of the judges shall be final in all matters affecting the working of dogs and handlers and in evaluation of their performance.

GENERAL INFORMATION

The Test Chairperson will be in full charge of the tests. These events are held under the rules of the Newfoundland Dog Club of Canada.

The Central Ontario Newfoundland Dog Club (CONDC-NDCC) will use due care and diligence for the welfare of the dogs and exhibitors, but will not be responsible for, or assume liability in the event of accident, or other misfortunes, to either dogs, exhibitors or patrons. If because of riot, civil disturbance or other acts beyond the control of management, it is impossible to open or to complete the tests, no refund of Entry will be made.

Owners or handlers are responsible for clean up after their doas.

Exhibitors must abide by errors made in entering their dogs, regardless of how or by whom the entries were made. Change or cancellation of any entry after closing day and time is prohibited.

The Test Committee may decline any entries, or may remove any dog from a test for just cause.

Telephone entries cannot be accepted except in the case of a postal disruption. Confirmation of entry and Judging Schedules will be mailed or e-mailed as soon as possible after the closing.

AWARDS

Through the generosity of its members and friends, CONDC-NDCC will offer rosettes for each qualifying score. A medallion will be awarded to each Newfoundland who receives a passing score under each of the three judges at this test by the Central Ontario Newfoundland Dog Club.

EQUIPMENT

Entrants must supply their own equipment. Be prepared for any weather. This event is entirely outdoors and there is no provision for cover in case of inclement weather.

Government approved flotation devices and appropriate footwear must be worn by all handlers and stewards during the water testing.
