Entry per dog : Qualifying: \$70.00

**CKC Listing Fee per dog: \$11.00

**A listing fee must accompany any entry form of dogs for which an individual CKC registration or ERN number is not shown.

All fees to be in Canadian funds, no exchange will be given on the U.S. Funds.

Official CKC Entry Form **MUST** be used. Official Entry Forms can be obtained from the CKC website: <http://www.ckc.ca>. If you are unable to access the website, contact the Field Trial Secretary for copies.

NO POST DATED CHEQUES accepted. All NSF cheques are subject to a charge of \$20.00. NSF cheques are considered non-payment of entry fees and are punishable by discipline action and cancellation of awards. All fees must be paid in full before the trial.

ATTENTION ALL CANADIANS WHO ARE NOT CKC MEMBERS

Effective January 1, 2011, the CKC has instituted an annual Non-Member Participation Fee for awards and titles for a CANADIAN non-member of the CKC. These fees apply only to dogs wholly owned by a non-CKC member and are not applicable to CKC members. Non-CKC member participants must either purchase a CKC membership or pay the non-member participation fee within 30 days of notification or the CKC will cancel any awards and titles. Bitches in season **MAY NOT** compete in the trials. Entry and listing fees paid for any dog withdrawn because of a bitch in season, injury, illness or death shall be refunded in full. An appropriate veterinary certificate must be given to the Trial Secretary **BEFORE** the start of the trial to qualify for a refund.

Running order will be determined by draw.

Ducks will be used for both land and water marks.

CKC rosettes will be awarded to all dogs that receive a placement or are awarded a Certificate of Merit.

There will be a designated area (land and water) available for airing your dog(s) on the trial grounds. Contact the Field Marshall upon arrival at the trial site to confirm location of both prior to airing your dog(s).

The Trial Committee is pleased to offer coffee and tea in the morning. A lunch will be available for purchase on site.

Section 3.8.1 Indignities to a Judge

A judge officiating at a field trial held under these rules shall not be subjected to any indignities of any kind during the progress of the field trial. It shall be the duty and obligation of the club holding the field trial to see that this rule is effectively carried out.
