THESE EVENTS HELD UNDER THE RULES OF THE CANADIAN KENNEL CLUB

TEST DETAILS:

- Standard CKC rosettes awarded to all qualifying dogs
- Ribbons will be given out at the conclusion of each test
- Ducks will be used
- Shotguns may not necessarily be used
- Handlers should not wear distinctive white or light clothing except that handlers may wear handling jackets for blinds in WCX
- Refunds will be given for bitches in season. A veterinarian certificate must be submitted prior to test
- Running order is by random draw within each test level
- Recommended arrival time is ½ hour prior to the start time for each stake

Listing Fee: The \$11.30 listing fee must be submitted for any dog without an individual CKC registration number or ERN number.

IMPORTANT NOTE regarding Non-Member Participation Fee (effective January 1, 2011.
