## **TEST DETAILS:**

- Standard CKC rosettes awarded to all qualifying dogs
- Ribbons will be given out at the conclusion of each test
- Ducks will be used
- Shotguns may not necessarily be used
- Handlers should not wear distinctive white or light clothing except that handlers may wear handling jackets for blinds in WCX
- Refunds will be given for bitches in season. A veterinarian certificate must be submitted prior to test
- Running order is by random draw within each test level
- Recommended arrival time is ½ hour prior to the start time for each stake

Entries limited to a total of 25 dogs.

Listing Fee: The \$11.30 listing fee must be submitted for any dog without an individual CKC registration number or ERN number.

Attention Foreign Exhibitors: Only bank drafts or money orders in Canadian funds or personal cheques drawn on a Canadian bank will be accepted.

## **IMPORTANT NOTE regarding Non-Member Participation Fee (effective January 1, 2011).**
