1. Judging for each show will start promptly and will adhere as closely as possible to this schedule.
2. Exhibitors and handlers of several dogs must have an alternate handler available so that judging is not delayed. Schedule changes will not be made.
3. It is the responsibility of the exhibitor to be at ringside when their classes are called. It is not the responsibility of the ring steward to locate dogs. Judges will not wait for any dog delaying a class.
4. The precincts of the Shows and Trials is the fenced area surrounding the rings.
5. The show site will be open each day at 7:00 am and will be open on Friday after 6:00 pm for those who wish to set up early.
6. **The Show/Trial Superintendent will be in complete charge of these Shows and Trials.**

Obedience judging will begin at 10:00 am on Saturday & Sunday  
Group judging will follow completion of Breed judging within each Group

### Directions to show site:

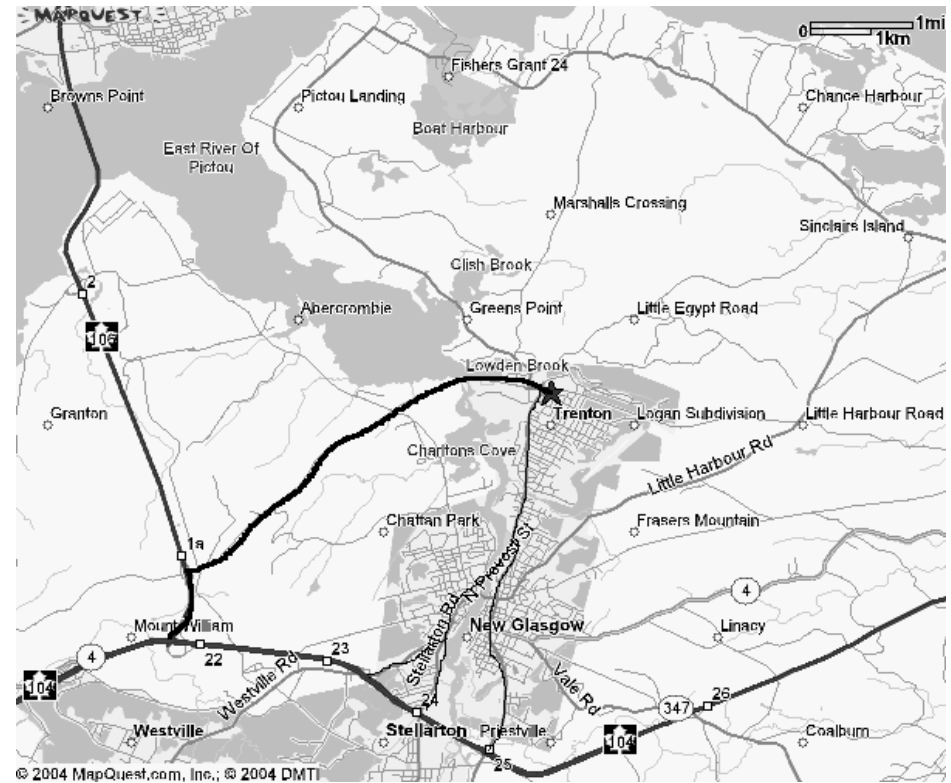
For those going directly to the show site coming from Truro:

Take exit 22 and then exit 1A. At the top of the ramp turn right onto Park Road. You will go through a set of lights and then a stop sign. The show site is on the left after going through the stop sign.

For those going to a motel prior to the show site:

**From Truro:** Take exit 23, Turn left at the bottom of the ramp. Proceed through New Glasgow to Park Road (look for Trenton Park sign). Turn right at the lights onto Park Road. The show site will be your left after going through the stop sign.

**From Cape Breton:** Take exit 25. Proceed through New Glasgow to Trenton and to Park Road. Turn right onto Park Road. The show site is on the left after going through the stop sign.
