\$20.00 1st dog, \$18.00 2<sup>nd</sup> and subsequent dog, (Per each Test)

Post Entry: \$25.00 1<sup>st</sup> dog, 2<sup>nd</sup> and subsequent dog \$22.00

### 600 YARDS

Eligible breeds: Chase Ability Program participation is open to all purebred and mixed-breed dogs at least 12 months of age that are individually registered with the CKC; or have an Event Registration Number (ERN); or have a Performance Event Number (PEN); or eligible for registration with the CKC; or have a Miscellaneous Certificate Number (MCN) if it belongs to a CKC listed breed; or have a Canine Companion Number (CCN) if it's a mixed-breed.

Dogs with Breed disqualifications are eligible to enter. Females in season may not enter. A dog may enter only once per event. Running order determined by order in which entries are received. Dogs run as singles.

300YARD COURSE: This distance is for dogs shorter than 12 inches at the withers or brachycephalic (flat-faced) dogs. Dogs will run one loop.

600 YARD COURSE: This distance is used for all dogs that do not run the 300 yard course. Dogs will run both loops.

If there is a question as to which course a dog will run the judge will decide.

## RIBBONS:

Orange qualifying ribbons will be awarded to dogs passing their test.

THERE IS A WAIVER IN THIS PREMIUM LIST THAT MUST ACCOMPANY YOUR ENTRIES OR THEY WILL NOT BE ACCEPTED.

## ATTENTION EXHIBITERS

There will be a \$10.00 fine for dogs loose on the field and not part of the course from after roll call

Dogs will be run once per trial

Lames dogs or bitches in season will be excused and their entry refunded, provided notice is given prior to or during roll call.

Dogs not present at roll call shall be scratched with no refunds. No Exceptions.

Muzzles & catch collars may be used at the handler's discretion. NO FLEXI-LEADS OR SHOCK COLLARS ALLOWED.

A veterinary clinic is within easy access from the field

\*\* People can park in the parking lot. Bathrooms available. Bring shade for your dogs, and own water.

People will be expected to clean up after themselves and their dogs. There will be a \$10.00 fine for those caught NOT cleaning up after their dogs.

- Oakville Fair Grounds. **Directions:**
- **Traveling west**
- Head southwest on Tupper St. N/MB-240 S (about 3 minutes)
- Turn left at E Saskatchewan Ave/Trans-Canada Hwy/MB-1A E/MB-240 S (signs for Trans Canada Highway/Manitoba 1 Alternate) Continue to follow Trans-Canada Hwy/MB-1A E. (about 7 minutes)
- Keep left at the fork, follow signs for MB-1 E/Trans Canada Highway/Yellowhead Highway/Winnipeg and merge onto Trans-Canada Hwy/MB-1 E. (about 17 minutes)
- Turn right at 331 Rd.
- Morrison Sports Park 475 PTH 331, MB R0H 0Y0.
- Traveling East- Take Trans Canada Hwy #1 Hwy 13 (other side of Portage La Prairie) turn right on Hwy 13. Continue about 2 miles. Park right on the cross road.
