Equipment and course familiarization:

- Electronic Timers will be used.
- Rubberized Contacts
- There will be NO contact equipment familiarization.
- A warm – up area with a single practice jump will be provided for dogs entered in the trials.
- NO toys that make squeaky sounds will be permitted within 15 feet of the rings.
- Handlers in all classes are permitted to walk the course, without a dog, prior to the start of the class
- **As per CKC Rules move ups are allowed one hour prior to commencement of the start of each trial each day. Same day move ups will be allowed.**
- **Day of entries allowed (space permitting) up to one hour prior to the commencement of the start of trials each day.**
- **We will try to accommodate dogs with conflicts in conformation/obedience/rally provided handlers inform gate stewards in advance, however we cannot hold the rings. Handlers please call out your dog's name to the scribe when entering the ring.**

CKC AGILITY HEIGHT CLASSES

Height Divisions - owners are responsible for entering the correct height divisions. The judge may require any dog to be measured.

REGULAR CLASSES: Standard, JWW, Steeplechase, Jumps and Tunnels & PAD

8 inches -----for dogs 11 inches and under at the withers
12 inches-----for dogs over 11 inches up to and including 14 inches at the withers
16 inches-----for dogs over 14 inches up to and including 18 inches at the withers
20 inches-----for dogs over 18 inches up to and including 22 inches at the withers
24 inches-----for dogs over 22 inches at the withers

SELECTED CLASSES: Standard, JWW, Steeplechase Jumps and Tunnels & PAD

4 inches -----for dogs 11 inches and under at the withers
8 inches -----for dogs over 11 inches up to and including 14 inches at the withers
12 inches-----for dogs over 14 inches up to and including 18 inches at the withers
16 inches-----for dogs over 18 inches up to and including 22 inches at the withers
20 inches-----for dogs over 22 inches at the withers

VETERANS CLASSES: Standard, JWW, Steeplechase Jumps and Tunnels & PAD

4 inches -----for dogs 11 inches and under at the withers
4 or 8 inches -----for dogs over 11 inches up to and including 14 inches at the withers
8 or 12 inches-----for dogs over 14 inches up to and including 18 inches at the withers
12 or 16 inches---for dogs over 18 inches up to and including 22 inches at the withers

THERE WILL BE NO REFUNDS FOR SERVICES CHARGES FOR CREDIT CARD, INTERAC or ETRANSFER TRANSACTIONS – EVEN PRIOR TO CLOSE OF ENTRIES, dogshow.ca POLICY.

Entries will be accepted after the pre-entry deadline with the following conditions:

- There will be no discount packages allowed; the price of each run will be \$28.00.
- Entry must be received by 1 hour prior to the scheduled start of the trial being entered.
- Additional classes added after pre-entry closing to an existing entry will be processed at the exhibitor's previous discount, no further discounts will be applied.
- FFO* (For Fun Only) Runs are NOT included in the discounted total run fee. No refunds will be given for any difference in fees already paid if an exhibitor switches a regular run to a FFO run at the trial.
- **CASH ONLY FOR POST CLOSING ENTRIES**
- NO Refunds will be given after early bird close of entries (July 19 at 10pm MDT) except in the case of a bitch in season or an injured dog – see rules on the next page.

Cheques post-dated up until closing date of entries will be accepted as meeting the closing date.

Cheques post-dated after pre-entry date will be accepted at post deadline rate – NO DISCOUNTS ALLOWED.

ENTRY FEE INFORMATION

NO entry will be accepted without payment in full. Tendering of a N.S.F. cheque in payment of entry fees or declined credit card in payment of entry is considered non-payment of entry fees and is an offence punishable by disciplinary action and cancellation of awards.

All N.S.F. cheques and declined credit cards will be assessed a \$50.00 service charge. (Chapter 8.8, C.K.C. Dog Show Rules). There will not be any refunds on duplicate entries or over payments.

The owner of a dog entered in this show is entirely responsible for any errors in the entering of the dog, regardless of how, or by whom the entry was made.

Courier entries must be prepaid for delivery, no signature required and WILL NOT BE PICKED UP.

Do not send entries by Registered Mail.

Please note that personal cheques will be accepted, however, fees are due and payable in Canadian dollars.

Attention Foreign Exhibitors:

Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted; however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated. Thank You.

VOLUNTEER RULES AND COUPONS

The Summer Classic 2021 is the last chance to use any volunteer coupons earned at the 2019 Summer Classic. Do not forget to redeem them! You MAY use multiple coupons per entry. Any coupons used for entries that are faxed or emailed must be scanned and sent with the entry to be accepted.

ANYONE volunteering or AKC representative who is in the ring is NOT to have a cell phone, or any food or drink except water. For liability reasons, ALL "ring Crew" (volunteer/AKC representative) must be AT least 14 years of age unless previously approved by the AKC Agility committee. Proof of age may be requested.

Bitch in Season

Entry fees will be refunded when a bitch entered in Agility, Rally/Obedience comes into season after the close of entries if a Veterinarian's Certificate (certifying that the bitch was in season within the 10-day period preceding the trial) is delivered to the Show Secretary on or before the starting date and time of the trial. The Alberta Kennel Club will refund entry, recording and TCN fees if the above conditions are met. A 50% refund of entry fees only will be made for a bitch in season without a veterinarian's certificate with written notification presented to the Show Secretary at least ONE HOUR before the start of the Trials. The bitch must be available to be examined by the Show Superintendent to verify she is in season.

Injured Dogs (12-05-19)

6.11.1 If a dog is injured after entry has been submitted to the Trial Secretary, a veterinarian's certificate, certifying the dog was injured before a 3 day period preceding the trial, must reach the Trial Secretary on or before the start of the trial. The trial-giving club may refund the entry fee but will keep a service charge and TCN fee. The refund and the terms thereof must be clearly stated in the premium list. The Alberta Kennel Club will be keeping a \$5/run service fee and any TCN fees collected (if applicable).

No other refunds will be issued after early bird closing (July 19).

AGILITY ONLY BENCHING

Pre-paid reserved benching, in close proximity to the agility rings, will be available to CKC agility exhibitors beginning 3:00 pm Thursday, July 29. You **MUST** reserve benching for this area. The cost will be \$40 for the weekend. **Very limited space** will be available free of charge under a Day Benching tent. Spots will be first come first served and once the tent is filled no other spots will be made available. **Nothing** can remain in the Day Benching tent overnight. **No benching is allowed other than the prepaid reserved benching. You will be asked to move if you are benched outside of designated benching areas.**

- No tents with floors – This will be STRICTLY enforced!!
- There are NO Generators allowed on the field
- Please make sure ALL tents are securely staked and lowered each night.

AGILITY PRIZES

Jennifer Chipperfield of **CHIPPERFIELD PHOTOGRAPHY** is pleased to offer 1st, 2nd, 3rd and 4th place cash prizes in the amounts of \$175, \$150, \$100 and \$50 respectively to the agility top dogs achieving the top 4 aggregate scores in Standard and JWW Classes in the CKC Agility Trials being held from July 30 through August 2, 2021. In the case of a tie, prize money for that place and the one(s) below it (if applicable) will be combined and then split between those competitors. Steeplechase, Jumps & Tunnels and PAD scores will not be considered when calculating placements for the cash prizes. Prizes may be mailed out.

Again, this year: To be eligible for these prizes, competitors ***must*** obtain a tracking sheet from the Trial Secretary to record the dog's qualifying runs. The Alberta Kennel Club reserves the right to refuse any entry subject to CKC Conformation Show Rules and Regulations (8.6.1).

In consideration of the acceptance of this entry, I (we) agree to be bound by the rules and regulations of the Canadian Kennel Club and by any additional rules and regulations appearing in this premium list.

I (we) agree to hold the Alberta Kennel Club, their members, directors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of a dog while in or upon the show premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim.

I (we) further agree to hold the aforementioned parties harmless from any claim for loss of a dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of the Club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this show, howsoever such injuries, death or damage to property may be caused and whether or not the same may have been caused and whether or not the same may have alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.

The Alberta Kennel Club (the "AKC") is not affiliated with nor does it endorse or guarantee any of the merchants or service providers, including but not limited to the health clinics (collectively, the "service providers") or the services being offered at the 2021 Summer Classic Show being held from July 30 through August 2, 2021 (the "Summer Classic Show").

Dogs not entered in the Show(s) are not permitted on the show premises.

An "In Transit Area" for owner/handlers who are transporting dogs not entered in the show is offered. The dog's information and reason for its presence must be recorded with the Show Superintendent and identifying information attached to the dog's crate.

If because of riot, civil disturbance or other acts beyond the control of the Alberta Kennel Club, it is impossible to open or to complete the show, no refund of entry fees will be made.

The welfare of an exhibitor's child is the responsibility of the exhibitor. It should be understood that exhibitors will exercise control and restraint over their children. The Alberta Kennel Club will not be responsible for injury to any child whether by accident or any other cause.

The Alberta Kennel Club will not allow the use of spike or pinch collars on its show grounds.

Exhibitors, through submission of entry, acknowledge that they are knowledgeable of and will comply with the CKC Agility Rules and Regulations. At the option of the handler, a dog may wear either a well-fitting plain buckle collar, a quick-release collar, or no collar. Fancy collars, choke collars, pinch collars, or other training collars are prohibited. Collars which are too tight or so large that they hang down unreasonable in front of the dog are not permitted. There shall be nothing hanging from the collar (12.3.1) Food and toys are not permitted in the course area and handlers are not permitted to use whistles or other training devices in the ring or within 10 feet of the course (12.1.1)

All dogs must be under control both entering and leaving the ring. Agility Rule 10.12.4 Failure to control the dog when exiting the ring shall result a failure to perform. Dogs must be under the handler's control when leaving the ring (either on leash or being carried).

Agility Rules and Regulations: (4.1.3.t) It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Agility Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit, on receipt of a report indicating that this has occurred.

Mixed Breed or Unrecognized Breed Entries in Performance Events

Amendments have been made to the Agility, Obedience and Rally Obedience Rules & Regulations such that mixed or unrecognized breed dogs are allowed to participate in the CKC Performance Events of Agility, Obedience and Rally Obedience Trials. The amendments are effective July 1, 2014.

The AKC will not accept any responsibility for damage to any vehicle entered to remove an animal(s) in distress.

The Alberta Kennel Club is pleased to be holding our show for the first time at the Calgary Rugby Union facility. Holding our event here comes with responsibilities for all of us – volunteers and exhibitors alike.

- Clean up after your dog
- Do not allow the male dogs to lift their legs on fences, posts, trees or shrubs
- Do not take dogs into the Clubhouse

PLEASE KEEP POOP BAGS WITH YOU AT ALL TIMES.

Failure to pick-up after your dogs will result in an automatic expulsion from the show and the show grounds.

This request will be enforced

Some Basic Requests:

1. Parking will be allowed only in areas designated by the Parking Superintendent.
2. All RV's must have boards under all of their tires and generators – sorry, No Exceptions!
3. Please be prepared to bring leveling materials for your unit.
4. For all Motor homes, please ensure you have your exhaust pipe extension, this is a mandatory requirement.
5. There will be absolutely NO dumping of grey water or sewage on the grounds permitted.
6. Water hook-ups are not available for RV units. A limited number of RV sites will have power service on a first come, first served basis.

10. All Setups are required to have a contact phone number posted in case of emergency.
11. Tents on day-benching sites must be securely staked and then lowered before you leave the grounds for the evening. Inclement weather can damage your property and create a danger to others in the area. Dogs may NOT be left overnight in day-benching sites.
12. All Benching and Camping areas must be cleaned before departure. Rakes will be available on the day-benching fields. All benching must be vacated 1 hour following Best in Show on Monday Aug 2, 2021.

If a group wishes to camp together, you must arrive together.

Summary of the 2020 CKC rule changes for Exhibitors

For the complete rules please see the CKC January 2020 Agility Rule Book.

New Category

Senior Handlers and Handlers with Disability

- Senior handlers (65 years and over) and handlers with disability may request a modified course time or a modified points requirement (PAD) (see tables below).
- Proof of disability or age will not be requested by the host club. A handler must indicate on the entry form if entering as senior/disabled handler (check S/D box) to receive modified times/reduced number of points.
- The handler's dog shall be entered at its current competition jump height and category. (Time and points concession is for the handler)
- For Standard, JWW, Steeplechase and J&T, the score table will subtract the time prior to scoring the run, regardless of whether the dog was under the SCT for that division and category or not.
- For PAD, the score table will add 3 points prior to scoring the run.

Modified Course Times

CLASS	MODIFIED TIME (More Time Allowed)
Standard, JWW, Steeplechase, J&T	If course is under 150 yards, subtract 5 seconds from dog's time. If course is 150 yards or more, subtract 10 seconds from dog's time.

Reduced Points Requirement for Pad

LEVEL	REDUCED POINTS REQUIREMENT
Novice	3 points less (add 3pts to dog's total)
Intermediate	3 points less (add 3pts to dog's total)
Excellent/Master	3 points less (add 3pts to dog's total)

For Fun Only Class

- At the owner's discretion, dogs are able to run in For Fun Only (FFO) class in any category. The owner would be allowed to take their dog into the ring with a toy. Toys are allowed but the toy must be identified to the judge prior to entering the ring. A maximum course time of 60 seconds would be allotted.
- FFO entries must meet all eligibility rules as dogs running for Qualification. FFO runs may be allowed at the same or a lesser fee at the club's discretion.
- A handler may choose to enter a FFO dog in any class, in any trial, at any performance level and at any jump height. Obstacle repetition is permitted without dismissal. They are not allowed to enter the same class again for a qualifying run. Dogs must attempt to run the course as numbered and are under the same judging criteria as dogs that are running for qualification.

Grand Agility Master Champion (G.Ag.M.Ch)

The Grand Agility Master Champion recognizes dogs that show consistency and versatility across all classes of the CKC agility program.

The CKC will permit the use of the letters G. Ag.M.CH. signifying Grand Agility Master Champion title, to be used in connection with and before the name of each dog which has met the requirements for that title as hereinafter provided To be permitted to use Grand Agility Master Champion title a dog must earn the following number of qualifying.

- 50 Qualifying scores in the Master Excellent Standard Class
- 50 Qualifying scores in the Master Excellent Jumpers with Weaves Class
- 25 Qualifying scores in the Master Excellent Points and Distance Class
- 25 Qualifying scores in the Steeplechase Class

Selected and Veterans will earn a title with the letter S or V after the title. Qualifying Scores previously earned in these classes will be used towards this title.

Competitors

- New category for Senior/Disabled Handlers
- New option to run For Fun Only with toy at any height and in any class
- Entry clarification: handlers may opt to enter their dog to jump at a higher height than their measured height for all Regular classes
- Height cutoff changes for dogs 11" and under. Dogs measuring 11' and under jump a Regular height of 8". The Selected/Veteran height will be 4"
- A select list of breeds, or mixed breed dogs that resemble these breeds in relation to weight to shoulder height ratios, are permitted (but not required) to jump either ONE or TWO jump height(s) lower than the designated shoulder height when they show in the Selected division. (See rulebook 8.5.5 for list)
- The CKC will permit the use of the letters AG.M.CH2, and so on signifying an Agility Master Champion earned a second time, third or fourth time, to be used in connection with and before the name of each dog
- New title Grand Agility Master Champion GAgMCh (see section 8.20)
- No toys that make a squeaking sound are permitted within 15ft of the ring

Time from end of walkthrough to first dog may range from 3-5 minutes. Time judging starts must be announced at

By entering the AKC Shows you are agreeing to the regulations that have been designed to keep us safe while together. The requirements are non-negotiable and will be strictly enforced. If you have personal objections to our restrictions which are based on the most current guidelines from Alberta Health Services, then please do not enter this show. Any breach of the requirements will result in dismissal from the show with no right of entry fee refund.

There will be a PHOTOGRAPHER at this show they will have their own COVID-19 Protocols in place.

COVID-19 WAIVER/DISCLAIMER

- Chief Medical Officer of Health order 05-2020: 2020 COVID-19 response legally obligates any person who has the following core symptoms of cough, fever, shortness of breath, runny nose, or sore throat (that is not related to a pre-existing illness or health condition) to be in isolation for 10 days from the start of symptoms, or until symptoms resolve, whichever takes longer, or they receive a negative COVID-19 test.
- If they are exhibiting any of these symptoms, it is suggested they complete the COVID-19 Self-Assessment online tool to determine if they should be tested.
- If you exhibit any of these symptoms or the symptoms on the COVID-19 Assessment Tool, you will NOT be allowed to attend the show. If you feel unwell at all, you must not attend the show.
- The AKC COVID-19 waiver/disclaimer must be signed and presented your first day at the show. The daily health screening questionnaire found in this Premium List will be required EACH DAY you are entered in the show.

- When you arrive for the first time, please fill out the WAIVER/DISCLAIMER, in this Premium List and bring it to the Screening Station. Do not wait until just before you need to be in the ring with your dog, to be screened and get your wristband for the day. The AKC volunteers are not responsible for poor timing on your part and the COVID-19 Screening will take priority over everything else. Abusive language or behavior will not be tolerated.

THE SHOW GROUNDS

- There will be signs indicating Entrance and Exits of the official Show Grounds.
- All entrances will have Screening Stations.
- There will be hand sanitizing stations provided in all areas.
- Porta-potties will be situated on the grounds with hand sanitizing stations.
- There will be NO lost and found.
- Judges' tables and other touch surfaces will be sanitized regularly.

MASKS

- Masks are mandatory at all times while on the show precincts. Masks MAY be required while in the ring, depending on current AHS requirements at the time of the event. Masks must be worn completely covering both mouth and nose.
- Face shields, neck warmers, masks with exhalation valves, handkerchiefs and any other loose fitting face coverings are NOT masks and are not recommended by Alberta Health Services. Face Shields are acceptable only when the exhibitor has a medical exception letter.
- Anyone unable to wear a mask due to a medical condition will require a medical exception letter from an authorized health professional. You must be able to show the letter at the Screening Station.
 - The medical exception letter must come from a nurse practitioner, physician or psychologist.
 - The medical exception letter may be presented when in a public setting if requested by enforcement officials, or retrospectively in court if a ticket is issued.

- If you do not bring a mask, one will be provided for you at a cost.

SOCIAL DISTANCING

- Maintain SOCIAL DISTANCING (6 feet) while at the show venue. We are providing extra space to maintain these distances so you do not encroach upon the person in front of you, be respectful.
- Due to COVID-19 protocols, there will be a maximum number of people allowed at each one of the show fields at one time.

WRIST BANDS

- Every day, before you can enter the show venue, you will fill out the COVID-19 Assessment Tool located in this Premium List and bring it to the Screening Station. At this time, ***please present your DogShow receipt which confirms your entry & arm-band number*** (on an electronic device or printed by you).
- Upon acceptance, an AKC volunteer will give you a wristband and watch you place the wristband on your wrist. The wristband is ONLY GOOD for one day. The COVID-19 Screening can be done at any time throughout the day, at any Screening station.
- You will need to show your wristband to the gate steward before you can enter the show ring with your dog.
- The AKC will refuse entry into the show precincts and rings to anyone without a wristband.
- Each exhibitor will receive a maximum of ONE wristband only per entry. NO replacement wrist bands will be issued.

SHOWING / TRIALING

- Exhibitors should arrive on the grounds ONE HOUR prior to their scheduled show/trial time and allow time for COVID-19 screening. **The COVID-19 screening stations will be open one hour before show time.**
- **No X-pens, floor mats or tables will be allowed at ringside or in the holding areas.**
- If you are unable to attend/exhibit due to COVID-19 or any other ailment, it is your responsibility to find an alternative handler for your dog, if you wish your dog to participate.

BENCHING

- 10' x 10' **pre-paid** reserved benching spots in close proximity to the agility rings will be available to CKC agility exhibitors beginning 3:00 pm Thursday, July 29. You **MUST** reserve benching for this area. The cost will be \$40 for the weekend.
- Very limited space will be available free of charge under a Day Benching tent. Spots will be first come first served and once the tent is filled no other spots will be made available. **Nothing** can remain in the Day Benching tent overnight.

FOOD

You will not be able to eat in the building. The concession may or may not be operating. To be determined whether if there will be food trucks available if the concession is closed.

REFUND POLICY
