TWO CKC LICENSED FIELD DOG TRIALS, September 13 & 14, 2025

The Brittany Spaniel Club of Canada will conduct a CKC licensed field trial for all pointing breeds near Mortlach, SK on September 13 & 14, 2025. All stakes will be walking. Judges will be mounted on horseback. This trial is held under the rules of The Canadian Kennel Club, 5397 Eglinton Avenue, W, Suite 101, Etobicoke, ON M9C 5K6.

Stakes - Saturday, September 13 and Sunday, September 14, 2025

| Amateur Shooting Dog Stake | For dogs 6 months of age on the first day of trial. | \$75.00 |
| Open Shooting Dog Stake | For dogs 6 months of age on the first day of trial. | \$75.00 |
| Stake Out Fee | Per Entrant | \$5.00 |

STAKE OUT Fee in effect. Each entrant will pay a \$5.00 Stakeout Fee. This is a one-time charge for the event for all participants on the grounds. Proceeds from the fee are paid directly to the landowner to offset incidental pasture damage from vehicles and animals. Please include this with your entries.

Entry Requirements - TCNs/ERNs

6.1.2 If a dog is not registered in the CKC Stud Book, it may be entered at a trial held under these regulations with a Temporary Competition Number (TCN) provided that: (a) If born in Canada, it is of a litter which is eligible for CKC registration (b) If not born in Canada, it is eligible for individual registration in the records of the CKC (c) If foreign born and owned, it obtains an Event Registration Number or CKC registration number, from the CKC within 30 days of the first trial entered.

6.1.3 The entry of a dog with a Temporary Competition Number (TCN) at a field trial held under these rules (sanctioned field trials are excluded), must be accompanied by the appropriate TCN fees. All fees, TCN and recording, must be submitted to the CKC by the club holding the trial within 21 days following the trial.

Field Trials have inherent risks that the Brittany Spaniel Club Canada takes all responsible steps to minimize. All entries for this Field Trial are accepted on condition that the BSCC, its officials and members, land owners, are released from all liabilities for loss, damage or injury sustained by dog or person in conjunction with, or during the running of, this Field Trial. All minors shall be under the direct care and supervision of the parent or guardian. All persons entering these grounds will be required to sign a waiver prior to entering or engaging in any activities on these grounds. Waivers are available for download from dogshow.ca for this event. Waivers are to be submitted prior to the start of the trial.

TRIAL INFORMATION:

- Course and Birds: This will be a single course trial and pheasant will be released on course. There may also be naturally occurring upland game birds present.
- Running and Handling: All stakes will be walking. There will be no horseback handling and no horseback gallery.
- Judges will be mounted on horseback.
- Blank pistols .22 caliber or larger will be fired over all dogs with bird work in senior and derby stakes. Blank pistols will not be fired in the puppy stake, unless both handlers agree to it.
- Total entries will be limited to the number of dogs that can be run in the available daylight hours.
- Puppy and Derby Stakes will be a maximum of 30 minutes in length. Open and Amateur Shooting senior stakes will be at least 30 minutes in length. If there is a large entry, the Derby stake may be shortened to 20 minutes and the Puppy to 15 minutes.

- Collaring a dog away after game contact will be allowed as per judge's instruction.
- Bitches in season will be permitted to run at the end of each day. If you have a BIS, advise the trial secretary immediately via email: boxerbounces@gmail.com.
- Backing tests: If a dog has placed in one of the senior stakes of the Trial and needs only a backing test to complete the requirements for a Championship, the handler may request a backing test. This test will be allowed at the discretion of the Field Trial Chair and will depend on the availability of birds. The test will cost \$35.00.
- Tracking Collars: The BSCC is allowing the use of electronic tracking collars in this trial. Only tracking collars that are legal for use in Canada and meet the CKC guidelines will be allowed. Participants must declare that they are using the tracking collars to the Field Trial Chair and also to the judges. Only Garmin GPS collars that are approved for use in Canada and will be permitted.

NOTE:

- a) As per rule 11.4.10 "With the exception of tracking collars, collars to be worn in competitive stakes must be of a type solely used for purposes of identification. That is, the normal dog collar with name plate attached or coloured collars used to distinguish between dogs in a brace."
- b) As per rule 11.6.6 "no more than two collars may be worn by a dog."
- It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind.
 - **Reminder:** there will be no exercising or training of any dogs on the grounds, before, during, or after the trial without the permission of the field trial chair or field trial secretary.
- Handler Accommodation:

As per rule 2.6.1 "At the judge's discretion a modification to the exercise/routine may be made to accommodate a handler with disabilities providing that such modification does not aid the dog's performance."
- All participants must be familiar with CKC Rules and Regulations and also the rules, conditions and provisions of this Premium List. CKC Field Trial Rules are available from the CKC. **NOTE: Make sure you review the rules for Field Dog Trials (available on the CKC website: www.ckc.ca)**

LOCATION:

Mortlach Field Trial Club - 4.5 miles north of Mortlach, SK We are grateful to have the use of these donated grounds for the purpose of this trial. We ask for your co-operation in keeping the grounds free of litter by using the garbage receptacles provided. Parking will be restricted to the marked areas and limited if grounds are wet.

* No smoking will be allowed on the trial grounds. Smoking is only permitted in your parked vehicles or RV.
