GENERAL INFORMATION

- ENTRY FEES SHALL NOT BE REFUNDED AFTER THE CLOSING DATE in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Trial Committee, or because it has been entered incorrectly. If because of riot, civil disturbance, or other acts beyond the control of the Club, it is impossible to open or complete the show, no refund of entry will be made. Overpayments will not be refunded.
- ENTRY FEES WILL BE REFUNDED WHEN A BITCH ENTERED IN OBEDIENCE COMES INTO SEASON after entry of the bitch has been submitted if a Veterinarian's certificate, (certifying that the bitch was in season within the ten-day period preceding the trial), is delivered to the Trial Secretary on or before the date of the trial.
- Entries must be typewritten or clearly printed. Owners are responsible for errors on entry forms. Cal K-9 Obedience Club of Calgary does not assume any responsibility for incorrect information or errors due to illegibility of information on any entry form.
- Make cheques payable to Cal K- 9 Obedience Club of Calgary. No post-dated cheques will be accepted.
- ENTRIES WILL BE ACKNOWLEDGED AFTER CLOSING DATE. Receipts and judging schedule will be emailed. Please ensure email address is printed on your entry form. Armband numbers will be available one hour before the trials begin. **There will be NO hard copy catalogues available at the show. The catalog will be posted on www.dogshow.ca for download by the participants the day of the trial.**
- (Chapter 3, Section 3.6.1 CKC Obedience Trial Rules & Regulations). "A judge officiating at a trial held under these Rules shall not be subjected to indignities of any kind during the progress of the trial. It shall be the duty and obligation of the club holding the trial to see that this rule is effectively carried out."
- ALL DOGS MUST BE KEPT UNDER CONTROL AT ALL TIMES. If not in competition, the dog must wear a collar and be on a leash a maximum length of six (6) feet or appropriately confined in the benching area.
- Dogs must be exercised in designated areas ONLY.
- All empty rings are to be kept free of dogs.
- An exhibitor has the right to withdraw an entry. This Notice of Withdrawal must be in writing and received by the Show Secretary on or before the official closing date and time as published in the Premium List.
- All Miscellaneous Class Dogs who do not have a Certification Number can only compete at the Novice level in Obedience Trials and must pay a listing fee of \$10.50. Those dogs with a certification number may proceed through all levels. Titles will only be awarded to those dogs that have been certified.
- In Transit permits will be available from the trial secretary if needed. Dogs not entered in the trials in the regular classes or exhibition only will not be permitted in the building without an In Transit Permit.
- Performance Event Number (PEN) allows an unregistrable dog of a CKC recognized breed to participate in competitive events that are appropriate for the breed. For more information regarding applying for a PEN visit www.ckc.ca.
- Cal K-9 Obedience Club of Calgary, its members and volunteers will use due care and diligence for the welfare of dogs and exhibitors, BUT will not be responsible for, nor assume any liability in the event of an accident or other misfortune to either dogs, exhibitors or patrons.
- The Trial Superintendent has the authority to expel any dogs deemed to be a danger to other dogs or people. There will be no refund for dogs that are expelled.
- The CKC will not consider a request for any corrections to results if received more than 90 days following the date(s) of the event(s).

20.7 "It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer, or competitor at an Obedience Trial held under these regulations, is not subject to indignities of any kind. The Obedience Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred."

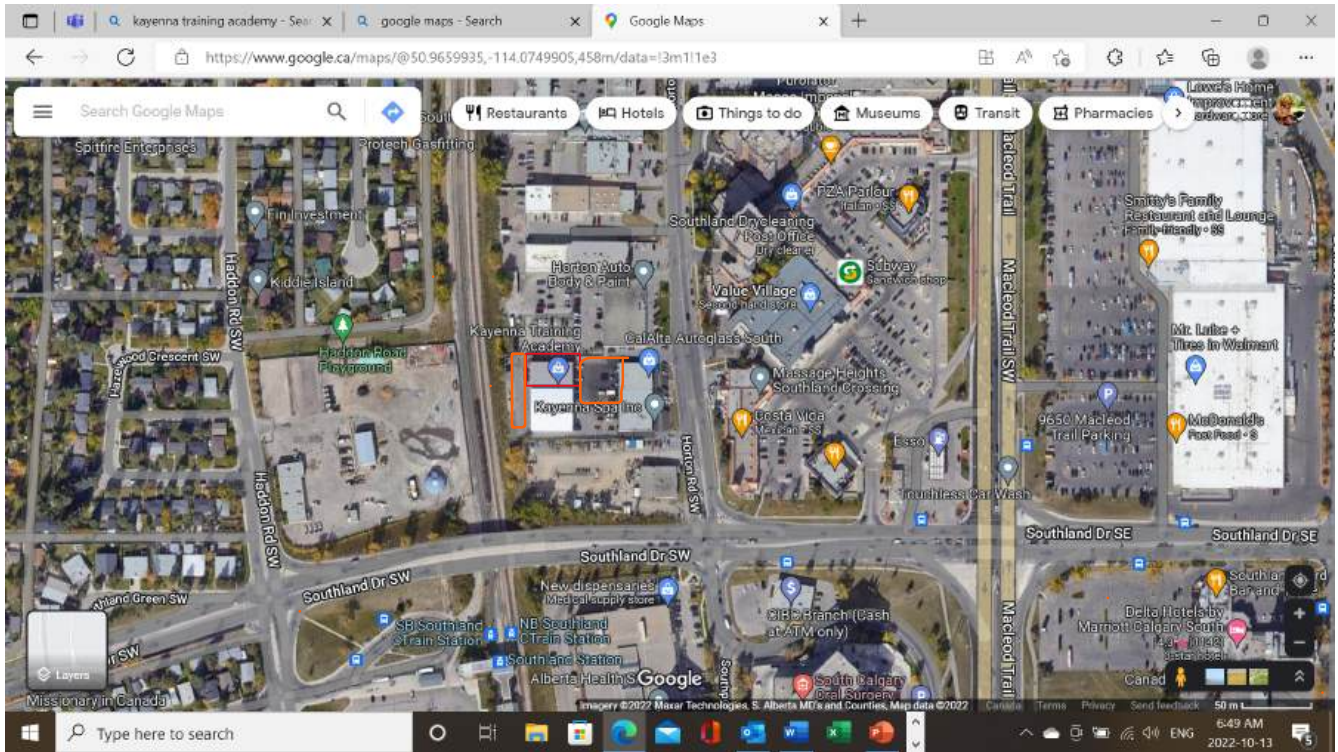
