**Location & Facility Information**

Good As Gold Training located at 4303 – 11<sup>th</sup> Street SE in Calgary, AB. Rings are fully matted. Plenty of parking is available in either the North lot or the South lot adjacent to the building, or on the street. Please enter the building through the main doors facing 11<sup>th</sup> Street. We kindly request that all dogs are pottied outside before entering the building. If an accident does occur inside, please clean it up & notify the staff.

**Outdoor shoes are not allowed on the facility matting; please bring a pair of indoor shoes to wear when walking on the facility matting.**

**Benching**

FREE on-site limited benching; please be respectful and only use what you need. Benching will be a mixture of either using the facility kennels or your own crate or benching from your vehicle. There are 10 large, 4 medium and 24 small facility kennels available for exhibitor use in the training area. Any dogs benched in the training area must be well behaved and not be reactive to dogs walking past. Any dogs that are being disruptive in the training area will be asked to bench out of your own vehicle; so be prepared to bench out of your vehicle if necessary. Please do not dump water on the facility matting; if you set up a crate on the matting consider putting a blanket/mat underneath your crate and please ensure your crate is clean.
