- Entry Fee structure:
- \$20/RUN • ALL 15 RUNS SAME DOG \$270
- FFO (for fun only) runs allowed: \$17 • NO LATE OR DAY-OF ENTRY
- July 20 is LIMITED to 250 RUNS and July 21 to 200 RUNS— competition entries will be given priority over FFO if needed
- Entries only accepted by online through Agility Rocks! (<http://www.agilityrocks.com/>) Do not mail your entries!
- Package prices are applied on Agility Rocks! after you finish selecting your dog's runs.
- Confirmations will be sent by email only.
- Start time will be announced with judging schedules
- Parking at Thunderbird for this event is \$5.00 per vehicle per day

It is the responsibility of the exhibitor to be familiar with the rules pertaining to the event in which they are competing.

NOTE: SAME DAY MOVE UPS WILL BE ALLOWED. e.g. Novice Standard Trial #1 to Intermediate Standard Trial #2.

Equipment and course familiarization:

- A warm – up area with a single practice jump will be provided for dogs entered in the trials.
- Handlers in all classes are permitted to walk the course, without a dog, prior to the start of the class. Only those entered in a class are permitted to walk the course.
- There will be no equipment familiarization period for dogs prior to the beginning of the trial.

List of Awards and Prizes:

- Ribbons (flats) will be provided for 1st – 4th in each class and jump height.
- Qualifying ribbons (flats) will be awarded for all dogs receiving a qualifying score in each agility trial.
- Title ribbons (rosettes) are available at the trial secretary desk.
- A Qualifying score is 85 points or more out of a possible 100 points, with no non-qualifying deductions except Master Excellent where a perfect run is required.

**Rosettes and prizes will also be awarded in Trial 3 for qualifying tollers only:

High Toller in Trial, Top Toller Novice, Top Toller Intermediate, Top Toller Excellent, Top Toller Master Excellent and Top Toller Veteran

Trial precincts Ring 2: The precincts of the trial are all areas reserved for the sole use of the NSDTRC of Canada and Leaps and Bounds Agility Club. Only Dogs entered in official classes are permitted within the precincts of the trial.

Agility Rules and Regulations: It shall be the duty and obligation of the trial giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Agility Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred

Withdrawal of entries:

Anyone wishing to withdraw an entry prior to the closing date MUST notify the trial secretary. After closing date only partial refunds may be provided at the direction of the trial committee. Full refunds will be provided for anyone who needs to withdraw due to illness—if you are sick, stay home!

Foreign Exhibitors Entry Payment: Please note that fees are due and payable in Canadian dollars. . Your understanding and cooperation is appreciated. Thank you.

General Information:

1. All dogs are to be certified to be free of all communicable diseases.
2. Bitches in Season are not permitted to compete. Entry fees will be refunded when a bitch comes into season after their entry has been submitted to the Trial Secretary, when a veterinarian's certificate, certifying the bitch was in season within the 10-day period preceding the trial.
3. Judging schedules, will be sent by email to exhibitors on or after July 14, 2024.
4. Before each trial the judges will provide a course design which will be posted before judging begins. COURSE MAPS WILL NOT BE PROVIDED VIA EMAIL. INDIVIDUAL PAPER COPIES WILL NOT BE PROVIDED. Multiple printed copies will be posted. You are welcome to take photos of the maps for individual use.

The owner of a dog entered in this event is entirely responsible for any errors in the entering of the dog, regardless of how, or by whom the entry was made. Please check your confirmations for accuracy.

No on-site Concession.

This event is run by volunteers. There will be a sign up to help. Many hands make light work. Please volunteer

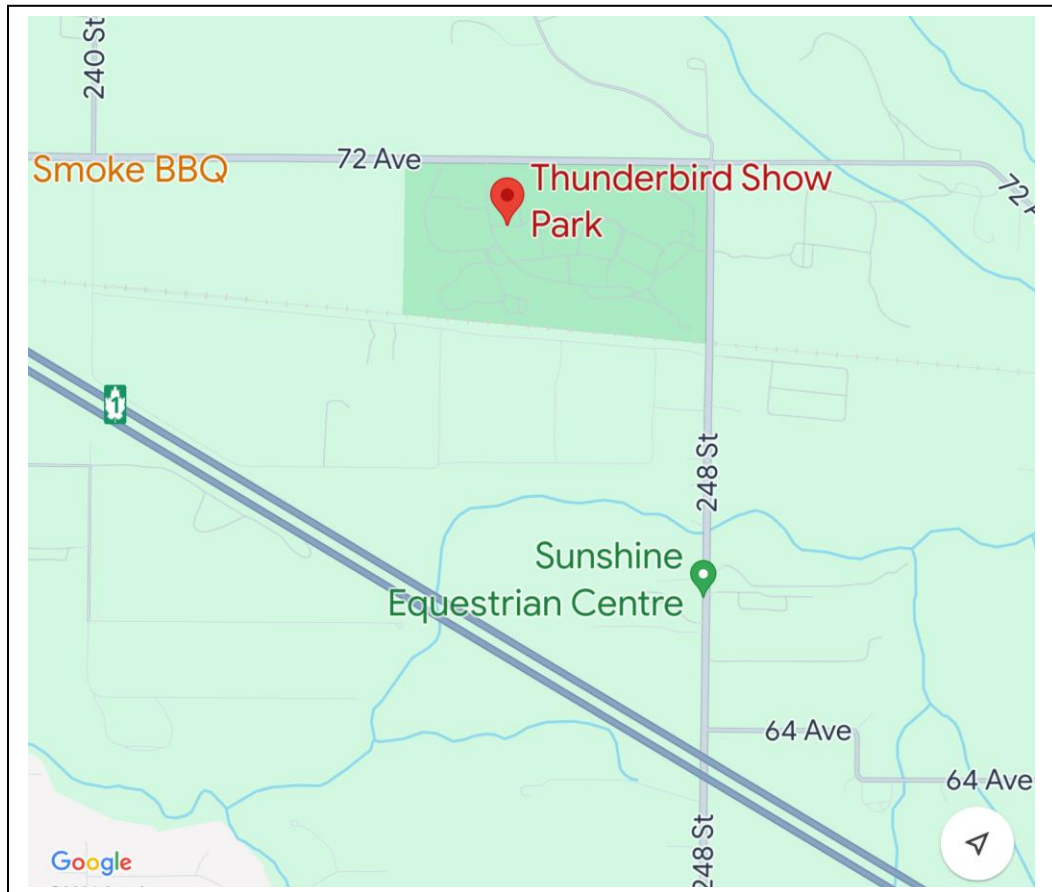
NON-MEMBER PARTICIPATION FEE FORM
