**ZERO TOLERANCE** – Any individual initiating bullying tactics at the CARIBOO KENNEL CLUB Events will be asked to leave the show grounds premises immediately and for the remainder of the event (no refunds). A report will be filed with CKC and the Disciplinary Committee shall have the authority to take such action as it deems fit. Including and not limited to suspension from attending the event for a specific period of time in the future, including permanently.

The RCMP can and will be called to deal with any form of abuse be it verbal or physical altercation or threats of violence against members of The CARIBOO KENNEL CLUB, Club Volunteers or staff of The CARIBOO KENNEL CLUB or Staff.

**Definition of Bullying:** *Refers to a range of behaviors in which targeted individuals are repeatedly, and over time, treated in a mean, insulting or abusive way. Bullying can be initiated deliberately or unconsciously. The affected person may feel upset, afraid, isolated, or humiliated. The bully sometimes acts alone and sometimes as part of a group of people.*

*Examples include:*

- *insulting a person's skills, looks, or habits*
- *spreading false or malicious rumors, gossip, or innuendo*
- *berating/belittling an individual*
- *unwarranted criticizing or ridiculing, especially in the presence of others*
- *giving insulting nicknames*
- *engaging in practical jokes that humiliate*
- *undermining or deliberately impeding a person's work*
- *physical gesturing that intimidates, offends, degrades, or humiliates*
- *mocking a person's accent, abilities or mannerisms*
- *yelling or shouting which intimidates, coerces, or belittles*
- *intruding on a participant's privacy by pestering, spying or stalking*
- *physically abusing or threatening abuse*
- *criticizing a participant persistently*
- *constantly belittling a person's opinions.*

This applies to interpersonal and electronic communications, such as email, Facebook, text messaging, Twitter and Instagram.

**CARIBOO KENNEL CLUB has a ZERO tolerance of abuse of any description involving any person involved with CARIBOO KENNEL CLUB Trials, including spectators.**
