- 2. There will be no Late Entries nor Day of Show Entries accepted.
- Trials will be held indoors in the Owl Barnat Swamp Dog Farm on rubber matted concrete floors. Outdoor blind of 10' x 20' will be used. No indoor crating is available. Classes will be alternating between 2 rings.
- 4. Parking is near the barn and will be designated
- 5. There is no kitchen or kitchen area at the trial site. Morning tea and coffee will be made available and we are planning a potluck for Saturday lunch and reserving for dinner at the Driftwood Restaurant. Sunday lunch we are planning on a sandwich bar. More information will be forthcoming.
- 6. The site is wheelchair accessible. There are two portable toilets outside the barn, and one is wheelchair accessible
- 7. Smoking is not permitted anywhere on the property.
- 8. Competitors with multiple dogs will run in different staging groups.
- 9. Please let the TRIAL SECRETARY know as soon as possible if you will be entering a bitch in season.
