Alternates will be contacted in catalogue order and advised of the opening. They may choose to accept the spot and become responsible for the entry fee or decline and bear no financial obligation. Anyone on the "Alternate List" may request a refund at any time prior to test day. Entries will be refunded within 10 days of the test date to those on the alternate list that did not participate in the test.
