
From Calgary – South on the #2 Highway, exit at the Okotoks overpass.


Proceed south through the town of Okotoks to the intersection of #2A and #7 Highways. (There will be a Sobeys on your left at the intersection.)

# **GENERAL INFORMATION AND TEST RULES (Cont'd)**

**ENTRIES:** Entries must be complete, signed and submitted on the official CKC entry form. The order of competing shall be the order that entries are received.

### SAME DAY MOVE UPS WILL BE ALLOWED as per Rule 6.7.1

**CLOSING DATE:** <u>30 minutes before the scheduled start of class</u> or when the stated limit has been reached. Online entries close at 9:00 pm July 28, 2015. Entries will close automatically when the following limits have been reached for each test: 10 Master Earthdog even if the official closing date and time for the entries has not arrived. Entries are accepted on a first come, first served basis. Entries for all other classes are not limited. If the ME class limit is reached prior to the closing date, a list of alternates will be kept to fill any vacancies created due to early (prior to closing date) cancellations. Entry fees will not be refunded after the closing date and time.

**CONFIRMATION OF ENTRY:** The receipt of entries will be confirmed for those providing a **return e-mail address** on their entry form.

**BITCHES IN SEASON:** Bitches in season shall not be eligible to enter the test. When a bitch comes into season after entry of the bitch has been submitted to the test secretary, a veterinarian's certificate, certifying that the bitch was in season within the 10 day period preceding the test must reach the secretary on or before the date of the test. The trial-giving club must refund the entry fee, service charge and listing fee.

**QUARRY:** The quarry used in these tests will be 2 adult gerbils.

**ATTENTION FOREIGN EXHIBITORS:** Please note that fees are due and payable in Canadian dollars. Due to fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted. If you pay by personal American cheque, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Do not write "Payable in Canadian Funds" or "At Par". This will not be acceptable and will not be cleared by the bank. To simplify the process, we urge you to purchase bank drafts or money orders payable in Canadian funds.

**BORDER CROSSING:** Government regulations require a valid rabies certificate for dogs entering Canada from countries not recognized by Canada as being rabies-free. The European Union pet passport is an acceptable alternative to the rabies vaccination certificate as long as all the elements outlined in the requirements are included. **EVENT REGISTRATION NUMBER (FOREIGN BORN/FOREIGN OWNED DOG):** For the purpose of entering CKC events to obtain CKC titles, individual registration is not required for foreign born, foreign owned dogs. Foreign exhibitors may apply for an ERN (Event Registration Number). This number MUST be applied for within 30 days of entering first CKC event to avoid cancellation. Exhibitors may submit a photocopy of dog's foreign Registration Certificate and the appropriate fee along with the completed application form. The form can be downloaded from <a href="http://www.ckc.ca/forms">http://www.ckc.ca/forms</a> or is available by contacting the CKC Order Desk at 1.800.250.8040.

**AWARDS & PRIZES:** Qualifiers in IQ will receive a Ribbon. Qualifiers in JE, SE and ME will receive a Rosette. Border Terrier Canada is pleased to offer prizes to all Border Terriers qualifying in Test I or Test II. The Canadian Scottish Terrier Club is pleased to offer prizes for qualifying Scottish Terriers competing under Lia Bijsterveld in the following classes Test I – SE and ME, Test II – JE.

**TEST PRECINCT:** The entire field south of the buildings. Dogs waiting to be tested shall be kept at least 30.5 m (100ft) from the perimeter of the test area in a designated holding area.

**REGULATIONS:** It is the responsibility of the exhibitor to be familiar with the rules pertaining to the event in which they are competing. Copies of the CKC Earthdog Test Regulations are available from the Canadian Kennel Club. Tel: (416) 675-5511.

**CKC REGULATION 15.7:** It shall be the duty and obligation of the event giving club to see that a judge, club official, volunteer or any participant at an Earthdog Test held under these regulations, is not subject to indignities. The Earthdog Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

**TEST SITE:** Bring water, shade and shelter for you and your dogs. These tests will be run **rain or shine**. All dogs must be under control, on a leash except during the test. Flexi leads will not be allowed within the test precinct. Remember that this is private property and we are here at the pleasure of our hosts. Clean up after yourself and your dog. Please follow the directions of our parking sheriff! As is the case with most Earthdog Tests, the ground at the site is uneven. Wear appropriate footwear.

**WAIVER:** Please complete the enclosed waiver that excludes the property owners, Border Terrier Canada, and/or any person associated with the Earthdog Test from any liability for personal injury or personal property damage and submit it with your entry.

# BORDER TERRIER CANADA ROOM RESPONSIBILITY POLICY

(adapted with permission from the Border Terrier Club of America Room Policy)

Border Terrier Canada (BTC) has adopted the following rules in order to insure that its members and their dogs will be welcome at hotels in the future:

Any individual attending a Border Terrier Canada (BTC) sanctioned event and staying in a hotel, motel, inn or campsite/fairground has the responsibility of leaving that room or campsite exactly as found. This includes picking up after dog(s) on the grounds. Anyone who damages a room or campsite/fairground and does not report the damage to the hotel/campsite/fairground management, and make immediate restitution or arrangements to do so within a period of time agreed upon by the management, will be subject to any or all of the following actions by the BTC Board of Directors.

- 1. May be banned from showing at the next BTC sanctioned event(s).
- 2. May be subject to CKC sanctions.
- Membership in the BTC may be terminated and may not be allowed to be reinstated.

### Damages shall be defined as:

- Flea infestation, urine, defecation and/or any damage to hotel/campsite/fairground property (walls, bedspreads, carpets, drapes, etc.).
- 2. Any verified complaint by the host hotel/campsite/fairground.
- 3. Any verified complaint by a BTC member.

### **BTC Room Regulations:**

- All dogs shall be crated and quiet when left alone in a room. Noisy dogs shall be quieted upon request, even if this means the owner/handler must stay in the room with the dog.
- Individuals will be expected to immediately report any damage by dogs or themselves to the hotel or campsite/fairground management, and to assume complete financial responsibility for those damages.
- No bathing or grooming will be allowed in rooms. A grooming room will be available whenever possible.
- Dogs are to be allowed on hotel furniture/beds ONLY if the furniture is covered with protective covering provided by the owner/handler.
- All owners/handlers will take preventative measures to assure that their dogs are free of fleas, mites, intestinal parasites and other communicable diseases prior to arriving at the hotel/campsite.

The fee is a yearly charge based on the calendar year January 1 to December 31 in which the awards, legs, points, titles, etc. were achieved. It is not based on the number of dogs or titles or awards earned, and is assessed against the owner(s).

Non-members will receive a letter from CKC Head Office informing them that they have 30 days to join the Club or pay the Non-Member Participation Fee.

Payment of the Non-Member Participation Fee or becoming a CKC member will protect all awards, points, titles and legs in the calendar year in which they were earned. Failure to pay the fee within 30 days of the notice will result in all awards, legs, points, titles being cancelled. Once cancelled the awards, legs, points or titles will be given to the next applicable dog. Once cancellation takes place any subsequent awards titles, legs, etc. earned will automatically be cancelled without further notice.


