## Sunday May 26th Trial

**Started** - Container, Interior, Exterior Area **Advanced** - Container, Interior, Exterior Area **Excellent** - Container, Interior, Exterior Area

This titling event is being held under the rules of the Sporting Detection Dogs Association \*Dogs must be registered with the SDDA and be over six (6) months of age.

#### **Registration Closing Date:**

Thursday May 15th 2019 at 12PM MDT <u>or when trials fill</u>. Space is limited per level - if day does not fill onsite entries will be accepted

Fees:

All 3 components (C-I-E) entry - for levels Started/Advanced/Excellent - \$90.00 Single component (Container/Interior/Exterior) entry - \$35.00

Entries:

Entries open: For **RPs: Friday March 29 at 7pm MST; For Non-RPs Monday April 1 at 7pm MST.** Host reserves the right to refuse entry.





### **KNOW BEFORE YOU ENTER:**

- Your Registered Participant (RP) number, and your dog's SDDA number
- Your competition stream: Amateur or Working check the rule book for current definitions
- If you earn your Component Q/ title on Saturday, do you want to move up to the next level on Sunday?
- Could your dog earn a new Championship Title at this event? Check the rule book for current
- requirements; select any that apply so we can ensure we have enough ribbons on hand.
- Alert/Indication: \*NEW\* This form requires each behaviour on a separate line.

If you are entering Advanced or higher, know ahead of time which ONE BEHAVIOUR you will put in each of the two fields.

<u>Entry Limits</u>: Note: Competitors may enter one dog per level per day. Second dogs will not be permitted to run in the SAME level with the SAME handler on the SAME day. Host reserves the right to change level availability based on entry numbers.

<u>Waitlist</u>: If the trial fills a waitlist will be maintained. Should a space become available it will be offered to waitlist members.

<u>Entry Confirmation</u>: Confirmations will be emailed upon receipt. Payment is due upon confirmation of entry. Payment must be sent within 72 hours of receiving confirmation or your space will be released.

<u>Refunds</u>: Refunds will be issued for any dog withdrawing for medical reasons. A Veterinarian Certificate must be submitted before the start of the trial. For handlers withdrawing for medical reasons a refund will be issued <u>if the space can be filled</u>. All refunds are subject to a \$5 per entry processing fee.

<u>No Shows</u>: Are considered competitors who are not present as of the time of their level briefing and who have not made contact with the Host to give notice. No refunds will be given for No Shows. No show spaces will be made available to those who showed up for onsite entries.





**General Rules and Regulations**: Through submission of your entry, you acknowledge that you have reviewed, and agree to abide by, the Rules and Regulations in the Master Rule Book on the SDDA website: <u>www.sportingdetectiondogs.ca</u> Specific site related rules and guidelines will also be shared with competitors before and at the trial with the expectation that these will also be strictly adhered to. All dogs in attendance must be over 3 months of age. All dogs must be on a **flat collar** or **harness in the search area**.

#### TRAINING AND/ OR UNOFFICIAL USE OF ODOUR IS NOT PERMITTED ON TRIAL GROUNDS.

**Titles**: All three (3) components (Container, Interior, Exterior) must be successfully completed (qualifying scores earned) to earn the SD-S, SD-A or SD-E title. The SP (Special) designation will be added to the title of any dog that completes the three components on the same day, at the same trial. All three (3) components (Container, Interior, Exterior) must be successfully completed (qualifying scores earned) SD-EL title.

Awards and Prizes: Qualifying ribbons will be presented per component; rosettes will be awarded for placements (1st – 3rd) in each component as well as overall for both streams. SDDA New Title rosettes will be awarded for new amateur titles in all levels.

Running Order: This will be decided by random draw and displayed for competitors.

**Bitches in Heat**: Bitches in heat may compete, but must wear panties when trialing and will be placed at the end of the running order for each component. Handlers must notify the trial secretary of a bitch in heat prior to arrival at competition.

**Crating**: Indoor benching will not be provided. Come prepared to bench in your vehicle or outdoors in the designated area.

Parking: Ample free day parking is available onsite, ask at sign in for any restrictions.
