

# 4 CKC Sprinter Trials \*Limited entry, 75 dogs per event\* July 19 and 20, 2025

Mixed and Unrecognized Breeds are welcome

Entries close **July 12, 2025** or when the limit is reached, whichever occurs first.

Day of entries will be accepted if trials are not full.

Waiver forms MUST accompany entries (found at the end of the premium).

This is a TEAM EVENT. Each team consists of 1 dog and 2 handlers. Waiver forms **MUST** accompany entries (found at end of Premium List)

CKC rules state that 'It is recommended that an owner or someone familiar with the dog stand at the finish in order to catch the dog once the course has been completed.'

There will be three groups per day. 1) 9:00 AM 2) 12:00 PM 3) 2:30 PM. Please watch your emails after the closing date for your assigned group. Please email the event secretary if you wish to be in a group with a specific person. These times are the safety huddle times. Please be early and prepared for the huddle at the assigned time.

# **Directions to the field**

From Saskatoon: Drive West on Hwy #7
Turn right on Wild Rose Road (354)
In 500m turn right onto 3073 (by blue sheds and pipes)
In 1 km turn right into driveway

Approx. GPS coordinates: 52°02'20.5"N 106°55'40.8"W



- This is a physically intensive sport. Ensure you properly warm up your dog before their run and cool down your dog after.
- This is an outdoor event. BRING YOUR OWN WATER AND SHADE.
- Please clean up after your dogs/yourself! There will be a garbage at the secretary's tent.
- Please park in designated areas.
- There will be a Port-A-Potty on site.

- Enter online at dogshow.ca
- Mail in entries with cheque to the Event Secretary.
- Make cheques payable to Saskatoon Kennel and Obedience Club.

No entry will be accepted without payment in full! Tendering of an NSF cheque in payment of entry fees will be considered nonpayment of entry fees and is an offence punishable by CKC disciplinary action and cancellation of awards.

## **EARNING POINTS**

The dog's time to complete the 100 meter dash is converted into Kilometers Per Hour (KPH). A handicap system is applied to a dog's KPH to determine the number of points earned. The handicap system is based on the height of the dog at its withers:

- 18" or greater handicap is 1.25
- 12" up to less than 18" handicap is 1.5
- Below 12" handicap is 2.0

**Points**: 360 divided by the dog's time produces the dog's KPH which is multiplied by the dog's handicap to result in the number of points earned. Ex: A 16" dog takes 20 seconds. 360/20 KPH x 1.5 = 27 points. Points are rounded to the nearest whole number. Please be sure to enter the correct height category

## **AWARDS AND TITLES**

- A qualifying ribbon will be awarded to each dog that achieves a score.
- A rosette will be offered to new title holders.
- Turtle Award to the slowest qualifying time in each trial

The titles dogs may earn in Sprinter events are:

Novice Sprinter (NS): 150 pts Veteran Novice Sprinter (VNS): 75 pts

Sprinter (S): 500 pts Veteran Sprinter (VS): 250 pts

Advanced Sprinter (AS): 1000 pts Veteran Advanced Sprinter (VAS): 500 pts

Sprinter Excellent (SX): 1500 pts Veteran Sprinter Excellent (VSX): 750 pts

Sprinter Excellent 2, 3, etc for each Veteran Sprinter Excellent 2, 3, etc for each

additional 500 pts earned additional 250 pts earned

Veteran Titles are for dogs over the age of 7. You MUST select the **VETERAN BOX** on your entry form in order for points to count towards veteran titles. If the selection is not made, your dog's points will go towards regular titles, regardless of their age.

# **Additional Information**

- Dogs run once per trial. There are 2 trials per day.
- Bitches in Season will be permitted to run. They must wear panties and will be put at the end of the run order in their group. Please notify the trial secretary ahead of time if possible.
- Lame dogs will be excused and their entry refunded, provided notice is given prior to or during roll call. Dogshow.ca fees are non-refundable.
- Dogs not present at roll call shall be scratched with no refunds. No Exceptions.
- Roll call / inspection will be done near the trial secretary tent.
- Muzzles, fitted, flat buckle collars (no tags) and catch collars are permitted. The dog may run 'naked'
- No Flexi-leads, electronic or prong/pinch collars allowed.
- No loose dogs on the property at any time. Any dog off leash when it is not your turn running will be charged a \$10 fine per offense. Any dog off leash after the first offense may be excused for the weekend.

- Please clean up after yourselves and your dogs. Do not stuff plastic bags down holes
- Do not leave dogs unattended.
- Give other dogs and handlers plenty of room
- Dogs are expected to be excited in the presence of the lure, however handlers must be able to control their dogs for everyone's safety or they will be refunded their entry and excused.
- The club reserves the right to bar known aggressive dogs from the event site.
- The dog finishing their event must be caught, leashed, and exit the field before the subsequent dog may be permitted to enter the field.
- The track will be fenced with temporary fencing

## Saskatoon Kennel and Obedience Club Sprinter Waiver

RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT.

By signing this document, you will waive certain legal rights, including the right to sue or claim compensation following an accident. Please read this document carefully.

In consideration of acceptance of the entry and the opportunity to have the dog judged and to win ribbons or prizes at the Sprinter events held by the Saskatoon Kennel and Obedience Club, I agree to hold the Saskatoon Kennel and Obedience Club organizing committee, club members, officers, directors, volunteers, employees, (further referred to as the SKOC) and owners of the premises upon which the event(s) is held, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog(s) while in or upon the event premises, or grounds, or near any entrance thereto, and I personally assume all responsibility and liability for any such claim.

I agree to hold the SKOC harmless from any claim for loss of this dog by disappearance, theft, death or otherwise and from any claim for damage or injury, even if such loss or damage/injury was caused or alleged to be caused by negligence of SKOC or any other person(s);

I assume the sole responsibility for and agree to indemnify the SKOC harmless from any and all loss and expense, including legal fees, by reason of the liability imposed by law upon the SKOC for damage because of bodily injuries, including death at any time resulting there from, sustained by any person(s), including myself, or on account of damage to property, arising out of or in consequence of my participation in the event, however such injuries, death or property damage may be caused and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the SKOC or any other person(s);

I agree that any cause of action, controversy or claim arising out of or related to the attendance at the event between the SKOC and myself or as to the construction, interpretation and effect of this waiver shall be settled by arbitration in the province of Saskatchewan

I agree that the SKOC has the right to refuse this entry for cause, which the SKOC will deem sufficient.

I understand while participating in this activity, I or my dog(s) may be photographed. I agree to allow my photo, video, or film likeness to be used for any legitimate purpose by the activity holders, producers, sponsors, organizers, and assigns.
