Please check in with the Trial Secretary upon your arrival to the trial site and present each dog's registration card.

Dogs must be under control at all times. Please pick up after your dogs promptly and note that your dog must be on leash when not crated or in the search areas. Any handler displaying inhumane or aggressive treatment of any dog, the public or other handlers (physically or verbally) will be asked to leave the premises without refund.

All dogs must be on a flat collar or harness in the search area. Leashes must be cloth or leather of any length in the search area.

Competitors, through the submission of their entries, acknowledge that they know the Rules and Regulations. See the Rule Book on the SDDA web site www.sportingdetectiondogs.ca to familiarize yourself with all rules.

General Information:
