Please note that fees are payable in Canadian funds. Due to fluctuating currency, discounted cheques will not be accepted.

Personal cheques will be accepted; however, they are payable in Canadian funds. If you send a cheque in US funds; it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques 'Payable in Canadian Funds' or 'At Par' as they will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation are appreciated! Thank-you.

Important: Entries accepted until 5:00PM on Sunday, July 14th. Entries must be in possession of the Show Secretary at closing time.

ENTRY INFORMATION

- Sanctioned Agility Matches are open to any dog <u>12 months or older</u> on the day of the match. No unentered dog is to be on the show grounds unless registered as Exhibition Only.
- 2. No entry will be accepted unless accompanied by the entry fee.

REFUND INFORMATION

Entries can be withdrawn, and a full refund obtained for any reason up to the day/time that entries close, i.e., July 14, 2019. Entry Fees will be refunded after the closing date only for bitches that comes into season within 10 days of the Match. For this refund, a letter from a Veterinarian must be presented to the Trial Secretary prior to the commencement of the Match.

ELIGIBILITY

Dogs may be spayed or neutered and/or debarked. Dogs must be 12 months of older to compete in a Sanction Match. Dogs may not be lame. The ring will be outdoors on grass with snow-fencing barrier. The ring precinct includes the ring and 10 feet surrounding it. The Match precinct is the venue of 97 LeDrew's Road, CBS, NL.

GENERAL INFORMATION

- The only dogs permitted on site are entered for competition or Exhibition Only.
- Dogs with or who have been exposed to communicable diseases within the last 30 days are not permitted to enter and are not allowed in the Match venue (see Section 6.11).
- Exhibition-Only dogs shall not enter the agility ring during the Match.
- Agility prizes: Dogs placing 1st through 4th in each jump height class will receive a Flat ribbon.
- On the day of the match, the Match Superintendent has complete charge of the Match.
- Ring building begins promptly at 7:30AM. All competitors must arrive on time to assist
 in ring building. First dog on the line promptly at 9AM.
- The Match Committee will use due care and diligence for the welfare of dogs and exhibitors but will not be responsible for, or assume any liability, in the event of an accident or other misfortune to either dogs or patrons.
- All exhibitors are required to volunteer in the ring during classes/jump heights in which they
 are not running, as well as course building/tear down. A volunteer schedule will be provided.

IMPORTANT NOTICES TO ALL EXHIBITORS Please Read and Observe the Following:

- **1. NO SMOKING** on any of the property at 97 LeDrew's Road except inside personal vehicles.
- 2. Parking. Off-street parking will be available on-site.
- **3. Crating Space.** Several event/shade tents will be provided courtesy of the match host for crating ringside. This space is limited, so please stack crates as much as possible and limit the amount of floor space being used. No ex-pens or personal tents.
- **4. Bring your own Chair.** Exhibitors must bring their own chair for use.
- **5. Bathroom facilities** will be available on-site.
- **6. Food** will be available for purchase at the match site, in support of the NKC and a future official CKC Agility Trial. *Please bring cash!*

Important: A Bitch in season **may not** compete in CKC Agility Sanction Matches/Trials. See Refund Information for further details.
