DIRECTIONS FROM SWARTZ BAY FERRY TERMINAL

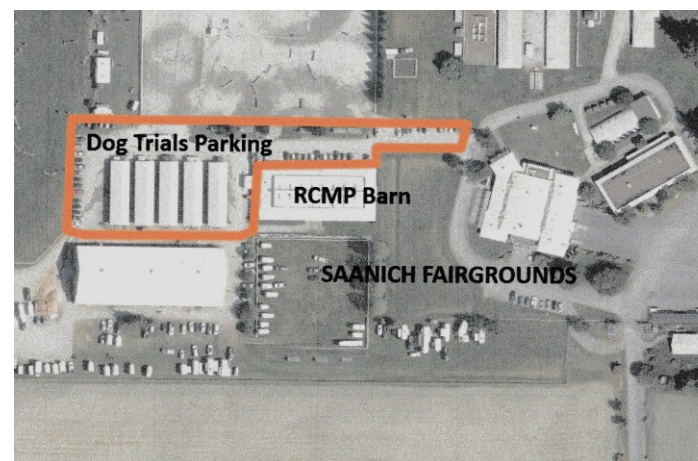
HEAD SOUTH ON HWY 17 TOWARDS VICTORIA FOR APPROX 11 KMS, TURN RIGHT AT MT NEWTON CROSS RD (TRAFFIC LIGHTS). TURN LEFT AT WALLACE DRIVE (4 WAY STOP). TURN RIGHT ON STELLYS X RD & SAANICH FAIRGROUNDS WILL BE ON YOUR RIGHT.

DIRECTIONS FROM NANAIMO

HEAD SOUTH ON HWY 1 TOWARDS VICTORIA & TURN LEFT ONTO MCKENZIE TO HWY 17 HEADING NORTH TOWARDS THE SWARTZ BAY FERRY TERMINAL. AT APPROX 15KMS, TURN LEFT AT MT NEWTON CROSS RD (TRAFFIC LIGHTS). TURN LEFT AT WALLACE DRIVE (4 WAY STOP). TURN RIGHT ON STELLYS X RD & SAANICH FAIRGROUNDS WILL BE ON YOUR RIGHT.

PARKING

PLEASE ENTER VIA MAIN GATES IN THE CENTER OF THE FIELDS (BY THE 'HOME OF THE SAANICH FAIR' SIGN). THERE WILL BE A SMALL 4H EVENT AT THE AGRIPLEX, BEHIND THE RCMP BARN. **OUR MAIN PARKING AREA IS OUTLINED IN ORANGE** TO THE NORTH AND WEST OF THE BARN.
