Send a photocopy of the dog's registration certificate reflecting current ownership with a written request for an ERN. Please indicate coat type and size if applicable. Fee for an ERN with the CKC is \$50.00. Include your payment in the full amount in Canadian dollars. Payment may be made with VISA or MasterCard, personal or business cheque or money order. For non-members, please note that discounted cheques or money orders will not be accepted due to fluctuating currency rates. Provide your full return address. Faxed requests will be accepted. Please ensure that your VISA or MasterCard number is legible and you have included the expiry date of your card as well as your signature. An ERN must be obtained within thirty (30) days of obtaining points, awards or scores to avoid cancellation. If factors beyond your control prohibit this or present a problem, please send a written request for a thirty (30) day extension. OBEDIENCE TRIAL RULES

- 1. The Obedience Trial Chairman is in complete charge of the trial.
- No dog will be allowed in the building or on the grounds unless entered in the trials.
 No dog is to be left off leash at any time on or near the grounds of the trial except in the obedience rings. Violation of this rule can result in dismissal from competition. No refund shall be made.
- 4. Exhibitors must wear the correct number while in the ring.
 5. A dog who has earned its CD degree in the U.S.A is not eligible for entry in the Novice A class and a dog which has earned its CDX in the U.S.A. is not eligible for entry in the Open A class. Such dogs must be entered in the B classes.
- 6. Obedience fees for bitches in season will be refunded upon the provision of a veterinarian's certificate proving same.

GENERAL INSTRUCTIONS

- No dog will be allowed to compete unless entry fees have been paid.
 The Trial Committee has the right to refuse any entry subject to CKC rules.
 The club will use due care and diligence for the welfare of the dogs and exhibitors, but will not be responsible for, or assume any liability in the event of an accident or other misfortune, either to dogs, exhibitors or patrons.
 A judge officiating at the trial under the Obedience Trial Regulations and Standards shall not be subject to indignities of any kind during the progress of the trial. It shall be the duty of the club holding the show to see that this rule is effectively carried out. The Trial Chairman shall promptly report to the Canadian Kennel Club any infringement of this rule. The Roard of Directors shall have the power to take action as it doesns fit on the receipt of a general. this rule. The Board of Directors shall have the power to take action as it deems fit on the receipt of a report indicating that this rule has been violated.
- 5. If because of riot, civil disturbance or other acts beyond the control of the trial holding club, it is impossible to open or to complete the trials, no refund of entry fees will be made.
- 6. Fees must accompany your entries. Tendering a NSF cheque shall be considered an offence punishable by disciplinary action and cancellation of awards by the Canadian Kennel Club. There will be a \$15.00 fee charged for any NSF chaque issued. No post-dated chaques accepted. Overpayments will be donated to the trophy fund.
