**Running Order:**

The running order draw will take place at the home of the OVPDC Treasurer (Stephanie Edh) on August 16 at 8:00pm. The water test will be starting with WDJ followed by WD and WDX tests and ending with the WDE. OVPDC is running 3 CKC water tests (which have been approved) by the CKC for August 26 in Ambertrail grounds in Maxville, Ontario.

The order and time of the water tests will be determined once entries are closed on August 7 or when the test is full. The drawing will be "random" and specific time cannot be assigned.

The OVPDC reserves the right to rearrange the running order of the water test should conditions warrant. First three dogs (in WDJ) will be notified by phone or email. However, OVPDC recommends for the WDJ test 1 that handlers be present at the latest by 7:45am at Ambertrail. It is the responsibility of entrants to confirm receipt of their entries.

AGREEMENT OF EACH ENTRANT In consideration of the acceptance of my/our entry (ies) and of the holding of the test and of the opportunity to have the dog tested and to win ribbons or trophies, I/we acknowledge and agree as follows:

- 1) The Ottawa Valley Pointing Dog Club (OVPDC) may refuse any entry for just cause, which the OVPDC deems to be sufficient.
- 2) Field and water tests have certain inherent dangers associated with them, including, without limitation, those due to the presence and/or use of firearms, and as such any person participating in the test or being present on the test grounds assumes the associated risks.
- 3) To hold the Canadian Kennel Club (the "CKC"), any CKC approved judge, the OVPDC, its members, directors, officers, agents, committee members, test secretary, official gunners at the test and the owners or lessor of the test grounds and any employees of any of them (collectively, the "Club"), harmless from:
  - a) Any claim for loss or injury which may be caused or alleged to be caused directly or indirectly to any person or thing by any act of any dog I have entered in the test, or am responsible for, while in or upon the test grounds, or near any entrance to the test grounds;
  - b) Any claim for loss of any dog I have entered in the test, or am responsible for, by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether the loss, disappearance, theft, damage or injury is caused or alleged to be caused by the negligence of the Club or any other person or any other cause or causes;
  - c) For bodily injuries, including death at any time resulting from bodily injuries, sustained by any person or persons, including myself/ourselves, any minors for whom I/we is or are responsible or on account of damage to property arising out of or in consequence of my/our or their participation in the test or presence on the test grounds, however such injuries, death or damage to property may be caused and whether or not caused or alleged to be caused by negligence of the Club or any of them or any other person; and

I/we personally assume all responsibility and liability for any such claim; and I/we further agree to assume the sole responsibility for and agree to indemnify and save the Club harmless from any and all losses and expenses (including legal fees) by reason of the liability imposed by law or a court of competent jurisdiction upon the Club or any of them for any of the foregoing.

I/We agree to be bound by this Agreement of Each Entrant printed in the Official Premium List. I/We certify and represent that the dog entered is not a hazard to persons or other dogs.
