HOW TO QUALIFY

The 2025 National Master Hunt Test is open to:

- Any dog with a CKC Master Hunter title or AKC Master Hunter title who has successfully completed two CKC Master Hunter passes* at hunt tests hosted by clubs in good standing of the Canadian National Master Retriever Club** during the period of August 25, 2024, to August 4, 2025
- Any dog with a CKC Grand Master Hunter title
- Any dog that qualified in the most recent National Master Hunt Test
- Any dogs that have passed a USA Master National or Amateur Master National inclusive from January 1st of the preceding year until the closing date of the current year's event.

JUDGES

Zone 1 Catherine Veysey Fredericton, New Brunswick

I am honoured and humbled to have been selected as one of the three judges to attend the 2025 Canadian National Master Hunt Test on Vancouver Island, and I thank the selection committee for their confidence in me.

My Dad was an avid duck hunter, and we always had a Golden Retriever in our home who was not only a family pet but also accompanied us on any outings to the marshes. I learned at an early age the value of a retriever on a hunt and their determination to get the job done. I always wanted my own Golden but raising two daughters, getting them through school and university took priority. Once they were on their own, I said, "Now it is My Time". So, 15 years ago I started on my journey with my first Golden Retriever "Murphy". I knew nothing about the Hunt Test/Field game but knew I wanted to play it. I sought out videos,



periodicals, like-minded folks and experienced successful trainers who were willing to share with me their time and expertise. My Murphy finished his career as a GMH. My boy Race a MH. My 3rd dog, Flyer, is a GMH and QAA and my new guy, Decoy, who just turned one year old, just completed his WC and has two JH passes. I also train and trial my boys in Obedience, Rally and Tracking of which we have been successful and titled. I have participated in two CNMHT's. The first in 2018 and the second in 2024. They were both amazing experiences.

Ten years ago, I figured it was time to give back to our clubs and our sport by obtaining my Judges Certification. Over the years I have been invited to judge Hunt Tests in New Brunswick, PEI, Nova Scotia, Cape Breton Island and Quebec. Sitting in that chair "behind the line", has taught me so much about the game and I am so happy I took that step. I want to wish all the teams attending the 2025 CNMHT a great week and enjoyable experience. I'm so looking forward to meeting my co-judges and all of you.

Zone 2 Susan Bell Puslinch, Ontario

In 1980 we had our first Labrador Retriever litter under the prefix "Pinebank Kennel" and in 1984 Pinebank Kennel became Permanent Registered with the CKC. Since then, we strive to produce Labradors that can do it all! We had a couple of Irish Water Spaniels, and I trained a Cavalier King Charles Spaniel in Obedience. I love to work with my dogs, and they teach us a lot about ourselves and life.



Training my pups has led to teaching and now judging. I have enjoyed judging all levels of CKC Obedience, Rally Obedience, Working Certificate and Hunt Tests and Canine Good Neighbour Tests. I have judged the Puppy Stake at the LOC Field Trial and Junior Handling for both Obedience and Conformation, as well as Sweepstakes for the Irish Water Spaniel Association of Canada and the Atlantic Labrador Retriever Club. I have been the Canine Good Neighbour Rep for Zone 6 and the Obedience Rep for the CKC. A few years ago, I was a Director for University of Guelph Pet Trust and held positions on the Board of LOC and Hamilton Dog Obedience Club and Labrador Retriever Club of Canada.

My dogs and I have worked together to achieve Conformation Championships, Grand Master Obedience Trial Champion, Rally Master Obedience, Grand Master Hunter, Working Certificate Excellent, Tracking Dog Excellent and Canine Good Neighbour Titles. Five different dogs I have trained have been in the top ten Obedience Dogs in Canada. I have trained eleven different dogs in Rally Obedience since it started, and twelve Utility Dog obedience titles, eight of those dogs received their MOTCH. Four of my dogs I have put Master Hunter Titles and 2017 and 2019 Grand Master Hunters; another dog has his first Master Hunter leg, and another dog is working in the Senior Title.


Now that I am retired, my time is spent having fun with my dogs and helping others with their dogs, training my dogs and I love it.

INFORMATION FOR EXHIBITORS

HEALTH

This notice is to provide clubs with a reminder regarding the rules and regulations for the health of all dogs on the event premises.

No dog may be brought onto the grounds or event premises if it:

- 1. is known to have distemper, parvovirus, kennel cough or other communicable disease.
- 2. has recovered from distemper, parvovirus, kennel cough or other communicable disease within the last 30 days (prior to the event), or
- 3. has been housed within 30 days prior to the event on premises on which there existed distemper, parvovirus, kennel cough or other communicable disease.

Clubs have the right to remove a dog from the event premises and the exhibitor may be subject to disciplinary action if it is found that CKC rules have been contravened.

BEHAVIOUR AND CONDUCT

The Canadian National Master Hunt Test adheres to the CKC Rules and Regulations regarding all conduct and behaviour on the grounds. Additionally:

- After a series has begun, no participating dog shall leave the area of the series until after it is tested or excused by the Marshal, or it is otherwise excused by the Hunt Test Committee
- No dog shall be exercised, trained or worked on the grounds for the duration of the test except for bumpers thrown by handlers in approved areas, only for the purpose of exercising the dog
- Designated exercise areas will be clearly defined and shall not be used for working or training purposes
- Any dog not entered in the stake and interfering with the running of the stake may be required to be removed
- Dogs not appearing on the line upon being called will be given 15 minutes to do so otherwise they will be disqualified
- Rotation of starting dogs will be directed by the Marshal

ENTRY

The entry fee is \$250.00 (Canadian funds) per running dog. Any dog which does not have an individual CKC registration number, must have a CKC TCN or ERN (if foreign), CKC PEN or CKC MCN. An annual non-member participation fee for awards and titles will be charged to a Canadian Non-Member of the CKC. The fee will match the ERN fee. The non-member participation fee is \$170.00 (Canadian funds) plus tax.

- The Non-Member Participation Fee applies to dogs **wholly owned by a resident of Canada** who is not a member of the CKC; it is not applicable to CKC members or dogs co-owned with a CKC member.
- For the title to be awarded, the non-member will have a choice to either become a CKC member or pay the Non-Member Participation Fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level. (For a Membership application, please go to www.ckc.ca under CKC Services and Forms On-Line).

Entries will close Monday, August 4th, 2025 @ 7:00 pm PDT. Please direct inquiries to the test secretary, Mary Shillabeer at lottadoghair@shaw.ca. ALL entries must be submitted via www.dogshow.ca.

SCRATCHES

Bitches in season may not compete and must be withdrawn. All entry fees paid will be refunded provided that a hard copy of a veterinarian letter is provided to the secretary before the test begins. If the dog is found to be in season at the official vetting, the assessment of the official veterinarian shall also be considered as sufficient proof.

Entry fees paid for a dog withdrawn due to injury, illness or death shall be refunded in full provided that a hard copy veterinarian letter is received by the secretary no later than seven days after the completion of the stake.

Otherwise, any scratches that occur after the closing date of August 4th, 2025, will not have entry fees refunded.

VETTING OF BITCHES

All entered bitches shall be examined by the official veterinarian at the Swamp Dog Farm barn headquarters on Sunday August 17, 2025, at 1PM. Spayed females will be exempted from vetting if a veterinary certificate of spaying accompanies the entry form.

AWARDS

All dogs receiving a qualifying score will receive a duck band, rosette and the title of National Master Hunter and shall be entitled to add the NMH prefix to the registered name.

TRAINING SITES

Training will be available at Swamp Dog Farm until August 13th. Booking can be made at https://www.swampdogfarm.org/training From August 13th-21th, off-site training grounds will be designated and information regarding these sites will be available at the CNM headquarters at Swamp Dog Farm. **Limited birds will be available for training, by request and donation** via Tracey Griffin tracey@cedarbraelabs.ca

THE EVENT

On Monday, August 18, 2025, at 7:30 am, entrants and spectators will depart the barn at Swamp Dog Farm to the site of the first test. The test dogs will demonstrate the test at 8:00 am to start each day of the event, except the Upland on Wednesday, which will be 9:00 am.

All handlers and workers must wear dark or camouflaged clothing or customary hunting attire.

Ducks and/or pheasants will be used in all series. Live pheasants may be used for the upland test.


