CKC NON-MEMBER PARTICIPATION FEE

The Non-Member Participation Fee applies to dogs wholly owned by a resident of Canada who is not a member of the CKC; it is not applicable to CKC members or dogs co-owned with a CKC member. In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the Non-Member Participation Fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level. (For a Membership application, please go to www.ckc.ca under CKC Services and Forms On-Line). The Non-Member Participation Fee is fee paid in the calendar year (January – December) in which the dog achieved its title and/or titles.

ATTENTION FOREIGN EXHIBITORS

Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted; however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be

made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated. Thank You."

GENERAL INFORMATION

This is an outdoor event. In the event of bad weather there is no cover provided over the rings.

Judging will not commence prior to 8:00 am

The show precincts will be a 150-foot (45m) perimeter from the exterior of the rings.

The obedience venue will be Field 1, within the perimeter outlined by the road from the house to, but not including the trailer/RV sites.

Catalogues will be provided at no cost to exhibitors.

The Trial Chair will be in full charge of the trials, governed by CKC rules.

If, because of riot, civil disturbance, or other acts beyond the controls of the management, it is impossible to open or complete the trial, no refund of Entry Fees will be made.

Noteworthy Farm Show Services and the Miramichi Kennel Club will use care and diligence for the welfare of all dogs, exhibitors and spectators, but will not be responsible for, nor assume any liability in the event of accident or misfortunes however caused.

GENERAL ENTRY INFORMATION

To comply with instructions issued by the Canadian Kennel Club, we will be unable to accept entries reaching the Show Secretary after the official closing date as published in this premium list.

No entry will be accepted unless all particulars called for on the entry form are shown thereon. INCOMPLETE ENTRIES WILL BE RETURNED. NO ENTRY WILL BE ACCEPTED UNLESS ACCOMPANIED BY ENTRY FEES.

TELEPHONE ENTRIES CANNOT BE ACCEPTED.

It is your responsibility to verify the receipt of any electronic entries prior to the advertised closing date.

NOTEWORTHY FARM SHOW SERVICES, reserves the right to refuse any entry, subject to CKC Dog Show Rules.

Identification cards and judging schedule will be mailed / emailed as soon as possible after entries close.

Conflicts between Dog Show Rules and the New Breed Standards. The Board of Directors of the CKC, has ruled that where a conflict arises between the Breed Standards and the Dog Show Rules that the Dog Show Rules will take precedence.

Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entry was made. Changes or cancellation of any entry after closing date is prohibited.

In the event that the dog is absent, excused by a veterinarian or Judge, disqualified, or barred from competition by action of the bench Committee, no entry fees will be refunded.

To avoid noise and confusion, there will be no individual dogs called to the ring by loudspeaker. Delays waiting for dogs will not be possible and handlers with several breeds must arrange for alternate handlers if judging times for their breeds conflict.

Only dogs eligible for registration with CKC may enter this show and trial.

The Miramichi Kennel Club reserves the right to refuse any entries, subject to CKC rules.

TROPHIES & AWARDS

A rosette will be offered for Best In Show, Best Puppy in Show, Best Baby Puppy in Show, All Group placements, Best Puppy in Group and Best Baby Puppy in Group each day.

Suitable prizes will be offered each day for all General Specials Classes, BBIS, BAIS, BVIS, BIS, RBIS, BPIS.





These trials are open to Canine Companion Dogs (CCN) and areNOT LIMITED.

OFFICIAL OBEDIENCE CLASSES The following class descriptions are from the CKC Rule Book. <u>THESE OBEDIENCE AND RALLY TRIALS ARE OPEN TO</u> <u>RECOGNIZED AND LISTED BREEDS ONLY</u>

No dog may be entered in both Novice "A" and Novice "B", Open "A" and Open "B" at the same trial. In determining class eligibility, if a dog shall have won a particular title before being entered or moved up, the handler shall have been notified by at least 2 different judges that the dog has won 3 qualifying scores for the required title. (However, a dog may continue to be exhibited for 60 days in a class after winning a particular title.) Dogs fulfilling the requirements for a title may be moved to the next level of competition if the schedule permits. The transfer must be on the appropriate move-up form and submitted to the show secretary at least 15 minutes before the start of the class.

PRE-NOVICE - The Pre-Novice class is an elective class and earning the title is not a requirement to enter Novice classes. The Pre-Novice class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has not earned the title of P.C.D. Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class. The same handler must handle each dog in all 5 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the group exercise. Only dogs that have not earned the title of C.D. may enter the Pre-Novice class.

NOVICE A - The Novice A class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has not earned the title of C.D. Only one dog per handler is allowed in this class, and that person must handle the dog in all exercises. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families. No person who has trained or exhibited a dog that earned a C.D.X. title shall be allowed to handle a dog in this class.

NOVICE B - The Novice B class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has not earned the title of C.D. Dogs in this class may be handled by the owner or any other person. The owner or any other person may handle a dog in this class. A person may enter more than one dog in this class. The same handler must handle each dog in all 6 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the group exercises.

NOVICE C - The Novice C class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned the title C.D. or any higher obedience titles. Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class. The same handler must handle each dog in all 6 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the group exercises. Dogs may compete in Novice C indefinitely. Scores earned by dogs in the Novice C class are not eligible for High In Trial and do not qualify a dog for any title. Dogs may be entered in the Novice C class in addition to any other official or unofficial classes for which they are eligible.

NOVICE INTERMEDIATE - The Novice Intermediate class is an elective class and earning this title is not a requirement to enter the Open classes. The Novice Intermediate class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned a C.D. or any higher obedience trial titles. Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class. The same handler must handle the dog in all 6 exercises. Dogs may compete in the Novice Intermediate class indefinitely. Scores earned by dogs competing in this class are not eligible for High in Trial.

Dogs may be entered in the Novice Intermediate class in addition to any other official or unofficial classes for which they are eligible.

OPEN HA - The Open HA class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of C.D. but has not earned the title of C.D.X. The handler of any dog in this class must be the owner, co-owner or member of their immediate families. Only one dog per handler is allowed in this class, and that person must handle the dog in all exercises. Any person who has trained or exhibited a dog that has earned a U.D. title may not handle a dog in this class.

OPEN 18A -The requirements are the same as Open HA and the same rules except the Long Sit is replaced with Change of Positions Exercises and the Long Down is replaced with a Group Sit-Walk around.

OPEN HB - The Open HB class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of C.D. Dogs which have earned the title of C.D.X. or any higher titles may enter in the Open B class. A dog may also be entered in the Utility Class in the same trial. Dogs in this class may be handled by the owner or any other person. A person may enter or handle more than one dog in this class. The same handler must handle each dog in all 7 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged

together in the group exercises. Prior to the start of judging, the judge will choose which of the six numbered routines

is to be performed. This choice will not be disclosed to the exhibitors until it is posted at ring side at least 30 minutes before the start of the class. In future assignments, judges are required to alternate the six routines so that each set will be used approximately the same number of times.

OPEN 18B – The requirements are the same as Open HB and the same rules except the Long Sit is replaced with Change of Positions Exercises and the Long Down is replaced with a Group Sit-Walk around.

UTILITY A - The Utility A class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of C.D.X. but has not earned the title of U.D. Any person who has trained or exhibited a dog that has earned a M.O.T.Ch. title may not handle dogs in this class. The handler of any dog in this class must be the owner or member of their immediate families. Owners may enter more than one dog in this class. The same person must handle the dog in all exercises.

UTILITY B - The Utility B class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of C.D.X. or U.D. Dogs in this class may be handled by the owner or any other person. Owners may enter more than one dog in this class. The same person must handle the dog in all exercises. Prior to the start of judging, the judge will choose which of the six numbered routines will be performed. This choice will not be disclosed to exhibitors until it is posted at ring side at least 30 minutes before the start of the class. In future assignments, judges are required to alternate the six routines so that each will be used approximately the same number of times.

OFFICIAL RALLY CLASSES

The following class descriptions are from the CKC Rule Book THESE OBEDIENCE AND RALLY TRIALS ARE OPEN TO RECOGNIZED AND LISTED BREEDS ONLY

No dog may be entered in both Advanced "A" and Advanced "B" at the same trial or Excellent "A" and Excellent "B" at the same trial.

RALLY NOVICE A - Dogs competing in this class may not have won a CKC Rally Novice (R.N.) title or any CKC Novice Obedience title. No handler who has exhibited a dog through its CKC Companion Dog Excellent (C.D.X.) title or instructed dog training classes shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or member of their immediate families. A person may enter more than one dog in this class. A dog may continue to compete in this class after the owner has been notified by at least 2 different judges

that the dog has won 3 qualifying scores in this class. However a dog may not be entered or exhibited in this class in any rally trial after the owner has received official notification form the CKC that the dog has won the title.

RALLY NOVICE B - Any dog may compete in this class until a qualifying score in the Rally Advanced class is earned. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged on leash, and all dogs must enter and leave the ring on leash.

RALLY INTERMEDIATE - This class shall be for dogs that have earned the R.N. title. A dog completing the R.I. or any other obedience or rally titles may continue to compete in this class indefinitely. The owner or any other person may handle dog in this class. A person may enter more than one dog in this class.

RALLY ADVANCED A - This class shall be for dogs that have won the Rally Novice (R.N.) title but have not won the Rally Advanced (R.A.) title or any CKC Novice Obedience title. No handler who has exhibited a dog through its CKC Companion Dog Excellent (C.D.X.) title or instructed dog training classes shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. A dog may continue to compete in this class after the owner has been notified by at least 2 different judges that the dog has won 3 qualifying scores in this class.

However, a dog may not be entered or exhibited in this class in any rally trial after the owner has received official notification from the CKC that the dog has won the title.

RALLY ADVANCED B - This class shall be for dogs that have won the Rally Novice (R.N.) title. A dog completing the Rally Advanced (R.A.) title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged off leash. All dogs must enter and leave the ring on leash.

RALLY EXCELLENT A - This class shall be for dogs that have won the Rally Advanced (R.A.) title, but have not won the Rally Excellent (R.E.) title or any CKC Novice Obedience title. No handler who has exhibited a dog through its CKC Companion Dog Excellent (C.D.X.) title or instructed dog training classes shall be eligible to enter this class. The handler of any dog in this case must be the owner, the co-owner, or a member of their immediate families. A person may enter more than one dog in this class, A dog may continue to compete in this class after the owner has been notified by at least 2 different judges that the dog has won 3 qualifying scores in this class. However, a dog may not be entered or

exhibited in this class in any rally trial after the owner has received official notification from the CKC that the dog has won the title.

RALLY EXCELLENT B - This class shall be for dogs that have won the Rally Advanced (R.A.) title. A dog completing the Rally Excellent (R.E.) title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class, A person may enter more than one dog in this class. All exercises are judged off leash except the Honor Exercise. All dogs must enter and leave the ring on leash.

RALLY MASTER - This class is for dogs that have earned the RE title. Any person may handle the dog in this class. Dogs must earn 3 qualifying scores of 85 points or more under at least 2 different judges.

Note: Tests will run concurrently (i.e. each dog will run their second test in the same time block as their first). The running order will be cycled through TWICE, giving dogs a break between tests.

8:00-9:00am – First heat of ~12 dogs (~24 runs)

9:15-10:15am – Second heat of ~12 dogs (~24 runs)

10:30-11:30am – Third heat of ~12 dogs (~24 runs)

11:45am-12:45pm – Fourth heat of ~12 dogs (~24 runs)

1:00-2:00pm – Fifth heat of ~12 dogs (~24 runs)

2:15-3:15pm – Sixth heat of ~12 dogs (~24 runs)

3:30-4:30pm – Seventh heat of ~12 dogs (~24 runs)

Note: Each test is its own event; therefore, dogs must be inspected each time. Inspection will take place at the beginning of each time slot/heat.

HOW THE EVENT IS RUN

Please read this carefully

You are responsible for reading the club waiver (attached) which you will **electronically sign** with your online entry. Your helper (if you bring one) must complete a paper waiver and bring it to the tests (or email it to <u>patrickmudge2@yahoo.ca</u> beforehand). You are responsible for calculating/checking your own points and knowing if your dog has achieved any titles. Your dog's Sprinter points (earned *after* August 28, 2019) are now available on your CKC online portal. The calculations and handicaps are available via the Sprinter Rules & Regulations from the CKC website at:

https://www.ckc.ca/en/Files/Forms/Shows-Trials/Event-Rules-Reg ulations/Sprinter-Rules-and-Regulations-Effective-January-1 On arrival for your scheduled time slot:

- 1. When you arrive, go to the main check-in station for the lameness and in-season inspection. You will need to swab your bitch with a tissue for in-season check amd all entries will also be measured.
- 2. Two to three dogs before your run, proceed to the start line waiting area with your dog and have your Catcher (which may be you or your helper) proceed directly to the finish line with a leash. *Unless it is a dog's very FIRST Sprinter Test weekend, Catchers CANNOT wait at the start line then walk/run down the chute when their dog steps to the start line for their turn. The Catcher must ALREADY be at the finish line and ready to catch the dog as the dog steps to the start line with their **Releaser.*** Dogs may run "naked" or wear a flat, snug-fitting buckle catch collar with nothing hanging from it that can become entangled in the line (NO running in martingale or slip collars and NO tags on catch collars). You may walk your dog to the start line in a martingale, slip collar or harness, but it MUST be removed prior to releasing them.
- 3. Once your dog runs and is caught and leashed, **clear the chute area**, and prepare for their second run. For safety

reasons, please stay CLEAR of the chute when walking your dog back from the finish line.

- 4. The running order is cycled through TWICE (repeat steps 1-3) and dog the runs its second, and final, run for the day.
- 5. Once you have completed your two runs per dog, collected your ribbons and times from the table, and taken your photos, please feel free to stay and enjoy the day at Noteworthy Farm, have lunch at the Woodsmoke Café and cheer on your friends. There are other events you might want to participate in.

OTHER EVENT INFORMATION

You will need to crate your dog in/by your car. There will be no shade provided so please keep your dog cool by keeping windows open, using shade cloths, and providing fresh water (Water is available on site). There's plenty of room for pop-up tents. All competitors must bring ***TWO* leashes**, one each for the Releaser and Catcher. A slip leash is ideal for the Catcher. You may bring your own helper to act as your Catcher or Releaser. If you are not bringing a helper, you may list another exhibitor as your helper or request that a club volunteer release your dog. This information will be gathered in a form via email ~2 weeks before the tests.

There will be a **Title Log sheet** at the main check-in table to record any titles your dogs have earned that weekend if you would like us to include them in our event wrap-up on the Miramichi Kennel Club Facebook page. Also, Noteworthy Farm would appreciate and will post any event pics/candids anyone wishes to share. (again to <u>patrickmudge2@yahoo.ca</u>)

Please ask for help when getting your title and Q ribbons from the check-in table. There are different rosettes for each Sprinter title and club members will help you get the right one.

There will be a "photo booth" set up near the parking area with title/event boards. Feel free to take some pictures of your dog with their ribbons.

The Miramichi Kennel Club will be following all current federal, provincial, and local COVID rules at the time of the tests ** Further information, if required, will be emailed to participants with the running orders prior to the event. Stay up to date here: <u>https://novascotia.ca/coronavirus/restrictions-and-guidance/</u> **Important Notes: Please respect instructions, pick up after and maintain control of your dog. Retractable leads, prong collars, and electronic collars are not allowed on the premises. Owners may have their dog wear a muzzle, if they desire. Dogs may run "naked" or wear a flat, snug-fitting buckle catch collar with nothing hanging from it that can become entangled in the line. You may walk your dog to the start line in a martingale, slip collar or harness, but it MUST be removed prior to releasing them. There is a risk of injury for all active sports; you can reduce this risk by warming up and cooling down your dog, only running your dog when you feel the field and weather are appropriate and staying aware of your environment and any safety hazards. A \$10 fine, payable to Miramichi Kennel CLub, will be levied for any dog loose on the field from the time of inspection until the completion of all events for the day. A \$10 fine, payable to ECSA, will be levied for any exhibitor not picking up after their dog. Events run rain or shine.

Eligibility: Purebred or mixed-breed dogs must be at least 12 months of age that are: (a) Individually registered with the CKC, (b) Have an Event Registration Number (ERN), (c) Have a Performance Event Number (PEN), (d) Eligible for registration with the CKC, or (e) Have a Miscellaneous Certificate Number (MCN) if it belongs to a CKC listed breed (f) Have a Canine Companion number (CCN) if it is a mixed-breed.

Bitches in Season: Bitches in season shall not be eligible to enter these tests.

Awards and Prizes: Qualifiers will receive flat ribbons. Rosettes will be provided for dogs achieving a title during these events.

Attention Foreign Exhibitors: Please note that fees are due and payable in Canadian dollars.
