# **NOTE: WATER TEST RULES & REGULATIONS Section 17**

It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer or competitor at a Water Test is not subject to indignities. The Water Test Committee Chairman shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

EVENT REGISTRATION NUMBER (ERN#): Effective January 1, 1992 all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will no longer require a CKC Registration number, but will require an Event Registration Number (ERN#) The ERN# MUST be applied for within 30 days of the first day of entering a CKC EVENT.
