ATTENTION CANADIAN EXHIBITORS - INFORMATION REGARDING TITLES:

The following has been copied from the CKC website:

Attention Canadian Residents

At the December Board meeting input provided by the membership was reviewed and considered to the board regarding the noticed posted to the CKC website on November 6, 2010 regarding a new Tracking fee for non-members. The Board has made changes to the original motion approved at the September Board meeting and the following motion was passed in December and therefore the following non-member participation fee now applies and is retroactive to January 1, 2011.

The non-member participation fee applies to all Canadian residents who participate in a CKC event and a participating non-member can choose to purchase a CKC membership or pay the non-member fee. This only applies to dogs wholly owned by non-members and is not applicable to CKC members or dogs co-owned with a CKC member. In order for the CKC to efficiently manage recording and tracking points, it's important that non-members select one of the two options within 30 days of notification or, unfortunately, we will be forced to cancel any awards and titles.

24-12-3. Non-member participation fee

- An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.
- In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.
- The Premium List must carry a note stating that these fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.

ATTENTION EXHIBITORS:

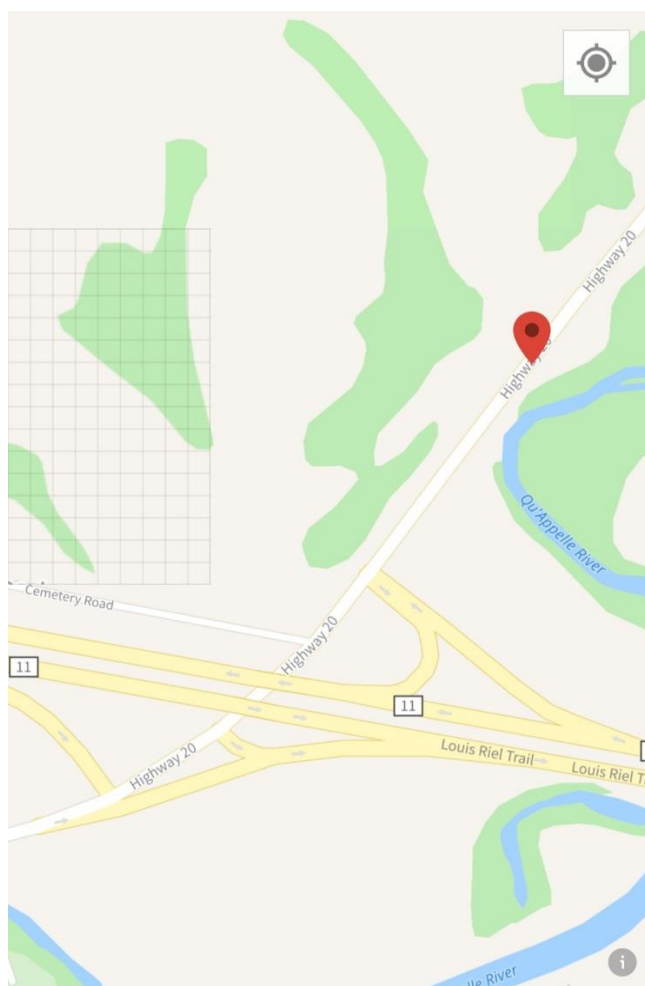
- There will be a \$10.00 fine for dogs loose on the field or on the property on which the trial will be held.
- Dogs will be run once per test.

- Lamé dogs or bitches in season will be excused and their entry refunded, provided notice is given prior to or during roll call.
- Dogs not present at roll call shall be scratched with no refunds. No exceptions.
- Muzzles and catch collars may be used at the handler's discretion. NO FLEXI LEADS, SHOCK COLLARS OR PRONG COLLARS ALLOWED on trial grounds .
- Catch collars must be free of any item that could become entangled in the line. All tags must be removed.
- Come prepared, bring your own shade, water and food. There will be no canteen on
- People are expected to clean up after their dogs. There will be a \$20.00 fine for NOT cleaning up after your dog.
- The field is mowed and will be enclosed by fencing.

DIRECTIONS TO THE FIELD

North from Regina or south from Saskatoon take Hwy 11 to Hwy 20 junction . Turn onto Hwy 20 towards Craven and drive 0.3 kilometers. Look for the WDOC banner on the driveway on west side of Hwy 20.
