A service charge of 5% will be assessed. This includes entries sent online, by fax or post using a credit card or interac for payment.

Entries will not be accepted unless accompanied by payment; forms and fees must be submitted to the Field Trial Secretary prior to the Closing Date. The club will be unable to accept, cancel or alter any entry after the closing date. **Post-dated cheques will not be accepted.** Please make cheques payable to **Eastern Slopes Spaniel Association.** We would encourage all entrants to enter using the [www.dogshow.ca](http://www.dogshow.ca) website. Most of the dog and handler information have been entered into the website but you should check your information. There is no charge to be a part of the website.

**Attention Foreign Exhibitors:** Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian funds. If you send a cheque in U.S. funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds or use the [www.dogshow.ca](http://www.dogshow.ca) website.

**Temporary Competition Number ("TCN"):** The current system of entering events with "listed dogs" is being replaced with TCNs, which will be required

to enter all events with closing dates after March 2, 2020. A TCN must be obtained before submitting an entry and the same TCN must be used for all event entries for a dog until it is permanently registered with either a CKC number or an ERN.

To obtain a TCN:

First check the dog's profile on CKC to determine if CKC has already created a TCN for it. If not:

- 1) Go to the CKC web site, click on forms, under Shows and Trials click Exhibitors. Find the Temporary-Competition-Number-Application Form. Complete the application form on line and the TCN should be issued instantly; **or**
- 2) You may print the application form and submit it to CKC via mail; **or:**
- 3) You may contact Shows and Trials Division by telephone (1-855-364-7252) toll free or email [information@ckc.ca](mailto:information@ckc.ca).

There is no fee to obtain a TCN, however Exhibitors will still be required to pay TCN fees (formerly called listing fees) when entering events using this number. The current TCN fee is \$10.50 per trial. (ie. per dog per day)

**Event Registration Number ("ERN"):** All dogs that are foreign born and foreign owned require an Event Registration Number (ERN) to enable them to be awarded titles by the CKC. A TCN will allow dogs to temporarily participate in CKC events while they pursue permanent registration or an ERN. Application forms may be obtained from the Field Trial Secretary.

**Amateur All-Age Stake:** “An Amateur All-Age Stake at a Spaniel Field Trial shall be for all dogs at least six months of age on the day of the trial at which the stake is judged. A person shall be considered an amateur if he has not attempted to receive any part of his livelihood from the training, handling or showing of field trial or hunting dogs in the calendar year of the trial or the preceding calendar year. Dogs running an Amateur Stake must be owned by an amateur and handled by an amateur.” *CKC Sporting Spaniel Field Trial Rules & Regulations, Chapter 10, Section 6*

**Open All-Age Stake:** “An Open All-Age Stake at a Spaniel Field Trial shall be for all dogs at least six months of age on the day of the trial at which the stake is judged.” *CKC Sporting Spaniel Field Trial Rules & Regulations, Chapter 10, Section 4*

**Puppy Stake:** “A Puppy Stake at a Spaniel Field Trial shall be for dogs at least 6 months of age and under 2 years of age on the day of the trial at which the Puppy Stake is judged.” *CKC Sporting Spaniel Field Trial Rules & Regulations, Chapter 10, Section 2*

**Water Test:** “A Spaniel is primarily a land dog. However, in many parts of the country he is used to retrieve waterfowl, and in an ordinary day’s shoot there are occasions when the only way of gathering shot game is after a swim or from a stream, pond or lake.” *CKC Sporting Spaniel Field Trial Rules & Regulations, Chapter 16, Section 1*

**Points:** Championship Points are awarded for placements in the All-Age Stakes, provided that there are 10 or more starters: 1st Place - 5 Points, 2nd Place - 3 Points, 3rd Place - 2 Points, 4th Place - 1 Point

**National Championship Qualification:** *CKC Sporting Spaniel Field Trial Rules & Regulations, Chapter 12, Section 1.3 (a) & Section 1.4 (a)* state that dogs which place 1st, 2nd, 3rd or 4th in an All Age Stake at a CKC approved trial hosted by a member club in good standing with the Canadian National Spaniel Field Trial Association (“CNSFTA”) will be qualified for the following two (2) National Championship Stakes. ESSA is currently not a member of the CNSFTA, therefore, any placement received will not result in qualification into any National Championship Stakes.

**Indignities:** “It shall be the duty and obligation of the trial-giving club to see that a judge, club official, field trial marshal, volunteer, or competitor at a field trial held under these regulations, is not subject to indignities of any kind. The Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.” *CKC Sporting Spaniel Field Trial Rules & Regulations, Chapter 21, Section 7*

**Field Trial events will be held in conjunction with Hunt Test events. Working tests to be held between the second and third series of the field trial after the puppy stake. There will be a water test held with the field trial.**

**The hunt test water events will be held immediately after the field trial water test. All other hunt test events will start after completion of the third series of the field trial. Schedule may be altered at the discretion of the Field Trial and Hunt Test Committees.**

## **NOTES**

**Please ensure all rabies shots are up to date.**

**No dog may be brought onto the grounds or premises of an event if it:**

- is known to have distemper, parvovirus, kennel cough or other communicable disease;
- has recovered from distemper, parvovirus, kennel cough or other communicable disease within the last 30 days (prior to the event); or
- has been housed within 30 days prior to the event on premises on which there existed distemper, parvovirus, kennel cough or other communicable disease.

ESSA reserves the right to remove a dog from the event premises and the exhibitor may be subject to disciplinary action if it is found that CKC rules have been contravened.

Noncompeting dogs must not be on the grounds (except in the parking area) and should be leashed when not kenneled.

Puppy stakes will be held each day between the 2nd and 3rd series of the Open and Amateur All-Age stakes each day.

In accordance with the CKC Spaniel Field Trial Rules and Regulations an article of **BLAZE ORANGE** clearly visible above the waist, must be worn by all persons in the field. **NO EXCEPTIONS**. Please note that the club has instituted a new rule that both a blaze orange hat & vest must be worn by everyone when they are on the field. This will be strictly enforced by the **Blaze Orange Police**.

Please bring your own lunch and refreshments as no lunches or refreshments will be provided.

**ESSA has a prohibition against smoking anywhere on the property including the parking area, please NO SMOKING.**

The McVinnie Conservation Site is Day Use Only Site. No overnight camping is permitted

Consumption of alcoholic beverages is not permitted on the field trial grounds except in the parking area. **DO NOT LITTER.** Your assistance in keeping the grounds clean will help ensure that we will be allowed to use them another time.

## McVinnie Conservation Lands

ESSA has a prohibition against smoking anywhere on the property including the parking area, please **NO SMOKING**.

McVinnie is crown land and reserved a wildlife conservation area. It is a pheasant release site in the fall and has a stocked trout pond that we will use for a water test or water series. ESSA went to considerable effort to obtain the necessary permission to use this land. We think you will find that these are outstanding lands and ESSA would like to continue to use McVinnie in the future



**Directions:** From Highway #2 at Claresholm, AB take Secondary Highway #520 east for 53 km (Secondary Highway 520 will become Township Road 124 at junction with Highway 23). Turn North off of Township Road 124 onto Range Road 214. Travel North 1.6 kms to entrance into McVinnie Reservoir Conservation Area.

Claresholm is the closest town with a broad selection of accommodation and restaurants and is approximately 55 km from the grounds.
