

Payment of entry fee: Due to the volatility of the current exchange rates, all entries must be paid in Canadian funds. We suggest you purchase a bank draft or money order for entry fee payment. Personally discounted cheques WILL NOT BE HONOURED. DO NOT mark your personal cheque *Payable in Canadian Funds* or *AT PAR* as such items are not readily cleared through the banks.

NOTE:

Only dogs entered in the Trials are allowed on Trial Precincts. The Trial precincts shall consist of all areas in the <u>LARGE HALL</u> set out for rings, all shelters or facilities set aside for officials, judges or exhibitors and handlers, and an area of 30 feet outside of the judging rings.

Non-Member Participation Fee/Droit de participation pour non-membre

The non-member *Participation Fee* applies to dogs wholly owned by a resident of Canada who is not a member of the CKC, it is not applicable to CKC members or dogs co-owned with a CKC member. In order for the title to be awarded, the non-member will have a choice of either becoming a CKC member or paying the Non-Member Participation Fee. Failure to comply within thirty (30) days of notification will result in the title being withheld and the dog cannot be moved up. For a membership application, please go to www.ckc.ca under CKC Services and Form on-line. The Non-Member Participation Fee is fee paid in the calendar year (January—December) in which the dog achieved its title.

Provide your full return address. Faxed requests will be accepted. Please include your VISA/MasterCard number, expiry date, cardholder's name and signature. An ERN must be obtained within 30 day of obtaining points, awards or scores to avoid cancellation. If factors beyond your control prohibit this or present a problem, send a written request for a 30 day extension.

CKC OBEDIENCE RULE 20.7

It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer, or competitor at an Obedience Trial held under CKC Rules is not subject to indignities. The Obedience Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fair on receipt of a report indicating that this has occurred.
