Entry online at [dogshow.ca](http://dogshow.ca) **ONLY**. Paper entries not accepted.

**Day of Trial Entries** will be accepted if space permits and must be submitted prior to the judges briefing. Day of trial entry fees shall be \$40 per component.

**Move Ups** within the same trial are not permitted. Move ups between trials must be done prior to the end of the trial on Saturday, if space and time permits.

**ENTRIES MUST BE PAID IN FULL.** The owner of a dog entered in this trial is entirely responsible for any error in the entering of the dog, regardless of how, or by whom the entry was made.

**REFUNDS:** Fees will not be refunded after closing date for any reason.

**WITHDRAWAL OF ENTRIES:** An exhibitor has the right to withdraw an entry up to the closing date and time as published in the Premium List.

**\*WAIT LIST:** If the trial fills, a waitlist will be maintained. Masters components are limited to 36 runs/components per day. If there is still available space 72 hours before the trial closing date, additional Masters spaces may be opened.

To comply with instructions issued by the CKC, we are unable to accept, cancel or substitute any entry reaching the Show Secretary after the closing date and time.

**ELIGIBILITY:** Purebred, unrecognized or mixed-breed dogs may compete.

**BITCHES IN SEASON:** Bitches in season are eligible to compete. Should a bitch be competing while in season the handler must inform the club prior to the trial date. These entries will run last in each component and must wear clean, properly fitted panties.

**GENERAL INFORMATION**

Indoor benching will **not** be available. Please be prepared to bench from your vehicle. Alternately, shade tents may be set up but may not be left overnight. All dogs must be on leash except during the test (where permitted by the judge).

Indoor and Outdoor components will be offered. Trials will run regardless of sun, wind, rain or snow. Please come prepared.

**Accessibility:** The indoor facility is wheelchair accessible. Outdoor search areas may be in gravel and/or on uneven ground.

This venue may use search areas with hardwood and/or linoleum floors. If your dog struggles with slippery surfaces, trial boots may be used.

This is a community facility used by families. Clean up after yourself and your dog, failure to do so will be immediate expulsion from the event. Canine potty areas will be clearly communicated.

Washrooms will be available intermittently.

NO non-trial odour is permitted on the trial grounds. No warm up area will be offered.

Handlers will be charged for any damage done by their dog to any equipment or items in the search area (including urinating on items, excessive scratching, or subsequent breaking of any item).

Anyone discussing hides before the end of the trial will be excused and asked to leave as per CKC rules.

**\*\*NON-MEMBER PARTICIPATION FEE/TCN Number:** The CKC requires all owners of unregistered recognized breeds entering events to obtain a Temporary Competition Number (TCN). TCNs will allow dogs to temporarily participate in CKC events while they pursue permanent registration or an Event Registration Number (ERN).

**HANDLERS WITH MULTIPLE DOGS:** Handlers with multiple dogs will not be permitted to enter more than one dog in the same class / components.

**“It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Event Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.”**
