FEES: \$55.00 for all categories. Dogs not registered with C.K.C. must pay a listing fee of \$11.30. Cheques payable to: VIZSLA CANADA

A listing fee as established by The Canadian Kennel Club must accompany each entry of a dog for which a Canadian Kennel Club individual registration number, Event Registration Number (ERN), Performance Event Number (PEN) or Miscellaneous Certification Number (MCN) is not shown on the entry form.

Vizsla Canada reserves the right to remove a dog from the running order if entry fees have not been paid in full. Vizsla Canada reserves the right to refuse entries from persons who have failed to pay entry fees in full at prior tests. Fees for entries withdrawn after the closing time will not be refunded.

Entries Close Tuesday, June 11, 2019 at 8:00 P.M. It is the responsibility of the entrant to confirm receipt of their entries.

**DRAW TIME: Tuesday June 11, 2019, 8:30 P.M. AT THE HOME OF THE TEST SECRETARY.** The draw will be random and specific times cannot be assigned to any entrants. Entries will be limited to the number of dogs which Vizsla Canada reasonably determines in its sole discretion may be run during the hours of judging. **Entries may close prior to 8:00 P.M. Tuesday, June 11, 2019** if the Test Secretary determines the tests are full.

Blaze orange MUST be worn in the form of a hat and a vest during all test categories: FDXCh, FDX, FDA, FD and FDJ. This includes gunners, handlers, judges, apprentice judges and volunteers. NO EXCEPTIONS!!! Gunning will be done by official gunners only.

COURSES AND GAME: Chukar will be used in all categories, including the FDX water retrieve.

FDXCh, FDX, FDA, FD and FDJ will be a single course with a bird field. FD and FDJ dogs will be run individually. FDXCh, FDX and FDA dogs will be run in braces or individually where applicable with a bye-dog for backing. All handlers must carry a starter's pistol.

### OTHER RULES:

- \* No dogs will be allowed to exercise or be trained on the test grounds
- \* Bitches in season will be allowed to run at the end of the test at the discretion of the Field Chair and Test Secretary, only if there are gunners and bye-dogs available to accommodate, where applicable.
- \* Current record of vaccination may be required.
- \* Test scores will be available from the Test Secretary after the completion of each test category
- \* Move-ups require a written request at least 30 minutes prior to the test

NOTE: If you have twice qualified your dog with any of our Judges, please notify the Test Secretary before the drawing time.

### **SPECIAL NOTE:**

It shall be the duty and obligation of the test-giving club to see that a judge, club official, volunteer or competitor at a Field Dog Test is not subject to indignities. The Field Test Committee Chairman shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

**PRIZES:** Standard C.K.C. Blue Ribbon to all dogs obtaining a qualifying score.

**MEALS:** Lunch and light refreshments will be available both days for a nominal fee.

### CKC NON-MEMBER PARTICIPATION FEE

A non-member participation fee will be charged to a resident of Canada who is a non-member of the CKC. The fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by the individual.

In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved to the next level.

# Directions to the Test Site 535 Concession 1 Road South

### From points east:

Take Hwy 403/QEW. Bear left onto the QEW.

Take exit 88, Centennial Parkway/Hwy 20. Keep right onto Centennial Pkwy South/Hwy 20.

Continue on Hwy 20 and continue as its name changes to Regional Road 56.

Take 56 thru Binbrook and Empire Corners.

Cross Hwy 3.

Take your next right onto Concession 1 Road South.

Ruffwood Game Farm is on your right. #535

### From points west:

Take Hwy 403 East toward Hamilton.

Take exit 41, Garden Ave. Keep right onto Garden Ave. South towards Cainsville.

Name changes to County Road 18.

Turn left onto County Road 54 towards Cayuga.

In Cayuga, turn left onto Hwy 3 then almost immediately right onto Regional Road 17/Thorburn St.

Turn left onto Concession 1 Road South.

Ruffwood Game Farm is on your left. #535

Take Hwy 6 south towards Hamilton.

Take Hwy 403 West towards Brantford.

Take exit 61, Hwy 6/Garner Road, south towards Caledonia.
