GENERAL INFORMATION AND TEST RULES

ELIGIBILITY: Purebred or mixed-breed dogs must be at least 12 months of age that:

- (a) Are individually registered with the CKC (have a CKC registration number),
- (b) Have an Event Registration Number (ERN),
- (c) Have a Performance Event Number (PEN),
- (d) Eligible for registration with the CKC ,and have a Temporary Competition Number (TCN)
- (e) Have a Miscellaneous Certificate Number (MCN) if it belongs to a CKC listed breed
- (f) Have a Canine Companion number (CCN) if it is a mixed-breed

Levels Offered: INSTINCT & NOVICE

COMPONENTS (NOVICE): CONTAINERS, INTERIOR, EXTERIOR

Note: 2 components may be run back to back

ODOURS: INSTINCT & NOVICE - WINTERGREEN

ENTRY FEE: INSTINCT - \$20

NOVICE - \$30 per component

RIBBONS & AWARDS: Rosettes awarded for Novice Titles

SITE INFO

- There is no shade for vehicles.

NON-MEMBER PARTICIPATION FEE: The CKC has a tracking fee for non- members. Please refer to the information about this policy on the CKC website: https://www.ckc.ca/en/Files/Forms/Shows-Trials/Exhibitors/Non-Member-Participation- Fee-Form-Form-No-150-00-5

If a dog is not registered individually in the records of the CKC, it may be entered at a trial held under these rules with a Temporary Competition Number (TCN), providing that the number is obtained before the closing date of entries. Once the dog is permanently registered or has an ERN, the TCN will no longer be valid. While there is no fee for the Temporary Competition Number, exhibitors will still be required to pay listing fees (\$10) when entering events. The request for a TCN will be self-serve; exhibitors should go to the CKC website to complete an online application and a TCN will be issued instantly. Exhibitors may also obtain a TCN by completing a printed application and submitting it to the CKC, or by contacting the Shows and Trials Division by telephone.

BITCHES IN SEASON: Bitches in season shall not be eligible to enter the test.

BORDER CROSSING: A valid rabies certificate is required to bring a dog into Canada and it must be dated at least 30 days prior to entry into Canada.

REGULATIONS: It is the responsibility of the exhibitor to be familiar with the rules pertaining to the event in which they are competing. Copies of the CKC Scent Detection Rules & Regulations are available from the Canadian Kennel Club. Tel: 1-800-250-8040.

CKC REGULATION: It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

Attention Foreign Exhibitors

Please note that fees are due and payable in Canadian dollars. Due to constantly fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian funds. If you send a cheque in U.S. funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor.

Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks.

To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and co-operation is appreciated. Thank you
