From Windsor: Follow ON-3 E, turn right onto Erie Street N in Leamington. Turn right onto Oak Street. Turn left onto Sherk Street and continue to Nature Fresh Farms Recreation Centre.

All dogs must enter from the north side entrance and are only permitted in the gymnasium. Crates and chairs may be left in the building overnight at your own risk.
