Emergency Veterinary Service

We currently have a rotation of veterinarians covering out of hours emergency care. Should you require emergency care please call 709-368-3728 and follow the prompts to be put in touch with the clinic on call.

We will be ordering lunch from Lorina's on Saturday, and pizza on Sunday! Information on ordering lunch will be sent to exhibitors at a later date.

There will be no refunds for withdrawn entries after the closing date except in the case of a female in season. When a female comes into season after entries have closed, she may be withdrawn from the trial and refunded provided the Trial Secretary receives, on or before the date of the trial, a veterinarian's certificate declaring that the female was in season within the 10-day period preceding the trial.

A water hose and a small wading pool will be available on site. This trial will use manual timing. The Wall Jump and Broad Jump will not be used. The ring will be 100'x100' on grass, using metal fencing & gates. Dogs must be kept on a leash at all times when not in the ring. The use of flexi leashes, choke collars, prong collars, and electronic collars is strictly prohibited anywhere on the trial site, including the parking lot.

It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities. The Agility Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

No person may approach a judge either directly or otherwise, orally, in writing or electronically, to favour his entry. Disciplinary action will be taken against any person who violates this rule, or against a judge who fails to report any contravention of this rule to the CKC within 14 days of the action.

Flat ribbons will be awarded for all Qualifying Scores and Placements, and rosettes will be awarded for all New Titles.
