TEST COMPLAINTS COMMITTEE

It shall be the duty and obligation of the event-giving club to see that a judge, club official, volunteer or competitor at a Field Dog Test is not subject to indignities. The Field Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue. (19.7)

The Field Test Committee shall promptly forward the complaint, the deposit and a record of the hearing of the hearing together with its recommendation on the disposition of the complaint to the CKC. Copies of the record of hearing and the Committee's recommendation will be forwarded to the parties concerned at the same time. (18.7)

A judge officiating at any test under these rules shall not be subjected to indignities of any kind. It shall be the duty and obligation of the club holding the test to see that this rule is effectively carried out. (3.7.1)

REFUND POLICY

If, due to COVID, these Tests are not able to be held; refunds will be issued to exhibitors - MINUS 20%. While all efforts will be taken to expedite refunds, they may take up to 14 days (depending on volume & other work commitments).

If because of; an act of God, riot, civil disturbance, extreme weather event, governmental orders, regulations, or decree, or other acts or circumstances beyond the control of Vizsla Canada, it is impossible to open or complete the Events, no refund of entry fees will be made.

There will be no refunds once the Tests are closed, either by date, or number of entries.

NOTE: If you have twice qualified your dog with any of our Judges, please notify the Test Secretary BEFORE the drawing time.

Attention Foreign exhibitors: Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted; however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated. Thank you

The **Non-Member Participation Fee** applies to dogs wholly owned by a resident of Canada who is not a member of the CKC; it is not applicable to CKC members or dogs co-owned with a CKC member. In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the Non-Member Participation Fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level. (For a Membership application, please go to www.ckc.ca under CKC Services and Forms On-Line.) The Non-Member Participation Fee is fee paid in the calendar year (January – December) in which the dog achieved its title and/or titles.

Temporary Competition Number (TCN) - * Effective March 2, 2020

A Temporary Competition Number (TCN) must be obtained before submitting an entry for an event. The same TCN must be used for all event entries for a dog until the dog is permanently registered. Once a dog is permanently registered or has an ERN, the TCN will be replaced with the registration number or ERN. A TCN cannot be used for Listed Breeds (MCN) or dogs that will require a Performance Event Number (PEN) or Canine Companion Number (CCN).

There is no fee to obtain a TCN however exhibitors will still be required to pay TCN Fees (formerly called Listing Fees) when entering events using a TCN.

TCN Numbers may be obtained online via the CKC website where the number is issued instantly. Exhibitors may also mail in a printed application or contact CKC Shows and Trials by phone for a number.

Event Registration Number (ERN#): Effective January 1, 1992

All dogs that are foreign-born and foreign-owned and enter Canada for the sole purpose of entering CKC events will no longer require a CKC Registration number but will require an Event Registration Number (ERN#) The ERN# MUST be applied for within 30 days of the first day of entering a CKC EVENT. Judging will begin with WDJ followed by WD and WDX.

Start Time: To be determined once entries close. All entrants will be provided with a running order and will be responsible for determining an appropriate time to arrive at the test site for their event. The first two entrants of the day will be notified by phone or email.

- **Total entries** will be limited to the **number of dogs** which Vizsla Canada Inc. reasonably determines, in its sole discretion, may be run during the hours of judging.
- Entries may close prior to 6:00 p.m. Monday, September 5th, if full
- Entries withdrawn after closing must still pay the appropriate fees, failure to do so, will be considered **"outstanding"** payment
- Running order draw will take place at the home of the Test Secretary and will be published after drawing
- The order & time of tests will be determined once entries close
- The drawing will be "random", and specific times cannot be assigned
- It is the responsibility of entrants to confirm receipt of their entries
- **Day of Test entries WILL be permitted**, provided the entry limit has not been reached, and must be brought to the Event Secretary up to a minimum of thirty minutes prior to the start of the Test. Once the limit of dogs has been reached, no more will be accepted. **Please bring your dog's CKC registration information** with you to avoid a listing fee.
- **INCOMPLETE ENTRY FORMS WILL NOT BE ACCEPTED.**

TEST INFORMATION:

Birds and Course: Birds will be Ducks. Course length will be according to Test level. Handler circle 6ft. radius (12 ft diameter) 3ft. from edge of handler's circle to water edge.

Note that running times are an estimate only, and may be affected by absentees, dogs "picked up". It is the handler's responsibility to be at the start of the course when it is their turn to run.

Bitches in season: will be permitted to run in the last test at the end of the day. Bitches in Season will be kept confined away from any other dogs and away from test fields. Bitches in season will be identified in the running order.

Training or Exercising: of dogs is prohibited on the test grounds before, during, or after the Test without the permission of the Event Secretary.

Collaring at WDJ level: dog may be restrained by handler holding the collar or leash

Gallery: Spectators will be permitted to watch the Tests, from a distance determined by the Judges.

Test Scores: will be available from the Test Secretary after the completion of each test category.

Moving up: eligible dogs may move up to the next level, provided they inform the Event Secretary one hour prior to the commencement of the test.

Prizes: Standard CKC qualifying ribbons will be awarded to all qualifying dogs. All ribbons are to be claimed at the Test – no ribbons will be mailed.

Vizsla Canada Inc. reserves the right to remove a dog from the running order if entry fees have not been paid in full. Vizsla Canada Inc. reserves the right to refuse entries from persons who have failed to pay entry fees in full at prior tests. Fees for entries withdrawn after the closing time will not be refunded.

All entries for these Water Tests are accepted on condition that Vizsla Canada Inc., its officials and members, and landowners, are released from all liabilities for loss, damage or injury sustained by dog, or person in conjunction with, or during the running of, these Tests. All minors shall be under the direct care and supervision of the parent or guardian.

WAIVER: All attendees, volunteers and participants are required to sign a Release, Consent and Indemnity for Water Tests Waiver before being allowed to participate in or view the test (page 5).

Use of Live Game and Livestock:

The Canadian Kennel Club (CKC) supports and encourages the sport of dogs to hold various types of shows and trials. We encourage all dog owners to participate with their dogs in such activities as hunting and field trials, herding, tracking and competitive events intended to improve the overall understanding and quality of purebred dogs. It is indeed through the sport of dogs that reputable dog breeders continue to improve their individual breeds as well as the species itself, for all.

Clubs and those persons taking part in these activities must make every effort to ensure the safety of dogs, as well as live game and livestock, used in these activities. Any person non compliant in the safety of animals, including livestock and game, may be subject to charges of cruelty and those who have been convicted of cruelty to animals are ineligible for membership in the CKC.

All participants must be familiar with CKC Rules and Regulations and also the rules, conditions and provisions of this Premium List. CKC Water Test Rules are available from the CKC.
