The trial will be run in accordance with CARO rules and regulations

There shall be no refunds for entries withdrawn after the closing date, or in the event a dog and/or handler are dismissed from competition, regardless or the reason for such dismissal.

Refunds will be issued for dogs that come into heat or are injured, provided a veterinarian's certificate is received by the Trial Secretary.

Physically challenged handlers are encouraged to participate. Handlers shall provide the judge with a written description of how they intend to perform any of the course exercises.

Dogs can be shown on a flat buckle or snap collar or plain harness. No choke, martingale, pinch, electronic collars, head halters or no-pull harnesses are allowed. Leashes should be made of fabric or leather and be long enough to provide adequate slack. Dogs at the advanced or excellent level are not required to compete with a collar.

**All exhibitors must pick up after their dog.** Waste receptacles & bags will be provided. Dogs must be exercised in the grassed area on the east side of the building ONLY. No dogs shall be allowed to urinate on anything at the front of the building.

Trial precincts shall be The Wascana Dog Obedience Club training building (513 East Ross Ave, Regina, Sask), parking lot and surrounding area.

Dogs must be on leash at all times when not in the ring.
