General Information

"It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Event Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred".

Event Plan

You will be assigned a time slot. In that time slot you will complete all your components with the exception of Instinct where there is only 1 component. There will be a limited number of people onsite to comply with provincial COVID rules. We will monitor where you are travelling from to ensure compliance travel/vaccine restrictions. (if applicable at the time of the trial.)

Eligibility to Compete

To be eligible to compete in these trials, the dog must be 6 months of age and registered or be eligible for registration with the CKC, have an ERN, PEN, CCN, Eligible for registration with the CKC, or a CKC Miscellaneous Certificate number (MCN) if it belongs to a CKC listed breed.

*See below for TCN numbers.

A dog may be spayed, neutered or debarked. Dogs must not be lame or must not compete if tape or bandages may impair its working ability. Dogs with physical challenges are eligible to compete, if in the opinion of the judge, they display no signs of physical discomfort and can safely complete the search.

Bitches in season

Bitches in season are not permitted to compete under CKC Rules. We will refund all entry and listing fees if a bitch comes into season after closing date, upon presentation of a veterinarian's certificate, certifying the bitch was in season within the 10-day period preceding the trials. This certificate must be delivered to or reach the Trial Secretary before the trial commences.

Scent Detection Levels offered

Instinct, Novice, Open, Excellent and Masters (Containers, Interior and Exterior). Limited class entries. Exhibitors CANNOT compete in the same component at the same level with multiple dogs.

NO move ups will be permitted on the day of the trial.

NOTE: Instinct is an entry on its own or can be combined with Novice only. It cannot be combined with Open, Excellent or Masters levels.

Scent Detection Prize List

Flat ribbons will be given for all qualifying scores.

New title rosettes will be available.

A judge's choice award will be offered for Portuguese Water Dogs for each level.

Penalties issued by club

Destruction of trial property (excessive scratching or subsequent breaking of an item) will have a monetary penalty of \$10.00 enforced.

Entry fees

All fees must be paid in Canadian Funds. HST included.

Entry fee for Instinct \$25.00

Entry fee per dog per single component \$35.00

Listing fee per entry per trial if not CKC reg'd \$11.30

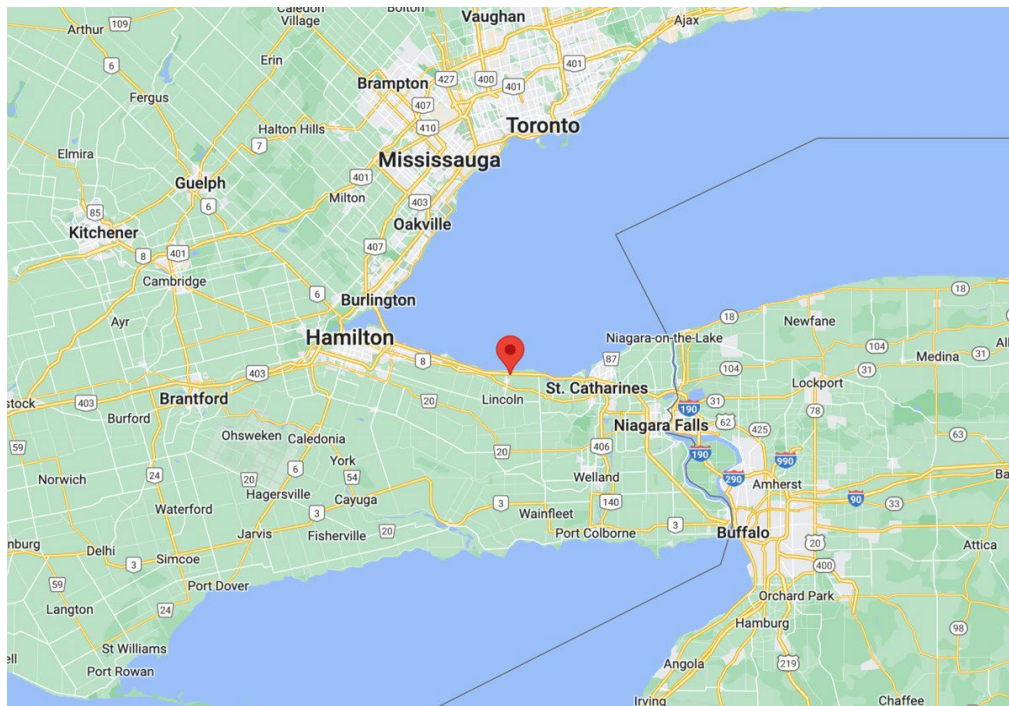

4. Please clean up your dog's waste. Garbage cans will be available at the front door of the school
5. Please clean up after yourself.
6. No smoking anywhere on the trial site
7. Please do your best to keep barking to a minimum
8. Be kind to our judge(s) and volunteers. Remember, if you want to be treated with respect, give others the same respect.
