PLEASE NOTE: All fees must accompany your entries. No entries will be accepted without accompanying full payment. Tendering of an N.S.F. cheque shall be considered an offence punishable by disciplinary action and cancellation of awards by the Canadian Kennel Club. There will be a \$25.00 fee charged for any N.S.F. funds issued to the Alberta Competition Dog Club (Post-dated cheques will NOT be accepted). Overpayment of entry fees will be gratefully accepted as a donation to our trophy fund.

ATTENTION FOREIGN EXHIBITORS: Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted; however, they are to be payable in Canadian funds. If you send a cheque in U.S. funds it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par" as they will not be cleared by the banks. Obedience Class Outlines

PRE-NOVICE - The Pre-Novice class is an elective class and earning the title is not a requirement to enter Novice classes. The Pre-Novice class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has not earned the title of P.C.D. Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class. The same handler must handle each dog in all 5 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the group exercise. Only dogs that have not earned the title of CD may enter the Pre-Novice class.

NOVICE A - The Novice A class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has not earned the title of CD. Only one dog per handler is allowed in this class, and that person must handle the dog in all exercises. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families. No person who has trained or exhibited a dog that earned a CDX title shall be allowed to handle a dog in this class.

NOVICE B - The Novice B class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has not earned the title of CD. Dogs in this class may be handled by the owner or any other person. The owner or any other person may handle a dog in this class. A person may enter more than one dog in this class. The same handler must handle each dog in all 6 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the group exercises.

NOVICE C - The Novice C class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned the title CD. or any higher obedience titles. Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class. The same handler must handle each dog in all 6 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the group exercises. Dogs may compete in Novice C indefinitely. Scores earned by dogs in the Novice C class are not eligible for High in Trial and do not qualify a dog for any title. Dogs may be entered in the Novice C class in addition to any other official or unofficial classes for which they are eligible.

OPEN HA - The Open HA class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of CD but has not earned the title of CDX. The handler of any dog in this class must be the owner, co-owner or member of their immediate families. Only one dog per handler is allowed in this class, and that person must handle the dog in all exercises. Any person who has trained or exhibited a dog that has earned a UD title may not handle a dog in this class.

OPEN 18A -The requirements are the same as Open HA and the same rules except the Long Sit is replaced with Change of Positions exercise and the Long Down is replaced with a Group Sit-Walk around.

OPEN HB - The Open HB class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of CD. Dogs which have earned the title of CDX or any higher titles may enter in the Open B class. A dog may also be entered in the Utility Class in the same trial. Dogs in this class may be handled by the owner or any other person. A person may enter or handle more than one dog in this class. The same handler must handle each dog in all 7 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the group exercises. Prior to the start of judging, the judge will choose which of the six numbered routines is to be performed. This choice will not be disclosed to the exhibitors until it is posted at ring side at least 30 minutes before the start of the class. In future assignments, judges are required to alternate the six routines so that each set will be used approximately the same number of times.

OPEN 18B – The requirements are the same as Open HB and the same rules except the addition of the new Change of Positions Exercises and Long Down is replaced with a Group Sit-Walk around.

UTILITY A - The Utility A class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of CDX but has not earned the title of UD. Any person who has trained or exhibited a dog that has earned a MOTCh title may not handle dogs in this class. The handler of any dog in this class must be the owner or member of their immediate families. Owners may enter more than one dog in this class. The same person must handle the dog in all exercises.

UTILITY B - The Utility B class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of CDX or UD. Dogs in this class may be handled by the owner or any other person. Owners may enter more than one dog in this class. The same person must handle the dog in all exercises. Prior to the start of judging, the judge will choose which of the six numbered routines will be performed. This choice will not be disclosed to exhibitors until it is posted at ring side at least 30 minutes before the start of the class. In future assignments, judges are required to alternate the six routines so that each will be used approximately the same number of times.

EXHIBITION ONLY - This is an official class. A dog may be entered for Exhibition Only, which is an official class that must be specified on the entry form. All dogs entered in this class shall be listed in the catalogue with the same particulars as for a dog entered for competition. No dog so entered can compete in any regular class; however, it may be entered in and compete in any unofficial class or parade offered at the trial on payment of the prescribed fees. If applicable, a listing fee is required. However, a listing fee is not required for a listed dog entered in Exhibition Only (not entered for any competition)

Rally Obedience Class Outlines

NOTE: The Dimensions of the Rally Ring will be 40 x 55 feet

Rally Novice A - Dogs competing in this class may not have earned the RN title or any CKC obedience title other than PCD. No handler who has exhibited a dog through its CKC CDX title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families. A person may enter more than one dog in this class.

No dog may be entered in both Rally Novice A and Rally Novice B at any one trial. 9.2

Rally Novice B - Any dog may compete in this class until a qualifying score in the Rally Advanced class is earned. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

Rally Intermediate - the Rally Intermediate class is an elective class for exhibitors and earning the title is not a requirement for a dog to enter Rally Advanced classes. This class shall be for dogs that have earned the RN title. A dog completing the RI or any other obedience or rally titles may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. Dogs may be entered in this class as a regular entry or changed to it from another official class within the same trial. The request to change must be made on the appropriate CKC form and be submitted to the trial secretary at least thirty (30) minutes before the start of the trial.

Rally Advanced A - This class shall be for dogs that have earned the RN title but have not earned the RA title or any CKC obedience title other than PCD. No handler who has exhibited a dog through its CKC CDX title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families. A person may enter more than one dog in this class.

No dog may be entered in both Rally Advanced A and Rally Advanced B at any one trial.

Rally Advanced B - This class will be for dogs that have earned the RN title. A dog completing the RA title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

Rally Excellent A This class shall be for dogs that have earned the RA title, but have not earned the RE title or any

CKC obedience title other than PCD. No handler who has exhibited a dog through its CKC CDX title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families. A person may enter more than one dog in this class.

No dog may be entered in both Rally Excellent A and Rally Excellent B at any one trial.

Rally Excellent B - This class will be for dogs that have earned the RA title. A dog completing the RE title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

Rally Master - This class will be for dogs that have earned the RE title. A dog completing the RM title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

Obedience Trial Rules

- 6.5.2 When a bitch comes into season after entries have closed, the trial giving club must refund the entry fee and listing fee providing the trial secretary receives, on or before the date of the trial, a veterinarian's certificate declaring that the bitch was in season within the 10-day period preceding the trial.
- 6.7.6 A dog that bites or attempts to bite another dog or a person outside the ring may be removed from the trial by the Trial Committee Chair.
- 20.7 It shall be the duty and obligation of the trial giving club to see that a judge, club official, ring steward, volunteer, or competitor at an Obedience Trial held under these regulations, is not subject to indignities of any kind. The Obedience Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it seems fit on receipt of a report indicating that this has occurred.
- 1. The Obedience Trial Chairperson is in complete charge of the trial
- 2. No dog will be allowed in the building or on the grounds unless entered in the trials.
- 3. No dog is to be let off leash at any time on or near the grounds of the trial except in the obedience ring. Violations of this rule can result in dismissal from competition. No refund shall be made.
- 4. Exhibitor must wear the correct armband while in the ring.

GENERAL INSTRUCTIONS

- 1. ***NO OUTDOOR SHOES TO BE WORN IN THE FACILITY. PLEASE BRING A CHANGE OF SHOES. MUDDY OR WET FOOTWEAR TO BE LEFT AT THE DOOR.*** Bring inside shoes.
- 2. No dog will be allowed to compete unless entry fees have been paid in full.
- **3.** Refunds will not be made after the closing date for dogs that do not compete under section 6.5.2 of the Obedience Trial Rules and Regulations.
- **4.** The Trial Committee has the right to refuse any entry subject to CKC rules.
- **5.** The Club will use due care and diligence for the welfare of the dogs and exhibitors, but will not be responsible for, or assume any liability in the event of an accident or other misfortune, either to dogs, exhibitors or patrons.
- 6 . A judge officiating at the trial under Obedience Trial Regulations and Standards shall not be subject to any indignities of any kind during the progress of the trial. It shall be the duty of the club holding the show to see that this rule is effectively carried out. The Trial Chairman shall promptly report to the CKC any infringement of the rule. The Board of Directors shall have the power to take action as it deems fit on the receipt of a report indicating this rule has been violated.

CKC RULE 4.6.1 – INDIGNITIES TO A JUDGE

A judge officiating at a show held under these rules shall not be subjected to indignities of any kind during the progress of the show. It shall be the duty and obligation of the club holding the show to see that this rule is effectively carried out. Further, this rule also includes a club official, volunteer, or any participant at our events.

- 6. If because of a riot, civil disturbance, or other acts beyond the control of the trial giving club, it is impossible to open or to complete the trials, no refund of entries will be made.
- 7. Fees must accompany your entries, Etransfer, money order or cheque. Tendering a NSF cheque shall be considered an offense punishable by disciplinary action and cancellation of awards by the Canadian Kennel Club. There will be a \$ 25.00 fee charged for any NSF cheque issued. No post-dated cheques will be accepted. Over payments will be donated to the club trophy fund.

Please be responsible for your dog always. For the safety of all dogs and exhibitors we ask that you keep a diligent eye on your dog always. Outside the ring we ask that you keep your dog in a crate or on a short leash and under control.

FAILURE TO PICK UP AFTER YOUR DOG OR ALLOWING IT TO URINATE ON THE TRIAL PRECINCTS OUTSIDE OF THE DESIGNATED AREA, INCLUDING THE BUILDING, STEPS, RAILS, ETC. WILL RESULT IN DISMISSAL FROM THE TRIALS
