### JUDGING SCHEDULE

***If any exhibitor entered in both obedience and rally foresees a potential conflict, you must check with the Chief Ring Steward to get the matter resolved.***

**Benching:** There is no charge for benching. Exhibitors may set up at 4 p.m. on Friday, April 21/23. No dogs can be left in the building overnight. You are responsible for cleaning up after your dog and your benching area.

There will be **no concession** at the arena. Exhibitors can bring their lunch. **There are limited food services in Picture Butte.**

### DAY OF TRIAL ENTRIES

**Obedience Trial #2 or #4 only - \$40.00 per class**

**NO 'Day of Trial' entries will be allowed any Rally Trials nor Obedience Trial #1 and #3. These trials are full!**

#### **Run-Offs and tie scores** (CKC obedience trial rules 8.9)

8.9.1 In case of a tie, the dogs shall be re-tested again by having them perform individually, all or the same part of one or more of the

regular exercises. In the case of a tie in Utility, the dogs shall be tested again by performing individually all or the same part of the

signal exercise. The original scores shall not be changed.

8.9.2 In the case of a tie the judge shall inform the exhibitors involved and allow a reasonable warm up period.

8.9.3 In case of a tie for High in Trial, the dogs shall be tested by performing the Heel Free exercise individually.

8.9.4 The officiating judge of a trial must judge any run-off for High in Trial. In the event of two or more judges officiating at a single trial,

the club shall designate in the premium list which judge will judge any run-off for HIT. Each Judge is responsible for breaking ties in the

classes that they judge.
