Notice to handlers attending FPO&TC obedience trials

September 26th – 28th 2025

There appears to be a nasty contagious respiratory disease in some dogs on Vancouver Island. It apparently starts with hacking and coughing and may progress to pneumonia and bronchitis and more serious illness.

If your dog exhibits **any** signs of **any** respiratory disease or has been in contact with any other animal exhibiting such signs, **PLEASE DO NOT ATTEND THE TRIALS.**

CKC rule 6.6 HEALTH. This is also on page 9 of the Premium List.

6.6.2 Dogs entered in trial must have current immunization status

6.6.3 No dog may be brought onto the grounds or premises of a trial if it:

- a) is known to have distemper, parvovirus, kennel cough or other communicable disease; or
- b) has recovered from distemper, parvovirus or other communicable disease within the last 30 days
- c) has been housed within 30 days prior to the show, trial or test on premises on which there existed distemper, parvovirus, kennel cough or other communicable disease.

Also, it is the season for human influenza, Covid-19 and other respiratory conditions.

If you are sick, please stay home.

*** The club will have masks available at the trials!!***
