Head west on 22nd Street and onto Hwy 14. Turn left (south) at the Sandyridge Gas Station onto Young Road. Go 1 mile to the stop sign, turn right (west) onto the paved road. Go about 1 mile; Sheep Thrills is the last place on the right hand side just before the train tracks. **Non-Member Participation Fee:** An annual non-member participation fee for awards and titles will be charge to a Canadian non-member of the CKC. In order to protect the awards/titles earned, the non-member will have a choice to either become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.

A copy of this regulation shall be prominently placed in every premium list and catalogue.
