**Judges:** Fiona McComb (Rounds 1 & 2 all levels) and Andy Carr (Rounds 3 & 4 all levels)

Fees: \$18 single entry \$65 package (4 entries for the same dog) \$13 FEO (For Entertainment Only) \$ 20 Day/Gate entries and after pre-entry deadline Entries open February 6, 2017

Pre-entry deadline: March 6, 6:00 PM

A valid entry includes the completed entry form and signed waiver with payment.

Entries are limited to 1 dog per handler per level (4 rounds available) or 2 dogs per handler per level, max 2 rounds per dog (1&2 or 3&4).

Female dogs in season may not compete. This trial is open to reactive dogs EXCEPT those dogs that are currently deemed as dangerous, vicious or aggressive by any municipality, city or province. Please note that this does not include dogs that are deemed under breed specific legislation only and do not have a bite history.

Entries will be limited to 360 minutes of judging per judge. Gate entries will only be accepted if the trial has not filled.

Move ups will be allowed from rounds 1 & 2 to rounds 3 & 4 only.

Entries must be received by the pre-entry deadline to receive the reduced rate.

**Schedule:** Rounds 1 & 2 and rounds 3 & 4 will run concurrently with staggered start times. All rounds will start with Level 1.

Rounds 3 & 4 Level 1 will begin after Rounds 1 & 2 Level 1 are completed. The exact times will be sent out prior to the trial once the number of entries at each level is known.
