## HONOURABLE JUDGES:



**John Burgess** - John obtained his first show dog, a Pembroke Welsh Corgi in 1973 and has been involved with the breed ever since. Under the Breconmohr prefix they have bred and owned numerous champions and BIS winners. John started judging in 1980 and obtained his All Breeds licence in 1996. He has judged in all States of Australia, New Zealand, Philippines, South Africa, United Kingdom and USA. He has also judged Pembroke Corgis at Championship level at a Specialty show in the United Kingdom and apart from All Breed appointments in the USA, he has judged four Pembroke Welsh Corgi Specialties to date.



**Murray Clark** - Murray has been involved in the sport of purebred dogs since the age of 10. As a family effort he and his parents bred Miniature Schnauzers under the 'Massawippi' prefix (Reg'd 1977). Murray developed the art of breeding, training, trimming, and showing this challenging member of the Terrier group. A natural progression, as a young professional handler, Murray also achieved great success and invaluable education piloting numerous breeds to top ranked status in Canada. Murray later attained a professional designation and is a founding partner at Batryn and Clark Chartered Accountants. He is an avid tennis fan and maintains a high fitness level by playing and mentoring within the sport. Murray continues to enjoy exhibiting new generations of best in show and specialty winners as a successful

breeder owner handler at major events in North America. He is excited to commence judging and to give back to his lifelong passion within the purebred dog world!



**Todd Foley** - Todd grew up in a dog show family. His parents bred Boxers since he can remember. At six years old he received his first show-dog, a whippet "Jet", who ended up winning multiple Best In shows. He competed in Junior Handling throughout his childhood and went on to be the Nova Scotia Junior Handling representative for the CKC. He has bred and shown dogs that have been successful at many levels throughout North America including a Westminster KC breed- winning Beagle, "Lil Ed". He also bred Standard Poodles, Kerry Blue Terriers, Salukis and Shetland Sheepdogs. Todd owner-handled the top winning Sheltie in Canadian History, Olivia – Am/Can Ch. Shelhaven Sweet Seduction, to 41 Best In Shows and the Canadian record setting Pug, "Adam" Am/Can Ch. Diamond Sand's Simply Perfect, to 31 Best In Shows. Todd has travelled all

over the World to prestigious dog shows such as Westminster, Crufts and the World Dog Shows. He has since turned his focus to judging and is now judging the Herding and Working Groups and now on permit for Hounds.



**Margaret Jones** - I am a retired Health Care Administrator who has been showing and training dogs since 1965, when I obtained my first Irish setter. Since then I have shared my home with Irish Setters, Cairn Terriers, Boxers and a number of different breeds including, Doberman Pinschers, a Great Dane, Afghan Hound and a Tibetan Mastiff. As a small breeding kennel we raised and bred Irish Setters, Boxers and Cairn Terriers under the Kian Prefix and exhibited them to Group, Specialty and Best in Show wins. We gained top Dog Awards and many Obedience titles with our Irish Setters and Boxers. Cairn terriers do not excel in the Obedience ring but they love to work at Rally, Scent detection and Earth sports.

As an All breed Judge I have been privileged to judge many times at All Breed and Specialty shows in Asia, Australia, Europe, South Africa, South America, U.K., Canada and USA.



**Wendy Maisey** - Wendy has been showing/breeding since 1972. She has bred, owned and exhibited Doberman Pinscher, Miniature Pinscher and Cavalier King Charles Spaniel under the kennel name Dawnaquinn. She has been judging since 1998. In addition to Canada, she has judged in the US.

Obedience competitors for their wonderful dogs and the determination and generosity of the trial hosting clubs. I continue to strive to improve my skills both as a competitor and judge and look forward to many more years in the Obedience and Rally rings.

### 2. ENTER Online



A service charge of 10% will be assessed. This includes entries sent online or post using a credit card or interac for payment.

ALL Entries **MUST** be received by closing date: **WEDNESDAY, APRIL 23<sup>rd</sup>, 2025 @ 9:00pm Pacific Time**

The tendering of NSF cheque shall be considered non-payment of entry fees and is punishable by disciplinary action and cancellation of awards. A collection fee of \$25.00 will be added to the amount of any returned cheque. Exhibitors whose charges are declined by the Bank Card Authorization Department will be assessed a service charge of \$25.00 for each transaction declined. Telephone entries are not accepted by the Show Secretary. Incomplete entries or entries received without fees, or entries received after the advertised closing date will not be accepted.

Attention foreign exhibitors, please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian Funds. If you sent a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please DO NOT make cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian Funds.

## **CONFORMATION CLASSES**

The following Regular CKC Classes (divided by sex) will be offered:

**JUNIOR PUPPY CLASS** - This class shall be for any dog 6 months of age and under 9 months of age on the day of the show

**SENIOR PUPPY CLASS** - This class shall be for any dog 9 months of age and under 12 months of age on the day of the show

**12 to 18 MONTH CLASS** - This class shall be for any dog 12 months but under 18 months of age on the day of the show

**CANADIAN BRED CLASS** - This class shall be for any dog born in Canada.  
(Champions of any country excluded)

**BRED BY EXHIBITOR CLASS** - This class shall be for any dog owned and handled in the ring by owner/breeder. The handler **MUST** be the owner/co- owner **AND** breeder/co-breeder of the dog. The owner/breeder must handle the dog at the class level, but need not handle the dog for further awards

**OPEN CLASS** - This class shall be for all dogs

**SPECIALS ONLY CLASS** - This class shall be for any dog that has a recorded CKC Registration or Event Registration Number and has attained the required points for Championship status. Note: A Listed dog may be moved to the Specials Only Class after the closing of entries, provided the CKC Individual or Event Registration Number was received prior to the first day of the show. The request to move a class dog to the Specials Only Class **MUST** be received by the Show Secretary **ONE HOUR PRIOR TO THE OPENING OF THE SHOW ON THE DAY CONCERNED**. Listing Fees **WILL NOT** be refunded

**EXHIBITION ONLY** - All dogs entered in this class shall be listed in the catalogue with the same particulars as dogs entered in regular competition. Dogs entered in this class **MAY NOT COMPETE** in any Regular class but may enter and compete in Non-Regular classes and/or Parades **ONLY**

## **NON-REGULAR CLASSES**

**VETERANS CLASS** - Dogs must be 7 years of age and over on the day of the show. Dogs entered in this class may be spayed or neutered. Awards for this class are: Best Male Veteran, Best Female Veteran, Best Veteran in Breed, Best Veteran in Group, Best Veteran in Show (This class will be held on completion of Best Puppy in Breed, Best Puppy in Group and **PRIOR** to Best in Show)

**BABY PUPPY CLASS** - This class shall be for any dog 4 months of age and under 6 months of age on the day of the show. The awards for this class are: Best Baby Male, Best Baby Female, Best Baby Puppy in Breed, Best Baby Puppy in Group, Best Baby Puppy in Show (This class will be held on completion of Best Puppy in Breed, Best Puppy in Group and **PRIOR** to Best in Show)

**BRACE CLASS** - This class shall be for two (2) dogs of the same breed handled by one person.

## **SEXUALLY ALTERED**

**SEXUALLY ALTERED CLASS** - This class is for dogs which have been spayed or neutered.

## **JUVENILE SWEEPSTAKES - SATURDAY, MAY 10<sup>th</sup>, 2025, LUNCH BREAK**

**OBEDIENCE CLASSES:**  
**(Ring Size 40' x 50' - Trials AM)**

No dog may be entered in both Novice "A" and Novice "B", Open "A" and Open "B" at the same trial. In determining class eligibility, if a dog shall have won a particular title before being entered or moved up, the handler shall have been notified by at least 2 different judges that the dog has won 3 qualifying scores for the required title. (However, a dog may continue to be exhibited for 60 days in a class after winning a particular title.)

Dogs fulfilling the requirements for a title may be moved to the next level of competition if the schedule permits. The transfer must be on the appropriate move-up form and submitted to the show secretary at least 15 minutes before the start of the class.

**PRE-NOVICE** - The Pre-Novice class is an elective class and earning the title is not a requirement to enter Novice classes. The Pre-Novice class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has not earned the title of PCD. Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class. The same handler must handle each dog in all 5 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the group exercise. Only dogs that have not earned the title of CD may enter the Pre-Novice class.

**NOVICE A** - The Novice A class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has not earned the title of CD. Only one dog per handler is allowed in this class, and that person must handle the dog in all exercises. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families. No person who has trained or exhibited a dog that earned a CDX title shall be allowed to handle a dog in this class.

**NOVICE B** - The Novice B class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has not earned the title of CD. Dogs in this class may be handled by the owner or any other person. The owner or any other person may handle a dog in this class. A person may enter more than one dog in this class. The same handler must handle each dog in all 6 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the group exercises.

**NOVICE C** - The Novice C class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned the title CD or any higher obedience titles. Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class. The same handler must handle each dog in all 6 exercises unless he has 2 or more dogs entered. In such cases, he must have an additional handler for each extra dog when they are judged together in the group exercises. Dogs may compete in Novice C indefinitely. Scores earned by dogs in the Novice C class are not eligible for High In Trial and do not qualify a dog for any title. Dogs may be entered in the Novice C class in addition to any other official or unofficial classes for which they are eligible.

**NOVICE INTERMEDIATE** - The Novice Intermediate class is an elective class and earning this title is not a requirement to enter the Open classes. The Novice Intermediate class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned a CD or any higher obedience trial titles. Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class. The same handler must handle the dog in all 6 exercises. Dogs may compete in the Novice Intermediate class indefinitely. Scores earned by dogs competing in this class are not eligible for High in Trial. Dogs may be entered in the Novice Intermediate class in addition to any other official or unofficial classes for which they are eligible.

**OPEN A** - The Open A class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of CD but has not earned the title of CDX. The handler of any dog in this class must be the owner, co-owner or member of their immediate family. Only one dog per handler is allowed in this class, and that person must handle the dog in all exercises. Any person who exhibited a dog that has earned an OTCH title may not handle a dog in this class. When a dog is wrongfully entered in these classes, any scores awarded will be cancelled.

**OPEN B** - The Open B class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of CD. Dogs which have earned the title of CDX or any higher titles may enter in the Open B class. A dog may also be entered in the Utility Class in the same trial. Dogs in this class may be handled by the owner or any other person. A person may enter or handle more than one dog in this class. The same handler must handle each dog in all 7 exercises. Prior to the start of judging, the judge will choose which of the six numbered routines is to be performed. This choice will not be disclosed to the exhibitors until it is posted at ring side at least 30 minutes before the start of the class. In future assignments, judges are required to alternate the six routines so that each set will be used approximately the same number of times.

**UTILITY A** - The Utility A class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of CDX but has not earned the title of U.D. Any person who has trained or exhibited a dog that has earned a MOTCH title may not handle dogs in this class. The handler of any dog in this class must be the owner or member of their immediate families. Owners may enter more than one dog in this class. The same person must handle the dog in all exercises.

**UTILITY B** - The Utility B class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of CDX or UD. Dogs in this class may be handled by the owner or any other person. Owners may enter more than one dog in this class. The same person must handle the dog in all exercises. Prior to the start of judging, the judge will choose which of the six numbered routines will be performed. This choice will not be disclosed to exhibitors until it is posted at ring side at least 30 minutes before the start of the class. In future assignments, judges are required to alternate the six routines so that each will be used approximately the same number of times.



**RALLY CLASSES:**  
**(Ring Size 40' x 50' - Trials PM)**

No dog may be entered in both Advanced "A" and Advanced "B" at the same trial or Excellent "A" and Excellent "B" at the same trial.

**RALLY NOVICE A** - Dogs competing in this class may not have earned the RN title or any CKC obedience title other than PCD. No handler who has exhibited a dog through its CKC CDX title or CKC RA title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families. A person may enter more than one (1) dog in this class. No dog may be entered in both Rally Novice A and Rally Novice B at any one (1) trial.

**RALLY NOVICE B** - Any dog may compete in this class until a qualifying score in the Rally Advanced class is earned. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged on leash, and all dogs must enter and leave the ring on leash.

**RALLY INTERMEDIATE** - This class shall be for dogs that have earned the R.N. title. A dog completing the R.I. or any other obedience or rally titles may continue to compete in this class indefinitely. The owner or any other person may handle dog in this class. A person may enter more than one dog in this class.

**RALLY ADVANCED A** - This class shall be for dogs that have earned the RN title but have not earned the RA title or any CKC obedience title other than PCD. No handler who has exhibited a dog through its CKC CDX title or CKC RE title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families. A person may enter more than one (1) dog in this class. No dog may be entered in both Rally Advanced A and Rally Advanced B at any one (1) trial.

**RALLY ADVANCED B** - This class shall be for dogs that have won the Rally Novice (R.N.) title. A dog completing the Rally Advanced (R.A.) title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged off leash. All dogs must enter and leave the ring on leash.

**RALLY EXCELLENT A** - This class shall be for dogs that have won the Rally Advanced (R.A.) title, but have not won the Rally Excellent (R.E.) title or any CKC Novice Obedience title. No handler who has exhibited a dog through its CKC Companion Dog Excellent (C.D.X.) title or instructed dog training classes shall be eligible to enter this class. The handler of any dog in this case must be the owner, the co-owner, or a member of their immediate families. A person may enter more than one dog in this class, A dog may continue to compete in this class after the owner has been notified by at least 2 different judges that the dog has won 3 qualifying scores in this class .However, a dog may not be entered or exhibited in this class in any rally trial after the owner has received official notification from the CKC that the dog has won the title.

**RALLY EXCELLENT B** - This class shall be for dogs that have won the Rally Advanced (R.A.) title. A dog completing the Rally Excellent (R.E.) title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class, A person may enter more than one dog in this class. All exercises are judged off leash except the Honor Exercise. All dogs must enter and leave the ring on leash.

**RALLY MASTER** - This class is for dogs that have earned the RE title. Any person may handle the dog in this class. Dogs must earn 3 qualifying scores of 85 points or more under at least 2 different judges.

## **GENERAL RULES GOVERNING THESE SHOWS**

It is the responsibility of the Exhibitor to be familiar with the rules pertaining to the event in which they are competing. Copies of the Conformation Rule book are available online at [www.ckc.ca](http://www.ckc.ca)

1. The Club reserves the right to remove any person from the show. The Show Superintendent shall have full control of the above shows and trials, which will be governed by CKC rules.
2. Any dog excused by the Show Superintendent or the Show Veterinarian for any reason shall not, after being excused, compete in any class for any award for the balance of the show.
3. The show committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, or other misfortune, to either dogs, exhibitors or patrons.
4. A Judge or any person participating in any capacity at a Dog Show held under CKC Rules shall not be subjected to any indignity of any kind during the progress of the show and it shall be the duty and obligation of the Club holding the show to see that this rule is effectively carried out. The Show Superintendent shall promptly report to the CKC any infringement of the rules, and the Discipline Committee shall have the power to take such action as it deems fit on receipt of a report indicating that this rule has been violated.
5. Exhibitors are solely responsible for the conduct or actions of their animals while they are on the show grounds.
6. **DOGS MUST BE READY FOR JUDGING.** The Club will not be responsible for and is not obligated to provide any service for notifying owners or agents of breed or class judging. No ring shall be held up waiting for exhibitors or handlers. Exhibitors & Handlers with more than one dog shall have substitute handlers available so the judging will not be delayed. All start times are PACIFIC TIME.
7. The owner of a dog entered in these shows is entirely responsible for any error in entering his/her dog, regardless of how or by whom the entry was made.
8. A dog once disqualified for any reason at a championship show held under these rules cannot again be shown at a show held under these rules until the dog has been examined by an official committee appointed by the CKC and the committee finds the dog is free from the condition which prompted the disqualification. Application for reinstatement must be accompanied by a fee of \$115 plus GST (for Canadian residents) (\$230 non-resident), which shall be forfeited to the CKC if the examining committee is satisfied that the dog should remain disqualified. All awards earned at a dog show in violation of this rule shall be canceled by the CKC and the owner of the dog is subject to disciplinary action.
9. Exhibitors and handlers will be responsible for their dogs and for their equipment left at the Show Grounds.
10. For the benefit of the health of animals and the pleasure of the exhibitors and spectators we insist upon keeping our grounds and buildings as clean as possible. Exhibitors are responsible for cleaning up after their dogs. Please exercise your dog BEFORE taking it to the Judging ring. Dogs are to be exercised in the designated areas only, not in the vicinity of the ring areas.
11. No entry fee will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, and Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club.
12. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge, or barred from competition by action of the Show Committee.
13. The tendering of NSF cheque shall be considered non-payment of entry fees and is punishable by disciplinary action and cancellation of awards. A collection fee of \$25.00 will be added to the amount of any returned cheque. Exhibitors whose charges are declined by the Bank Card Authorization Department will be assessed a service charge of \$25.00 for each transaction declined. Telephone entries are not accepted by the Show Secretary. Incomplete entries or entries received without fees, or entries received after the advertised closing date will not be accepted.
14. Attention foreign exhibitors, please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian Funds. If you sent a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please **DO NOT** make cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian Funds.

## CANADIAN KENNEL CLUB SCHEDULE OF CHAMPIONSHIP POINTS

SECTION 2. The schedule to be employed in the determination of the number of points to be allocated to a dog awarded WINNERS shall be as follows: (\*Includes the dog awarded Winners.)

Dogs Competing*	1	2	3 to 5	6 to 9	10 to 12	13 or more
Points Allocated*	0	1	2	3	4	5

To determine the number of championship points earned by a dog awarded Winners, total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best of Opposite Sex and then consult the schedule set forth above. A dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for championship points. Further section 15.1.12 {C} has been added and states the dog must: "have earned at least one 2 point win either at the breed level or group level."

The system provides for additional points if a dog awarded winners also places in the Group as listed here under.

A class Dog awarded Best In Show at an all-breed championship show will be credited with five points inclusive of any points earned at the breed or group level. In no case may a dog earn more than five (5) points at a single show. To earn a Canadian Championship, a dog must earn at least ten championship points under at least three different judges; and be individually registered with the Canadian Kennel Club, or have a CKC Event Registration Number (ERN) and have earned at least one 2-point win either at the breed or group level. In order to obtain a Grand Champion title, a dog must obtain a minimum of 20 points which must include a minimum of two wins of at least 2 points and at least two (2) points after 12 months of age. In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for Grand Champion points. (d) Only the highest points earned at a single show are carried forward.

15.2.4 Grand Champion Bronze (GChB) The title of Grand Champion Bronze may only be earned after the completion of the CKC conformation title Grand Champion is attained.

(a) Points for this title are only accumulated after the completion of the Grand Championship, and do not include the points earned in attaining the Grand Championship.

(b) To be awarded a Grand Champion Bronze title, a dog must attain a minimum of 50 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/Specialty level. Only the highest points earned at a single show are carried forward.

(c) Points accumulated prior to July 1, 2021 may be used to attain the GChB title, however, a minimum of five (5) points must be earned after July 1, 2021.

15.2.5 Grand Champion Silver (GChS) The title of Grand Champion Silver may only be earned after the completion of the CKC conformation title Grand Champion Bronze is attained.

(a) Points for this title are only accumulated after the completion of the Grand Champion Bronze is attained, and do not include the points earned in attaining the Grand Championship Bronze.

(b) To be awarded a Grand Champion Silver title, a dog must attain a minimum of 100 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/ Specialty level. Only the highest points earned at a single show are carried forward.

15.2.6 Grand Champion Gold: (GChG) The title of Grand Champion Gold may only be earned after the completion of the CKC conformation title Grand Champion Silver is attained.

(a) Points for this title are only accumulated after the completion of the Grand Champion Silver is attained, and do not include the points earned in attaining the Grand Championship Silver.

(b) To be awarded a Grand Champion Gold title, a dog must attain a minimum of 200 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best in Show/ Specialty level. Only the highest points earned at a single show are carried forward.

15.3 Grand Champion Excellent (GChEx) (48-06-12)

15.3.1 The title of Grand Champion Excellent may be granted only after the completion of the CKC Grand Championship Silver Title. Exhibitors will be required to submit to Shows & Trials the Grand Champion Excellent Record Sheet documenting the additional requirements. The Grand Champion Excellent Record Sheet Form is located on the CKC website.

15.3.2 To earn the title a dog must have earned the following during their career as a Special:

(a) one (1) Best in Show or a Best of Breed at a breed national specialty (where a minimum of 10 dogs have competed)

(b) three (3) Group 1st, or three (3) breed specialty best of breed wins.

(c) a CKC performance title from any CKC Event. Titles excluded are: CGN, Herding Novice Tested Certificate, all Instinct titles from all events, as well as all Sprinter titles and all Chase Ability Program titles.

15.3.3 Best in Show, Best of Breed at a National Specialty, 3 Group wins, or 3 Specialty Best of Breed wins, must be attained after the completion of a regular championship. The performance title may be attained at any time in the dog's career.

1. Exhibitors are required to complete the Grand Champion Excellent Record Sheet form located on the CKC website and forward to CKC upon completion of requirements above.
