

Entry forms and fees must be submitted to the Field Trial Secretary prior to the Closing Date. The club will be unable to accept, cancel or alter any entry after the closing date. Post-dated cheques will not be accepted. Please make cheques **payable to** <u>**PEI Springer Spaniel Club**</u>.

Credit card and Interac entries are available at www.dogshow.ca; 10% service charge applies. Use the SPANIEL50 discount code to receive a 50% reduction in the service charge.



Listing Fee: A listing fee as established by the Canadian Kennel Club (CKC) must accompany the entry of a dog for which a CKC individual registration number or Event Registration Number (ERN) is not shown on the entry form. The current listing fee is \$10 (\$10 US) per trial (i.e. per dog per day).

Event Registration Number: All dogs that are foreign born and foreign owned require an event registration number (ERN) to enable them to be awarded titles by the CKC. Dogs may be entered as "listed"; however, an ERN must be obtained within 30 days of obtaining points, awards or scores to avoid cancellation. Application forms may be obtained from the Field Trial Secretary.

Non-Member Participation Fee:

a) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee. b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.

c) The Premium List must carry a note stating that "these fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members".

National Amateur Championship Stake: "A dog which has placed 1st, 2nd, 3rd or 4th in an Amateur All-Age Stake at a CKC approved trial held under these rules will be qualified for the following 2 National Amateur Championship Stakes. All dogs which have previously won this Stake (are also qualified)." *CKC Sporting Spaniel Field Trial Rules & Regulations, Chapter 12, section 1.4*

Points: Championship Points are awarded for placements in the Amateur Championship Stake, provided that there are 12 or more starters: The winner of the National Amateur Championship Stake will automatically become a Canadian Amateur Field Trial Champion and is also entitled to be designated "National Amateur Spaniel Champion."

1st Place - 5 Points,2nd Place - 3 Points,3rd Place - 2 Points,4th Place - 1 PointCKC Sporting Spaniel Field Trial Rules & Regulations, Chapter 12, section 2

Indignities: "It shall be the duty and obligation of the trial-giving club to see that a judge, club official, field trial marshal, volunteer, or competitor at a field trial held under these regulations, is not subject to indignities of any kind. The Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue." *CKC Sporting Spaniel Field Trial Rules and Regulations, Chapter 21, section 7*


