A service charge of 10% will be assessed. This includes entries sent online or post using a credit card or Interac for payment.

Attention Foreign Exhibitors: Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted; however, they are to be payable in Canadian funds. If you send a cheque in U.S. funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and co-operation is appreciated. Thank you.

FEEES / CHEQUES / N.S.F. CHEQUES:

All fees must accompany your entries. No entries will be accepted without accompanying full payment. Tendering of an N.S.F. cheque or credit cards that have maxed out shall be considered an offence punishable by disciplinary action and cancellation of awards by the Canadian Kennel Club. There will be a \$50.00 fee charged for any N.S.F. funds issued to the Hub City Kennel and Obedience Club. (Post-dated cheques will NOT be accepted). Overpayment of entry fees will not be refunded.

OFFICIAL CKC ENTRY FORMS

ENTRIES MUST BE TYPED OR DISTINCTLY PRINTED. Owners are responsible for errors on entries. Incomplete entry forms must be returned to the designated owner or his authorized agent. Unsigned, telephone, or telegraph entries cannot be accepted, except in the event of a postal strike when telephone entries may be made in accordance with the Canadian Kennel Club Regulations.

The following **CKC OBEDIENCE** classes will be offered:

Pre-Novice; Novice A; Novice B; Novice C; Novice Intermediate;
Open HA; Open18A; Open HB; Open 18B;
Utility A; Utility B

Refund of entry fee is allowed for bitches in season provided a signed certificate is provided from a veterinarian.

CHAPTER 20

◆ 20.7 It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer, or competitor at an obedience or rally trial held under these regulations, is not subject to indignities of any kind. The Trial Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in the premium list and catalogue.

GENERAL INFORMATION

1. As per CKC rules all dogs on the show premises ***MUST be listed in the show catalogue.*** Any dogs not listed will be asked to leave. There will be no "IN TRANSIT" area provided.
2. There will be no overnight kennelling in the building.
3. Only approved CKC collars will be allowed in the precincts of the trials.
4. **DOGS MUST BE EXERCISED IN THE DESIGNATED AREAS ONLY. NON-COMPLIANCE WILL RESULT IN IMMEDIATE EXPULSION FROM THE TRIALS.**
5. Entries will be acknowledged after entry by DogShow.ca and a judging schedule will be available after the closing date. If such acknowledgement is not received one week before the show date, please contact the Event Secretary
6. Entry fees will not be refunded for cancellation of entries if the dog is absent, disqualified, excused by a veterinarian or judge, or barred from competition by action of the Trial Committee, or because it has been entered incorrectly.
7. If because of riot, civil disturbance or acts beyond the control of the Club, it is impossible to open or complete the show, no refund of entry will be made.
8. Showing correct information on the entry form is the responsibility of the entrant. The HCKOC takes no responsibility for the omissions or errors made on the entry forms. The Trial Committee reserves the right to refuse any entry subject to the CKC rules.
9. **BITCHES IN SEASON:** Obedience entry fees will be gladly refunded to exhibitors whose females are in season during the trials (and must be withdrawn) provided a dated veterinarian's certificate is produced prior to the trial.
10. The precincts of these trials shall be the HCKOC Training Centre and grounds.
11. The HCKOC will use due care and diligence for the welfare of the dogs and exhibitors but will not be responsible for, or assume any liability in the event of an accident or other misfortune, either to dogs, exhibitors or spectators.
12. All dogs must be under complete control at ALL times.
13. The selling of merchandise at these trials by other than our authorized vendors is not permitted. Anyone doing so will be expelled from the show/venue.

14. Any show official, volunteer, employee or exhibitor shall not be subjected to any indignity by anyone at these shows. Should this occur, the offender may be excused from the show/building by the Show Superintendent or his/her representative.
15. No dog may be brought on the grounds or premises of an event if it:
- Is known to have distemper, parvovirus, kennel cough or other communicable diseases;
 - Has recovered from distemper, parvovirus, kennel cough or other communicable diseases within the last 30 days (prior to the event);
 - Has been housed within 30 days prior to the event on premises which there existed distemper, parvovirus, kennel cough or other communicable diseases.

Results & Corrections: 90-Day Rule

Effective January 1, 2024

The CKC will not consider a request for any corrections to results if received more than 90 days following the date(s) of the event(s).

WAITING LIST

HCKOC will be accepting entries for a Waiting List on DogShow.ca. This application form must be fully (and correctly) completed **by the closing date and time**. Entries received will be sorted by date received AND CLASS. Any entries that are incomplete or incorrect will not be processed and the next submitted entry for that class will be chosen. Competitors will be notified that their entry was incomplete/incorrect and what the issue was.

CKC allows the Club to substitute an entry from the Wait/Reserve List for any dog that is withdrawn for reason of it being a bitch in season (in writing and with veterinary verification) for up to 72 hours before the start of the trial.

CKC also allows the Club to choose to accept withdrawals (in writing) for any dog other than a bitch in season up to 72 hours prior to the Trial and substitute a dog from the same class from the Wait/Reserve List. Entry fees for withdrawn dogs will NOT be refunded.

Should your dog be substituted into a class for a dog that has been withdrawn, competitors will be notified that this has occurred. Their entry will be processed using DogShow.ca and the applicable entry fee(s) must be paid immediately.

SHOW & GO – FRIDAY 5:00 – 8:00PM

Mat Time – 10 minutes @\$15.00

In order to accommodate as many people as possible we are restricting each handler/dog to one 10-minute spot. If a handler is trialing multiple dogs, we will allow two, 10-minute spots for that handler (max: two spots). Only the dog and handler will be allowed.

Booking is first come, first serve.

Booking will begin on the website www.HCKOC.com **the day after closing**.
