# Judges Biographies

## Conformation



**Erin Brown** – Australia -All Breed - I am a licensed All Breeds dog judge (Australian National Kennel Club) and have been judging at Championship level since 1987. I judge extensively in Australia and New Zealand, and also regularly in Europe and throughout Asia. I started exhibiting show dogs in the early sixties and registered the Quanmarra prefix in 1971, when I imported my foundation Salukis from Daxlore Kennels in the UK. I have also shown and bred Papillons, Rottweilers and Dachshunds however Salukis have remained as my abiding passion. Over the years I have owned and bred a number of multiple Best in Show winning Salukis and have bred in partnership with Penny Dunkley and Ahmadi Salukis owned by Ian Rasmussen and Philip Bennett. Our dogs have included the top Saluki in Australia for 2002, 2003, 2004 & 2005 and

Queensland Dog of the Year 2004 and 2008. More recently we have owned, shown and bred the Queensland Hound of the Year over several years with different dogs. While I love the elegance and ethereal look of salukis, I do have a very strong belief that all dogs should be able to do the task they were developed for, so I look for structural soundness as well as type - so we Lure Course our dogs for fun as well as showing them.



**Denise Cornelissen** - Denise started showing in 1973 and has been judging since 1990. She has owned and bred Shetland Sheepdogs and exhibited Finnish Spitz. Breeder of over 80 Canadian, American and Japanese Champions, and multiple Best in Show, Best in Specialty Show and High in Trial Shelties. She also bred Canada's first bi-black BIS Sheltie. Won the Canadian Shetland Sheepdog National Specialty and several other large Specialties. Won the American Shetland Sheepdog National Specialty. Denise travelled with an all-breed professional Handler (CPHA) for approximately 5 years, and groomed and showed dogs in all Groups. Denise has judged most of the Shetland Sheepdog Specialties offered in Canada as well as several in the USA and Japan, the Canadian Rottweiler National Specialty, Regional Specialties for Siberian Huskies, smaller Specialties for breeds in most Groups, several large all-breed Shows in the USA, Canada, Australia and Korea. She has served in most positions with Specialty Clubs and all-

breed Clubs over the past 35 years, and is a Charter and Life member of the Canadian Shetland Sheepdog Association; Member of the American Shetland Sheepdog Association; Life member of the Canadian Kennel Club and Member of the Northern Alberta Canine Association.



**Gunnar Nymann** - Chouan Kennels - In my childhood we always had dogs (Rottweiler, Doberman, German Shepherd, Danish/Swedish Yard dogs) but never for shows, just pets, and for me personally, horses was always top priority, so it was not until relatively late that I started taking an interest in dog shows. When I was at college I got my first dog, a German Shepherd, he was found one night in bar and my then girlfriend paid the man 2 beers and a packet of cigarettes for him. I got my first showdog in 1980 (a Petit Basset Griffon Vendéen) and it was with this dog the interest took off. We have been breeding Petit Basset Griffon Vendéen since early 80'ies and with good results, I guess the most well-known is Danish, German VDH, Dutch, American, Canadian, Burma Champion (and also 2 times World Winner)

Chouan Gimlet, who was awarded Best in Show at the World Show in 1989 and Dog of the Year All Breeds 1989. We have exported PBGVs to many countries in the world, and our dogs are behind many of the top winning PBGVs you will see all over the world, including Australia. In 1993 we got our first Siberian Husky. Kontoki's Gibson Girl (called Ewok). Already from day one her show career took off like a comet with Best in Show at the Amsterdam Winner Show in 1993, which was her first show in Europe, She won BIS in many countries, and was 2 times Dog of the Year All Breeds in Denmark. Her son, Chouan Breaking The Waves was top dog in Sweden in 2000, and runner up I Denmark the following year. However, because of too much work, we have had to give up the Sibbs, as we did not have the necessary time to work them. Besides the Petit Basset Griffon Vendéen and Siberian Huskies we have also owned and shown Basset Hounds, Bichon Frise, Löwchen, American Cocker Spaniel, Chow Chow (short haired), Hovawart, and Brittany Spaniel. I am licensed by FCI to judge all breeds and Best In Show. I have judged in Denmark, Finland, Norway, Sweden, Iceland, Russia, Estonia, Latvia, Lithuania, Poland, Slovenien, Italy, Schwitzerland, Belgium, Holland, Germany, England, Ireland, USA, China, New Zealand and Australia.

I live in a 250 years old house approx 1 hour out of Copenhagen together with Holger, 1 cat and on an average approx 5 dogs. I like going to the theater and Opera, and I also love gardening, but have far too little time to be serious about it.





**Shawn Nichols** - My involvement in purebred dogs started in 1982 when I attended my first conformation shows. I quickly developed a keen interest for the sport of dogs. In the summer of 1985 I went to work for professional handlers Mark and Sally George, in Northern California. I soon realized this sport would be a life commitment. I continued to work for professional handlers, namely Tim Brazier, Mark Shanoff and Carol Graham, all of whom offered me the privilege of working with some truly amazing dogs. Eventually I relocated to Calgary where, in partnership with Raymond Yurick, I handled several breeds specializing in Toy & Terrier breeds. One of the dogs we showed was Am. Can.Ch. Clarion Camelot Communique, Canada's top Non- Sporting dog and #10 All breeds in 2008. I have bred Wire Fox Terriers, Whippets, Scottish Terriers but primarily Toy & Miniature Poodles under the Typecast prefix. In 2007 I took on the job of editor for Terrier Type, a unique magazine that chronicled the history and achievements of the Terrier since 1961. I currently reside in Burnaby where I work with Kao Canada in Sales and Marketing. My career aspirations have me pursuing my Marketing Sales Management Diploma at BCIT. In 2012, I started to judge and I have completed the Toy & Non Sporting Group this past year I have recently moved on to the Hound Group. Judging to me was a natural evolution to add to my experiences in the dog world. It also allows me to remain current with issues of importance to breeders and exhibitors and offers me a means to be involved with CKC.



**Brenda Wilson** - Brenda started in the dog show game with the purchase of her first purebred in 1980, an Old English Sheepdog. From the time they began attending puppy obedience classes, she was hooked on the sport. Brenda bought her first Golden Retriever in 1984 and has had many Goldens sharing her life since then. Brenda and her husband, Dale, have owned and bred Goldens, German Shorthaired Pointers, and Labs and owned a Flat-coat & a Pug. As well as competing in the conformation and obedience rings in both Canada & the US, Brenda trialed the Flat-coat to his WCI and JH. Along with her husband, Brenda currently shares their home with a Labrador, a Boerboel and a Pug ranging in age from 1 to 10 years. Brenda is a life member of the Canadian Kennel Club, the Golden Retriever Club of Canada and the Nanaimo Kennel Club, and is one of the founding members of the Sporting Dog Club of BC. She is licensed for all sporting and working breeds, and is on permit for half of the herding group.

## Obedience & Rally



**Paul Oslach** - One day I wandered down to the far end of the arena during a dog show to see what else was going on. Next thing I knew I was hooked. The dogs at that end of the ice pad were doing more interesting things like jumping and retrieving. That was some where around 1980. Since then I have trained and shown Cavalier King Charles Spaniels. In 1982, I became the proud owner of Ch & OTCh. Picbrand Mardi Grais, the first Cavalier in Canada (and North America) to obtain a Utility Title. My judging career began the 1988 and has taken me all over Canada and parts of the United States where I have seen some of the best arenas. My other hobbies include camping and canoeing.

**Lynne Oslach** - I have always loved animals and horses in particular. When I met my husband Paul in 2001 I spent most of my time at the barn with my horse. Paul, who had owned Cavalier King Charles Spaniels for over 25 years, was not only an obedience judge but had trained the first Cavalier in North America to its OTCh. Within the year I had a Cavalier of my own. Joy and I learned about obedience together as we took our first classes. I found out how exciting it could be to work with your dog as a team. By titling together Joy gave me the opportunity to become an obedience judge. I have had a wonderful time judging in Canada, the US and Bermuda. My greatest pleasure is to see a happy dog and handler team who know each other's every move working together in the ring. When I'm not involved a dog activity I like to spend my time outdoors doing photography.

# Rules and Regulations

## GENERAL INFORMATION AND REGULATIONS

Dogs should be in the building at least one hour prior to ring time. It is the responsibility of the exhibitor to be aware of the posted schedule and be at ringside at the time of judging. The club will not call individual dogs to ringside. Please remain at ringside until judging is completed. A practice ring will be set up in the benching area. Regular rings must not be used for this purpose. Dogs must be exercised in the areas provided, anyone exercising their dogs on the grounds outside the building and not cleaning up after them, will be excluded from the show or trial.

Exhibitors are reminded to respect hospitality facilities. The Red Deer & District Kennel Club reserves the right to refuse future entries from any exhibitor who creates excessive destructive or disruption to host facilities (Hotel, motel or campground). The show superintendent is in complete charge of the shows and trials which, are governed by CKC rules. No judge or any other person participating in any capacity at a dog show held under CKC rules shall be subjected to an indignity of any kind during the progress of the show. The Show Committee has a responsibility to see that this rule is enforced. Chapter 19.7, Page 55, CKC Conformation Show Rules and Regulations.

The Dog Show Committee will use due care and diligence for the welfare of dogs, exhibitors and spectators, but will not be responsible for, nor assume any liability in the event of accident or misfortune. The Red Deer and District Kennel Club reserves the right to remove from the shows or trials any person or dog for any just cause. Any dog excused by the show superintendent or veterinarian, for any reason, shall not compete in any classes or accept any awards for the duration of the shows or trials. No refund of any fees will be made.

If because of riot, civil disturbance, or any other acts beyond the control of the show committee, it is impossible to open or complete the show, no refunds shall be made!

## EXTRACTS FROM THE DOG SHOW RULES - BREEDS, CLASSES, AWARDS AND STAKES

### CONFORMATION CLASSES OFFERED:

12.2.1 Regular official classes at a CKC conformation show shall be as described in (a) to (k) of this section. All classes must be divided by sex (except for Specials Only). Only dogs entered in one of the regular, non-regular, or unofficial classes shall be allowed within the show precincts.

**JUNIOR PUPPY:** shall be for dogs at least six months of age and under nine months of age on the day of the show.

**SENIOR PUPPY:** shall be for dogs 9 months of age and under twelve (12) months of age on the day of the show.

**12-18 MONTH** - for dogs over 12 months of age but under 18 months of age.

**CANADIAN BRED:** shall be for dogs born in Canada, Champions of any country excluded

**BRED BY EXHIBITOR:** shall be for dogs owned and handled in the ring by the Breeder. The handler must be the owner/co-owner AND breeder/co-breeder of the dog. The owner/breeder must handle the dog in this class, but need not handle the dog for further awards.

**OPEN CLASS:** shall be for all dogs.

**SPECIALS ONLY:** is for dogs which have a recorded CKC Registration or Event Registration Number and have attained the required points for Championship status including at least one 2 point win either at the breed or group level. Should a dog which is entered in this class be found either not to be registered or has not completed the requirements for Championship status, all awards earned at the show will be cancelled. Dogs entered in this class will compete for Best of Breed, Best of Opposite Sex and Best Puppy if eligible.

### UNOFFICIAL/NON-REGULAR CLASSES OFFERED

**BABY PUPPY** Dogs 3 months of age and under 6 months of age on the day of the show. The award for this class are: Best Baby Male and Best Baby Female Best Baby Puppy in Breed Best Baby Puppy in Group Best Baby Puppy in Show

**VETERAN** In this optional class for All Breed Shows, dogs must be 7 years of age and over on the day of the show. Dogs entered in this class may be spayed or neutered. The awards for this class are: Best Male Veteran and Best Female Veteran, Best Veteran in Breed, Best Veteran in Group, Best Veteran in Show. A Veteran awarded Best Veteran in Breed is not required to stay to compete for Best Veteran in Group. A Veteran awarded Best Veteran in Group is not required to stay to compete for Best Veteran in Show.

**BRACE** At an all-breed or specialty show a club may, but is not required to, offer a Brace Class. This class shall be for 2 dogs of the same breed (not necessarily of the same sex). A Brace should be judged as an identical pair – same colour, size, gait, and same stride. When viewed from the side they should appear as one dog and its shadow. A brace must be handled by 1 person on 1 lead.

**RESERVE BEST IN SHOW:** will be selected from the remaining 6 Breeds competing for BIS

### OBEDIENCE CLASSES OFFERED:

Novice A, Novice B, Novice C, Novice Intermediate Open A, Open B, Utility A, Utility B, Pre -Novice, Exhibition Only,

### RALLY OBEDIENCE CLASSES OFFERED:

Novice A & Novice B, Intermediate, Advanced A & B, Excellent A & B, Exhibition Only

## CHAPTER 4 – JUDGES

SECTION 19.7 It shall be the duty and obligation of the show-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities. The Conformation Show Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

**Attention Foreign Exhibitors:** Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you pay by credit card, bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated.

**Entries sent by Greyhound must be sent prepaid;** To comply with instructions issued by the Canadian Kennel Club, we will be unable to accept any entry reaching our Show Secretary after the closing time and date.

**Please allow ample time for delays in the mail.**

**Exhibitors Please Note:** An exhibitor has the right to withdraw an entry at any time up to the closing date and time as published in the premium list. This may be done by telephone but **written or electronic notification must be received by the show secretary not later than closing date and time.** If written or electronic notification is not received, the dog will remain entered in the show.

**Entry fees will be refunded when a bitch entered in Rally/Obedience comes into season** after the close of entries if a Veterinarian's Certificate (certifying that the bitch was in season within the 10 day period preceding the trial) is delivered to the Show Secretary **before the starting date and the time of the trial.** The Red Deer and District Kennel Club will refund entry, recording and listing fees if the above conditions are met. No Refunds will be given for the service fees provided by the dogshow.ca

**A 50% refund of entry fees only will be made for a bitch in season without a Veterinarian's certificate with written notification presented to the Show Secretary at least ONE HOUR before the start of the Trials. The bitch must be available to be examined by the Show Superintendent to verify she is in season.**

**There will be no refunds on duplicate entries or overpayments.**



## Extracts From CKC Dog Show Rules

### Chapter 8 Entries and End of Show Section

**8.2.5** An error in an age specified class, date of birth or sex may be amended on the entry form up to one hour before the start of the show.

**Section 8.3.1** Entries: Every dog entered in a Championship show must be one of the following:

- registered with the CKC,
- have an Event Registration Number,
- be eligible for registration with the CKC, or
- if it belongs to a listed breed, it must have a Miscellaneous Certification Number (MCN).

**Section 8.4.1** Listed Dogs: If a dog is not registered as in 8.3.1 (a) or (b) but is eligible for registration with the CKC, it may be entered at a show as a listed dog provided:

- that if born in Canada, it is eligible for individual registration;
- that if not born in Canada, is eligible for registration in the records of the CKC.
- that if it is a foreign born and owned dog, an Event Registration Number or CKC registration number is obtain from the CKC within 30 days of the first show entered.

**Section 8.4.2** Entry of a listed dog at a show must be accompanied by a listing fee as set by the Board in addition to the regular entry fee.

**Section 8.5.1** Acceptance of Entries: If indicated in the premium list, an electronically transmitted entry may be accepted provided the entry is accompanied by a credit card charge authorization.

**Section 8.5.3** No entry shall be accepted from or on behalf of any person who is officially known to be expelled, deprived of privileges, debarred or suspended by the CKC or any other registering body for pure bred dogs.

**Section 8.5.4** After entries close, no further entries may be accepted, cancelled or substituted other than as otherwise stated in this section or as provided for in case of a postal strike.

**Section 8.6.1** Refusal of Entries: The authorities of any show may:

- decline to accept entries for just cause, and/or
- refuse to receive or may remove any dog from the show building on account of disease or viciousness.
- in the case of non-acceptance, refund the fee with the reason for non-acceptance.

**Section 8.8.2** Fees: Tendering of a dishonoured cheque or declined credit card in payment of an entry fee shall be considered non-payment of said fee and is an offense punishable by disciplinary action and cancellation of awards.

**Section 8.9.1** Moving a Dog to Specials: A dog which is individually registered in the records of the CKC or that has a Miscellaneous Certification Number (MCN) and has completed the requirements for a Championship in accordance with these rules but at the time of the closing of entries for a show has not received confirmation of the title, may be transferred from one of the regular classes to Specials Only providing the transfer is submitted to the Show Secretary in writing by the owner or handler at least one hour prior to the opening of the show.

**Section 8.9.2** If it is established that a dog transferred to Specials Only has not completed the Championship requirements, all awards will be canceled and all ribbons and prizes won shall be forfeited. The owner may also be subject to disciplinary action.

**Section 8.9.3** When one or more All-Breed and/or Specialty Shows are held on the same day, in the same venue, the moving of class dogs to Specials must be made prior to the scheduled opening of the first show.

**Chapter 4 Judges Section 4.1.3** A judge officiating at a show held under these rules shall not be subjected to indignities of any kind during the progress of the show. It shall be the duty and obligation of the club holding the show to see that this rule is effectively carried out.

**Section 4.1.6** No person may approach a judge either directly or otherwise, orally or in writing, to favor his entry. Disciplinary action will be taken against any person who violates this rule or against a judge who fails to report any contravention of this rule to the CKC within 14 days of the act.

### Chapter 14 Disqualifying or Excusing Dogs

**Section 14.1.2** (a) At his discretion, a judge shall have the authority to excuse or disqualify a dog which menaces, threatens, attempts to bite or bites the judge, another person, or another dog in the ring. When a dog is twice excused on this account, it shall have the status of a disqualified dog.

(b) At his discretion, a judge shall have the authority to permanently disqualify a dog which bites the judge or another person in the ring. Dogs disqualified under this provision will not be eligible for reinstatement. The decision to permanently disqualify a dog must be clearly indicated on the Judge's Disqualification Form.

**Section 14.1.4** Once a dog has been disqualified for any reason at a conformation show, it may not be entered or shown at another show until

the dog has been reinstated by the CKC. All awards earned by a dog shown in violation of this section will be cancelled by the CKC and the owner of the dog is subject to disciplinary action. A dog disqualified under section 14.1.2 (b) is not eligible for reinstatement.

**Section 14.1.5** Any dog that is disqualified under section 14.1.2(a) shall automatically be disqualified from entering in any CKC event in any other discipline until such time as the dog is officially reinstated, if the dog is eligible for reinstatement.

### Championship Points and Cancellations

**Section 15.1.1** A dog awarded Winners at a conformation show shall be credited with a number of championship points (ranging from 0 to 5) and the number of championship points credited to a dog awarded Winners shall be as provided hereunder.

**Section 15.1.2** The schedule to be employed in the determination of the number of points awarded Winners shall be as follows:

Dogs competing*	1	2	3-5	6-9	10-12	13 & more
Points allocated	0	1	2	3	4	5

\*Includes the dog awarded Winners.

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall NOT be included in the calculation for championship points.

**Section 15.1.3** If a Dog awarded Winners was also awarded Best of Breed then at the show all dogs competing in the breed, including Specials Only, shall be included the total.

**Section 15.1.4** If a Dog awarded Winners is also awarded Best of Opposite Sex to Best of Breed, then all dogs of the same sex including those competing for Specials Only shall be included in the total.

**Section 15.1.5** If a Dog awarded Winners is also awarded Best of Winners, then all dogs defeated directly or indirectly in the breed shall be included in the total.

**Section 15.1.6** If a dog is awarded Winners only, then all the dogs of the same sex in the class competition shall be included in the total.

**Section 15.1.7** The number of championship points to be credited to a dog awarded Winners shall be determined by the highest award earned and calculated as per this section.

**Clarification:** Example of directly or indirectly defeating: If the Winners Bitch is awarded Best of Opposite Sex but not Best of Winners, the Best of Winners Male shall be deemed to have indirectly defeated the Specials Bitches, and is thus entitled to add them to the number of dogs and bitches defeated.

**Section 15.1.8** In addition to championship points allocated at the breed level, a dog awarded Winners which also places in the regular Group competition shall be credited with the following additional points provided that the dog was defeated at the Group level.

**Section 15.1.9** A dog may not be credited with more than 5 championship points in a single show:

**Section 15.1.10** A breed or class shall not be allowed more than 2 sets of championship points per sex on any day in the same venue.

**Section 15.1.11** A dog awarded Winners which also places Best in Show at an all-breed conformation show shall be credited with 5 championship points inclusive of any points earned at the breed and group level.

**Section 15.1.12** In order for a dog to be recognized as a Champion and its owner provided with a Championship certificate, the dog must:

- earn at least 10 championship points under at least 3 judges; and,
- be individually registered in the records of the CKC or have an Event Registration Number.
- have earned at least one 2 point win either at the breed or group level.
