NOTE: CKC rules re NSF cheques – tendering of an NSF cheque shall be considered NONPAYMENT OF ENTRY FEES and is an offense punishable by disciplinary action and cancellation of awards by the Canadian Kennel Club. There will be a \$40.00 charge on all NSF cheques received.

FIELD TRIAL ELIGIBILITY:

Only purebred Whippets may be entered. All dogs must be one year of age or older on the day of the trial. Dogs not registered with the CKC must pay a \$9.50 Listing Fee per trial / per day until CKC registration is obtained. Altered and neutered hounds may compete. **DOGS PRESENTLY DISQUALIFIED / DECLARED INELIGIBLE IN CANADA OR THE US CANNOT ENTER.**

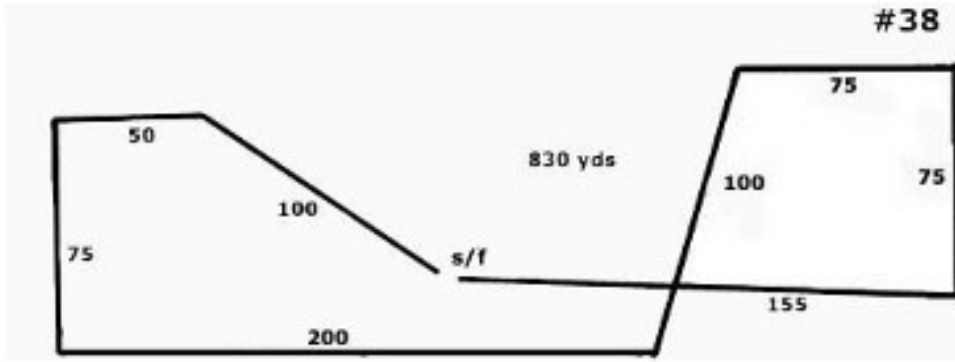
CONDITIONS:

Stakes will be split in any breed has more than 24 dogs entered at the time of the draw. All dogs will run twice in braces or trios unless excused, dismissed or disqualified. Bitches in season or lame hounds will be excused, and any entry refunded if notice is given prior to roll call. Hounds not present at roll call will be scratched and entry fees not refunded. Handlers must use slip leads when starting their hounds. Muzzles may be used at owner's discretion. All hounds will be slipped from a standing start.

COURSE PLANS

The club reserves the right to alter the course plan as required by weather and/or field conditions on the day of the trial. Course will be reversed for finals and again for run-offs and BOB. BIF will be as per the Judges request. They will be changed to suit field conditions.

EQUIPMENT: A continuous loop machine with white and/or coloured plastic streamers will be used. Back up equipment will be on site.

STAKES OFFERED

Official

OPEN – For all hounds – Including Field Champions

Un-Official

Puppy 3-6 months, 6-9 months, 9-12 months

Puppies will run once only; distance adjusted to age group.

Kennel Stake: Top combined qualifying score 2 hounds same owner,

TROPHIES AND AWARDS:

- Trophies will be awarded for BOB, BPIF, 1st place each stake, & kennel
- Ribbons for 1st through NBQ each stake, BOB, and BPIF

JUDGES:

"A judge officiating at a field trial under these rules and regulations (CKC) shall not be subject to indignities of any kind during the progress of the field trial. It shall be the duty and obligation of the club holding the field trial to see that this regulation is effectively carried out. The Field Trial Chairman shall promptly report to the Canadian Kennel Club any infringement of this regulation, and the Discipline Committee shall have the power to take such action as it deems fit on receipt of a report indicating that this regulation has been violated.

CKC Non-Member Participation Fee Policy

A non-member participation fee will be charged to a resident of Canada who is a non-member of the CKC. The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual. In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level. All Premium Lists will carry a note stating the fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

PLEASE TAKE YOUR GARBAGE WITH YOU – At this trial you are encouraged to not pick up your dog poop – please walk your dogs at the edges of the field so nobody steps in it.

Directions: (GPS 45 04 09.44 N 74 16 37.36W)

From Show Site: Turn R from show grounds onto Long Sault Parkway; Turn L onto Hwy 2;

Turn R onto Dickinson Dr (twd 401 but don't take 401) (Cty Rd 14); Turn L onto Cty Rd 18 in Osnabruck Ctr; twd Gallinger Town; after ~ 5km turn R onto Cty Rd 11 twd Chesterville after 15 km:

Turn L onto Hwy 43 twd Chesterville, Winchester in 4.5 km Turn L: onto Nation Valley Rd

after ~ 4km: 12758 Nation Valley Rd on L; drive around R past barn

From Host Hotel (McIntosh Inn): Turn R out of hotel onto Hwy 2; turn R onto Hwy 31, **go NORTH (toward Winchester)**... see below

From 401: take exit 750 (Morrisburg), **go NORTH (toward Winchester)** about 22 km Turn R. onto River Rd. (1st rd. after Cass Bridge; previous Rd. = Nesbitt, also known as airport rd., on R. also); Cass Bridge Cheese (& ice cream!) House is directly opposite River Rd. Go 4 km along River Rd.; there will be a bridge across the river (South Nation) on your R. This is Nation Valley Rd. Take this bridge, keep on curve to the L. 12758 will be the 1st place on R. after that curve. Go past the house (2 story red brick), past the barn, drive on lane way along fence till you see the field.

From Speciality Breed Judging : see From Show Site

From Ottawa:

31 south (Bank St.) to 4 km south of Winchester (do not turn into Winchester, stay on 31); turn L. onto River Rd. opposite that cheese house, then as above.

From Kemptville:

Hwy 43 east to 31, turn R onto 31 (south) - then as above.

From Alexandria or Monkland:

Hwy 43 west to Chesterville; just past 1st exit off 43 for Chesterville, Nation Valley Rd. is on the L., Eastern Ontario Graphics on SE corner. 12758 is about 5 km down, on the L.

FIELD CONDITIONS

No shade on field or camping area All fenced, well away from roads.

Grass will be farm length (trimmed or grazed down, not mown to golf course length); there will be sheep droppings on field.

Water tub will be available for dogs

Very flat field

ATTENTION ALL EXHIBITORS:

- You need an up to date rabies certificate dated not less than 30 days but not more than three years to cross the border
- You need a passport for each individual in your vehicle in order to return to the United States.
- Our bank will not accept cheques marked "Payable in Can Funds". We suggest sending an US cheque and either replacing it with cash on the day or sending Money Order in Can funds.
- WCEC appreciates everyone's co-operation in keeping our site clean.
- There will be a \$5.00 fine for any loose dog interfering with a course in progress.
- Flexi Leads and Electronic Collars are not permitted on the field.
- Foreign born and foreign owned dogs may compete with an **Event Registration Number (ERN)**. This must be obtained within 30 days of obtaining points, awards or scores to avoid cancellation and can be obtained by submitting a copy of your foreign certificate of registration and a fee of \$57.60 with a letter of request to the CKC. This ERN replaces a CKC individual registration number for American Owned dogs entering events only and is not subject to taxes
- NOTE: a CKC Listing Fee of \$9.50 per dog is payable for each dog that does NOT have a CKC Registration Number, Performance Event Number or Event Registration Number. **This \$9.50 is in addition to the regular class entry fee.**

CHAMPIONSHIP POINTS IN REGULAR STAKES SHALL BE AWARDED ON THE BASIS OF THE FOLLOWING:

1st. Place	4 x # of hounds in Stake (Max. 40 points)
2 nd Place	3 x # of hounds in Stake (Max. 30 points)
3 rd Place	2 x # of hounds in Stake (Max. 20 points)
4 th Place	1 x # of hounds in Stake (Max. 10 points)
NBQ	No Points
