

## ENTRY AGREEMENT

I (we) acknowledge that I (we), all exhibitors, handlers and patrons, know and abide by the "CKC Dog Show Rules" and that I am (we are) familiar with their content. I (we) agree that the Northern Alberta Canine Association has the right to refuse this entry for just cause, which the Club shall deem to be sufficient. In consideration of the acceptance of entries made in these all-breed shows, obedience trials, agility trials or any of the associated Specialties, and of the holding of these shows and of the opportunity to have the dog judged and to win prize money, ribbons or trophies, I (we) agree to hold the Northern Alberta Canine Association and associated Specialty Clubs, their members, directors, governors, officers, agents, superintendents, or show secretaries, and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of a dog while in or upon the show premises or grounds or near any entrance thereto, and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of a dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of the Club(s) or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in these shows and trials, howsoever such injuries, death or damage to property may be caused and whether or not the same may have been caused and whether or not the same may have alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.

### RULES GOVERNING THESE SHOWS

1. Dogs must be kept on a leash at all times on the show grounds or within the show building.
2. The Club reserves the right to remove any person from the show. The Show Superintendent shall have full control of these shows and trials, which will be governed by CKC rules.
3. ANYONE PARKING IN THE FIRE LANES OR OTHER AREAS DESIGNATED AS "OFF LIMITS" WILL BE REMOVED FROM THE SHOW.
4. All recreational units must have buckets underneath for their drains. Those discharging of any water on the grounds will be removed by order of the health department and subject to a fine.
5. A judge officiating at this show held under CKC rules shall not be subjected to any indignities of any kind during the progress of the show. (4.1.3)
6. A show-giving club will be held responsible during the show for the conduct of exhibitors and spectators. Any person acting in an abusive or objectionable manner must be removed from the show on complaint to the Show Superintendent (1.4)
7. There is to be NO SMOKING in the large show tent, nor entrances to it, and NO SMOKING is allowed in the show building.
8. Dogs must be on the show grounds 1 hour prior to judging of their breed.
9. All vehicles are left on the show grounds at your own risk. No security is provided.
10. No abuse of parking personnel, NACA members or volunteers will be tolerated!!
11. RV's will not be allowed to travel on the show grounds when judging is occurring. Under special circumstances (in case of emergency) the show superintendent will stop the show and parking personnel will assist in the safe removal of vehicle.

## CHAMPIONS AND CHAMPIONSHIP POINTS

A dog awarded Winners at a Conformation show shall be credited with a number of Championship points (ranging from 0 to 5) and the number of Championship points credited to a dog awarded Winners shall be as provided hereunder:

*Dogs Competing	1	2	3 to 5	6 to 9	10 to 12	13 & more
Points Allocated	0	1	2	3	4	5

*\*includes the dog awarded Winners*

All dogs defeated, either directly or indirectly up to the Breed level, are to be including in the count. In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall be included in the calculation for championship points. In addition, points are awarded to a dog awarded Winners which also places in the regular Group competition:

A class dog awarded Best in Show at an all-breed championship show will be credited with the five (5) points inclusive of any points earned at the breed or group level. In no case may a dog earn more than five (5) points at a single show. In order for a dog to be issued a CKC Championship Certificate the dog must: earn at least 10 Championship points under at least 3 (three) different judges, be individually registered in the records of the CKC or have an Event Registration Number, and have earned at least one 2 (two) point win at the breed or group level.

*Introducing Our Judges*

**SANDRA ANDERSON** – has been a Scottish Terrier fancier since 1968 when the foundation bitch for Chess Kennels was obtained from Tayann Kennels in Brockville, Ontario. In 1979 Sandra judged her first Sanction match in Montreal and was permitted by the Canadian Kennel Club to judge Terriers in 1988 and is now licensed to judge 3 groups and Best in Show. She has judged in Canada, the United States and overseas; this has included 10 Specialties for Scottish Terriers.

There have been over 37 Scottish Terrier Champions from Chess Kennels and many specialty winners. Sandra has schooled the Scotties and one Deerhound in obedience and agility. One of her Scotties is now at the excellent level in Rally-O and is active at therapy visitations with that same Scottie. Sandra is a member, past president and show chairman of Rideau Terrier Club, a 35-year member of the Scottish Terrier Club of America, 25-year member of the Canadian Scottish Terrier Club, and a founding member of the Chateaugay Valley Kennel Club. She has given breed presentations to judges groups and mentored for the Scottish Terrier Club of America in New England.

Before the Terriers Sandra bred Weimaraners, which were conformation and obedience trained. She has also owned Scottish Deerhounds, a Wirehaired Fox Terrier and has bred Sealyham Terriers, Lakeland Terriers and Weimaraners. Sandra taught obedience for a 4-H program in New York for several years.

Sandra is a trained floral designer and dressmaker and is currently the owner of a grooming business.

**MICHELLE ARMITAGE** – as a junior I started training dogs for other people as I lived in a house that wasn't totally particular to dogs. So by good fortune I met several wonderful people that let me train their dogs and took me to dog classes. This also opened my eyes to training different breeds. When it was time for me to get my own dog I chose a Beagle. He provided me with numerous challenges with the greatest rewards, earning two legs towards his Utility title. My first Springer did me the honours of earning the OTCh to gain access to becoming a judge with the CKC. Since then I have trained my current Springers to their OTCh and CDX. I have also been bitten by the agility bug and my success in agility always comes back to their foundation in obedience. A new sport that has caught my attention is tracking. There are so many things we can do with our dogs; they truly are man's best friend.

**ROBERT BROWN, DVM** – My first exposure to Great Pyrenees was in 1964 when I attended the benched dog show, Heart of America Kennel club, at Kansas City while a veterinary student. I kept coming back to a bench that had a large white dog, Ch. Soleil Baron, on it. My first puppy followed in 1967 and, as they say, the rest is history. I joined the Great Pyrenees Club of America in 1968 and early on served as the specialty trophy chairman. I served as secretary-treasurer and membership chairman in 1972 and continued on to hold every office in the club. Since 1981 I have served as the club AKC Delegate and continue in that position today. I chaired the committee that rewrote the 1935 standard for the breed in 1989; this standard that we use today passed the membership by 70% majority.

From 1969 to the early 1990's I bred or showed over 50 Great Pyrenees champions under the name Starlaxy, Reg. I am particularly proud of the breeding pair that were sent to Sweden in the early 1980's. They were influential in the development of the breed in that country.

I was first approved to judge Great Pyrenees in the fall of 1978. I currently judge the entire working and herding groups, junior showmanship and Best in Show. I have judged the United States National Specialty three times, the Swedish National Specialty twice and the Canadian national Specialty once. I was also honored to judge the AKC Centennial Dog Show in Philadelphia in 1983.

Other club memberships included...being a founding member of the Great Pyrenees Club of Metro Milwaukee, membership in the Great Pyrenees Club of Maryland (1966), and All Breed clubs Waukesha, Kettle Moraine, and Richland.

Professionally, my most important contribution was my early involvement in canine frozen semen. I have written three breed specific medical books and have published numerous articles and columns in such widely diverse magazines as Popular Dogs and Doberman Quarterly. While active professionally, I held a number of veterinary seminars on canine reproduction and canine dermatology and allergy.

In "retirement" I work for the USDA Food Safety Inspection Service in Eastern Washington. My wife, Valerie, and I moved to our current address in late 2003 and have planted a vineyard and have a

small bonded winery. Valerie is a partner in a small, upscale bistro restaurant in the heart of Washington wine country.

**GAIL CARROLL** – Most of my adult life has been devoted to dogs. I have trained and handled a succession of Siberian Huskies and one Tibetan Terrier to a variety of titles in conformation, obedience, and rally.

Two of my dogs made history for the Siberian Husky breed in Canada. One, Ch. OTCh Watasoggin's Sutar of Laska, was the first to earn both a championship and a Utility Dog title. The other, Grand Ch./Am. Ch. Oshvah's Rooo The Day, CD, RA, Am RN (Daisy) was the first of the breed to earn the Grand Champion title.

I have judged obedience trials for more than 20 years, in both Canada and the US. I am a long-time member of the Canadian Association of Obedience Trial Judges and I am a life member of the CKC. For many years I have represented Manitoba on the CKC Obedience Council.

At present I have two Siberian Huskies, the above-mentioned Daisy and her daughter, Can/Am. Ch. Oshvah's Ruby Red Dress.

My husband and I live in the scenic Carberry Hills are of Manitoba but we spend our winters in Arizona.

**FRED DEWSBURY** – I am a retired school teacher who has been involved with purebred dogs almost my entire life. A close family member was a long-time breeder of Bulldogs and Borzoi. I loved the Borzoi, and in 1972 my wife and I started our own kennel. Over a span of more than 20 years we were fortunate enough to have bred many champions, group winners, specialty winners, and Best in Show dogs. I have also owned and shown Italian Greyhounds, and have professionally handled breeds from all seven of the groups recognized by the Canadian Kennel Club.

I received my first permit to judge in 1987 and since then have worked my way to all-breed status. I have judged all across Canada, in the USA, Ireland, Finland, Norway, Australia, New Zealand, Venezuela, Colombia, China, Thailand, Indonesia and Korea.

Over the years I have served on the executive of several Canadian dog clubs. I am a Life Member of the CKC, and did a term on its Dog Show Council, and currently am a regional chairman of the Examining Committee for the CKC.

**CAROL GRAY** – I have been associated with pure-bred dogs in Canada since 1965. In 1978 I registered Thunderally Kennels Permanent Registration with the Canadian kennel Club. In a career of over 30 years in Great Danes and Great Dane Rescue I became well-known in the conformation ring in Ontario as a breeder of quality Great Danes with exceptional temperament. I was the owner /breeder of about a dozen champions. Among the first to successfully show in America, I was the first Canadian to win at the Great Dane Club of America National Specialty winning in 1983 with Thunderally's Bold Chevron. In 1988 I owned and showed my one and only Basset Hound to his championship and a national ranking.

I have been in Bull Terriers since 1998 and proudly have a Bull Terrier at home that is over thirteen years old. Little has changed from my Great Dane days. Thunderally is still recognized throughout North America, the UK and Europe for Bull Terriers of quality and exceptional temperament. I currently have several Champion Bull Terriers showing in America, one of which is a Grand Champion. I stand firmly opposed to any form of Breed Specific Legislation anywhere in the world.

I have served the Bull Terrier Fanciers Association in many executive positions since 2004 and am currently on the Board of Directors as well as active in Bull Terrier Rescue. I have been a CKC member since 1970, a founding member of the Association of Great Dane Fanciers, member of Canine Federation of Canada, Bull Terrier Club of America, Bull Terrier Club of the UK, a member of the Bull Terrier Club of Canada, the Bull Terrier Club of the Niagara Frontier and a member of the Seaway Kennel Club and the St. Catharine's Kennel Club.

**JAMES HAM** – Jim purchased a \$100.00 pet Dalmatian in 1972. That very special bitch became the first Am/Can. Ch. Am/Can UDT in the breed. Jim has also bred, trained and exhibited other Dalmatians, Smooth Fox Terriers and, his present breed, Border Terriers.

Jim now judges about fifty dog shows each year. When not judging he often shows his Border Terrier in agility, obedience and rally.

Judging at Sanction Matches in the 1980's gave John experience that led him to apply for permission to judge at the Championship Dog Show level in 1998, drawing on his broad experience breeding and showing English Cocker Spaniels in North America as well as the knowledge he gained about other breeds raised by friends.

In other areas, John has bred purebred Arabian horses since 1984, served on the CKC Discipline Committee and as CKC Director for Eastern Ontario, and worked in his community as President of the Lanark County Children's Aid Society and founding board member of the Beckwith Child Care Centre. He currently sits on the Beckwith township Recreation Committee.

**IRENE LATCHFORD** – I have been involved in conformation and the Shetland Sheepdog since 1992 under the kennel name of Nitelatches. To date we have 23 home-bred champions. In 2007 I began my journey of becoming a CKC judge. I am the Show Chair for the Burlington Kennel & Obedience Club, treasurer, membership and show chair for the Dominion Collie & Shetland Sheepdog Club, but the position I hold dearest to my heart is I am Zone 7 Junior Handlers Representative. It gives me great joy to watch these up and coming new stars as they are the future of our sport.

I am now retired from the work force after 35 years, the last 26 years spent as a Property Field Adjuster for an insurance company.

**LAMAR & ELAINE MATHIS** – began judging in 1972, 39 years ago, and have a truly diverse background in the sport of dogs. They are multiple group judges having the honor of judging many prestigious All-Breed shows, foreign assignments and nationals.

LaMar was an AKC licensed all-breed handler, finishing various breed championships. He won groups, multiple all-breed Best in Shows and Best in Specialty Shows.

LaMar and Elaine have spent more than 53+ years immersed in the world of dogs and dog shows. Under the prefix of "LaMar's" Kennels, their breeding program of American Cocker Spaniels began in 1958, 53 years ago, and they have breeder/owner/handled nearly 70 AKC Cocker champions and additional top winning and producing champions around the world. Among those champions was their breeder/owner/handled Ch. LaMar's Ivory Summer who retired as the Top winning Cocker Spaniel bitch in the history of the breed in 1969. She, along with her son Ch. LaMar's London, were a commanding influence on the cocker bloodlines and winners of the day. Since that time they have bred the Top Winning Cocker Bitch All Varieties in 1998. Since then, they have produced multiple group first winners and in recent years also have owned three of the breeds top producing stud dogs who were excellent producers of quality winning and producing offspring. Each of these stud dogs have produced Group, Specialty and All-Breed Best in Show winners and are inducted in the American Spaniel Club's Hall of Distinction for dogs that have made valuable contributions to the breed.

BIS,BISS Ch. LaMar's Bentley, UD,CDX,OA,AAJ,AXP,AJP, sired by Ch. LaMar's Montana, has been verified by AKC to be the first Sporting Dog to win an all-breed Best in Show while holding advance performance titles.

In January 2011 at the American Cocker Spaniel Annual Flushing Spaniel Club show, Elaine and LaMar Mathis were honored with induction into the American Spaniel Club's Hall of Fame for their

significant contributions to the Cocker Spaniel Breed. They are life members of American Spaniel Club, joining in 1966 and holding 45 years of membership.

LaMar and Elaine continue to breed on an extremely limited basis and find enjoyment in their judging assignments in each and every breed.

**MARILYN O'NEILL** – Marilyn has been actively involved in purebred dogs since 1971 when shortly after she married, she and her husband Larry bought their first American Cocker Spaniel. They immediately became hooked on both obedience and conformation. They went on to breed many American and Canadian champions under the Larmaro prefix. Marilyn presently lives in Ancaster, Ontario. She has two grown children – Scott who is a paramedic and Julie, who has spent most of the last two years volunteering in India helping the street animals. **RALPH “SKIP” SCOGGINS** – Ralph Wm. Scoggins or “Skip” as he is known by friends and throughout the dog world obtained a Bachelor of Arts from Texas Western University (now known as the University of Texas at El Paso) and a Doctor of Jurisprudence from the University of Texas School of Law in Austin, Texas. He has been in the legal profession for 48 years serving as Judge of the 41<sup>st</sup> District Court of the State of Texas, a Mediator and Arbitrator and as a three term Member of the Legislature of the State of Texas. In a semi-retired manner, he still practices law and acts as a Mediator and Arbitrator.

“Skip” purchased his first pure-bred dog, a Great Dane, in 1955 and entered his first dog show in March 1956. He and his former wife, Sandra, founded the Great Dane club of El Paso (Texas' First Affiliate) and aided many Great Dane Clubs in Texas and the Southwest in their beginning. A member of the Great Dane Club of America for 52 years, he served as Parliamentarian and First Vice President. He was first approved to judge by the American Kennel Club in 1968; he has also been approved as an All-Breed Judge by the Federation Cynologique Internationale and Federacion Canofila Mexicana since 1974. “Skip” has judged All-Breed and Specialty shows numerous times throughout the United States, Canada, Mexico, Guatemala, El Salvador, Costa Rica, Dominican Republic, Colombia, Brazil, Uruguay, Argentina, Chile, New Zealand, Australia, Thailand, China, and South Korea.

Over the past 54 years under the kennel names “Acerino” and “Xenecu” he has (in a limited breeding program) owned, bred, and finished many champions from his first “Ch. Gaylord of Timberwolfe” (Great Dane), to BIS Ch. Acerino's Hans v. Hawk-Deb” (Great Dane), “Ch. Xenecu's Hawkeye Pierce (Great Dane), “Ch. Acerino Evanwhit's Copper” (Pembroke Welsh Corgi), “Ch. Int'l Camp. Xenecu Mariposa (Pug), “Ch. Jerez de los Arbolitos” (Bichon Frise), “Ch. Xenecu Blush Chablis Triviz” (Bichon Frise), “Camp. Xenecu Malinche” (Xoloitzcuintle) and “Int'l. Camp. Xenecu Peluchin” (Xoloitzcuintle) to mention a few. He has also owned, bred, and finished dogs of other breeds: Bassett Hound, Smooth Fox Terrier, Alaskan Malamute, Bedlington Terrier and most recent breed is Boxers.

He maintains residences in Mexico City and Trophy Club, Texas, and had a kennel, “La Quinta Xenecu” in Canutillo, Texas which he sold to the Animal Rescue League of El Paso when he retired from active breeding. “Skip” is most fortunate to have nine children (3 girls and a boy born to him (Valorie, Julie, Melanie and Blake) and five girls he adopted (Maria, Elisa, Susanna, Ana and Georgina).

## CLASSIFICATION

Please see CKC rule books for specific class descriptions. CKC members may access these books at [www.ckc.ca](http://www.ckc.ca) (member services). Non-members who require class details are asked to call the Show Secretary at 780-988-5020 or by email at [Mal dawn@aol.com](mailto:Mal dawn@aol.com). It is the responsibility of the exhibitor to be familiar with the Conformation, Obedience & Rally rules as set out by the Canadian Kennel Club.

### CONFORMATION

The following CKC conformation classes (divided by sex) will be offered:

**Junior Puppy:** for dogs 6 mths of age but under 9 mths of age.

**Senior Puppy:** for dogs 9 mths of age but under 12 mths of age

**12-18 Months:** for dogs 12 mths of age and under 18 mths of age

**Canadian Bred:** for dogs born in Canada; champions in any country excluded.

**Bred by Exhibitor:** for dogs owned and handled in the ring by the breeder.

**Open:** for all dogs.

**Specials Only:** dogs which are registered individually in the records of the Canadian Kennel Club and have attained championship status may be entered in the ‘Specials Only’ class. **Exhibition Only:** for all dogs over 6 mths of age and eligible for registration with the CKC (non-competitive class).

### OBEDIENCE

**Pre-Novice:** for any pure bred dog that has not earned the title PCD (Pre Companion Dog) title in

Canada. Dogs in this class may be handled by the owner or any other person. A dog may be entered in this class that has not earned the title of CD in Canada or US.

**Novice A:** for any purebred dog that has not won the title of CD. Only one dog may be entered in this class by any one exhibitor. A dog which has won a comparable degree in any foreign country is not eligible for this class.

**Novice B:** for any purebred dog that has not won the title of CD in CANADA. Dogs in this class may be handled by any person. More than one dog may be entered by any handler, but each dog must have a separate handler for the ‘sit’ and ‘down’ exercise. A dog which has won a comparable degree in any foreign country is eligible for this class.

**Novice C:** for any purebred dog that has gained a CD, CDX, UD or any other advanced title and exercises will be performed and judged as described in the official Novice classes. Scores earned in Novice C are not eligible for High in Trial. This is an elective class and offered for those people who feel the dog requires ring experience. Dogs may be entered in Novice C class in addition to any of the Official Classes or Unofficial classes.

**Open A:** for any purebred dog that has won the title of CD but has not won the title of CDX. Only one dog may be entered in this class by any one exhibitor. A dog which has won a comparable degree in any foreign country is not eligible for entry in this class.

**Open B:** for any purebred dog that has won the title of CD, CDX or UD in CANADA. Dogs in this class may be handled by any person. A dog which has won a comparable degree in any foreign country is eligible for this class. A dog may be entered in both Open A and Open B at any one trial. A dog eligible for UD is also eligible for entry in this class at the same trial.

**Utility:** for any purebred dog that has won the title of CDX in CANADA. Handlers may enter more than one dog in this class, but each dog must have a separate handler for the ‘group examination’ exercise.

### RALLY

**Rally Novice A:** Dogs entered in this class may not have won a CKC Rally Novice title or any CKC Novice Obedience title.

**Rally Novice B:** Any dog may compete in this class until a qualifying score in the Rally Advanced Class is earned. No dog may be entered in Rally Novice A and Rally Novice B at any one trial.

**Rally Advanced A:** For dogs that have won the Rally Novice title but have not won the Rally Advanced title or any CKC Novice Obedience title.

**Rally Advanced B:** for dogs that have won the Rally Novice title. No dog may be entered in both Rally Advanced A and Rally Advanced B at any one trial.

**Rally Excellent A:** for dogs that have won the Rally Advanced title but have not won the Rally Excellent title or any CKC Novice Obedience title.

**Rally Excellent B:** for dogs that have won the Rally Advanced title. No dog may be entered in the Rally Excellent A and Rally Excellent B class at any one trial.

This test is not a competition calling for precision performance by the handler and dog. Rather, it assesses the handler and dog’s relationship together with the handler’s ability to control the dog. We recommend that you read the CGN Participant Handbook so that you will be familiar with what you and your dog will be required to do.

ENTRY FEES: \$25.00 per dog (this includes the \$5.00 CKC fee for CGN Certification)  
 Entries at this pre-entry price of \$25.00 will close May 10, 2011. (If space available, some entries will be taken after this date or at the show for a fee of \$35.00 per dog.)

PLEASE NOTE: Dogs will be tested in order that their entries are received, however flexibility in scheduling will be made for those showing in the Friday Conformation, Obedience or Rally rings.

*(This only applies to dogs wholly owned by non members and is not applicable to CKC members or dogs co-owned with a CKC member, nor does it affect US exhibitors who must apply for an ERN number as noted above)*

A non-member resident in Canada is subject to the fee. Dogs co-owned with a CKC member are exempt. There are 2 options for non-members: a) Join the CKC or b) Pay the Non-Member Participation Fee

The fee is a yearly charge based on the calendar year January 1<sup>st</sup> to December 31<sup>st</sup> in which the awards, legs, points, titles, etc. were achieved. It is not based on the number of dogs or titles or awards earned, and is assessed against the owner(s).

Non-members will receive a letter from CKC Head Office informing them that they have 30 days to join the Club or pay the Non-Member Participation Fee. Dogs co-owned by two or more individuals ... the first person listed in the CKC dog records will be considered the caregiver of the dog and all communication will be sent to this person.

Payment of the Non-Member Participation Fee or becoming a CKC member will protect all awards, points, titles and legs in the calendar year in which they were earned. Failure to pay the fee within 30 days of the notice will result in all awards, legs, points, titles being cancelled. Once cancelled the awards, legs, points or titles will be given to the next applicable dog. Once cancellation takes place any subsequent awards titles, legs, etc. earned will automatically be cancelled without further notice.

The Non-Member Participation Fee is applicable starting at the first event in which the dog earns awards, points, titles, legs and is not prorated.
